**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on a review of aerial photographs, NWI surveys and topographic maps, it was determined that the site is void of wetland areas. Aerial photographs provided no evidence of wetland signature. The aeriels also showed that many of the adjacent properties have at been cleared and are also void of wetlands. The NWI showed that the site**

contains uplands. The soil maps submitted by the consultant showed that the site contains Bladen and Wahee soils. However, the data forms also submitted by the consultant showed that the site did not contain hydric soils, therefore a site visit was conducted on July 28, 2008 in which hydric soils were not observed. It was determined during the site visit that the site is void of wetlands .
