This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Wetland itself acts as a catch basin for adjacent uplands. The non-RPW carries little if any flow from these wetlands to Buck Creek TNW.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetlands have been impaired to due intensive silvicultural practices (timber harvesting, rutting etc.). The only drainage feature for these wetlands is an upland cut surface ditch which is located north of and adjacent to the wetlands. Three different site visits to the area and tributary in question determined that the slope of the tributary was not sufficient to support any flow resulting in the lack of a significant nexus to the TNW. In addition, previous jurisdictional determinations (SAC 2007-0375-3JH & 84-99-0701) on adjoining property determined that the adjoining property did not contain any wetland areas or other waters of the United States. .
