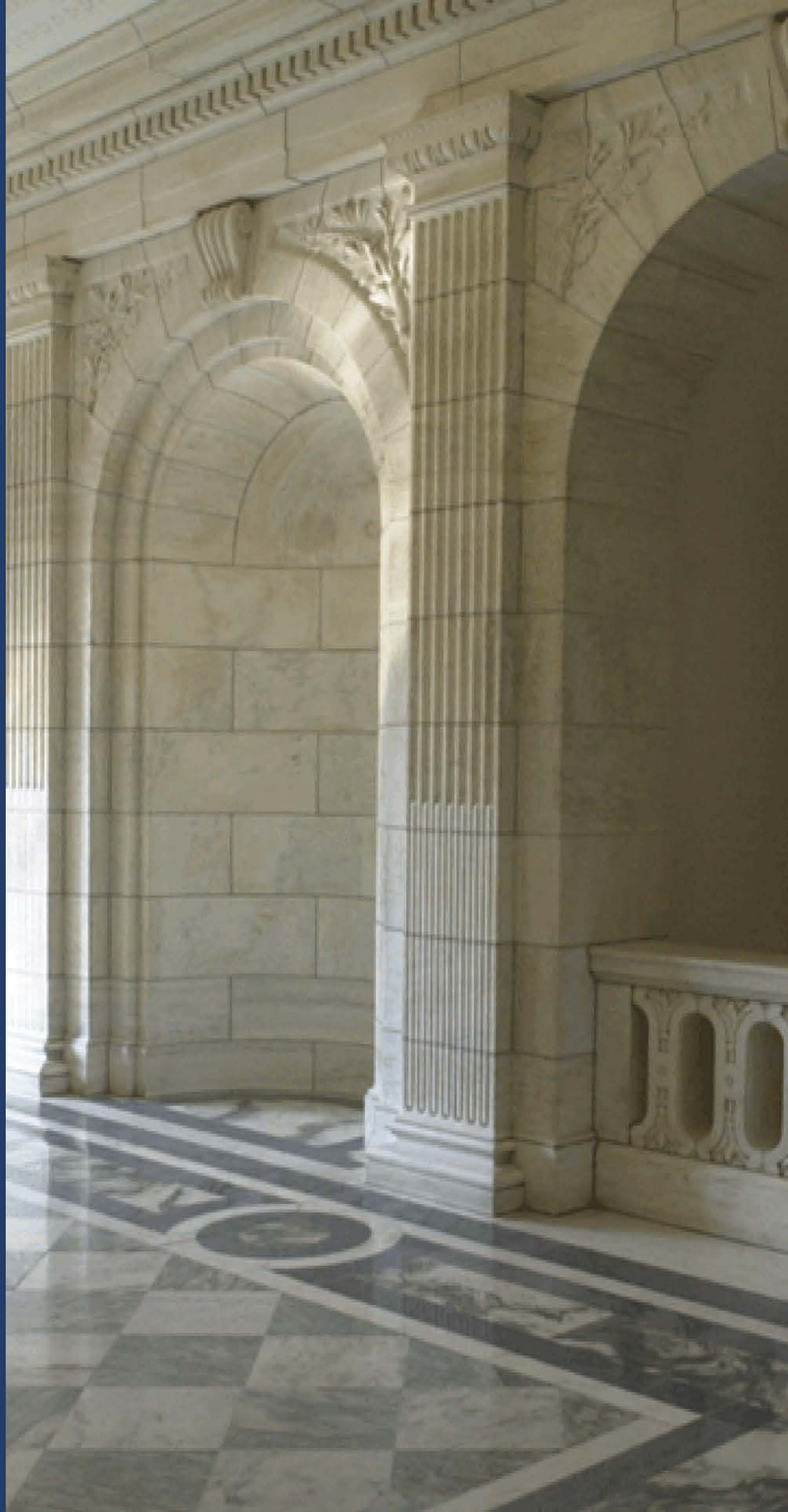




A MESSAGE FROM THE GENERAL COUNSEL

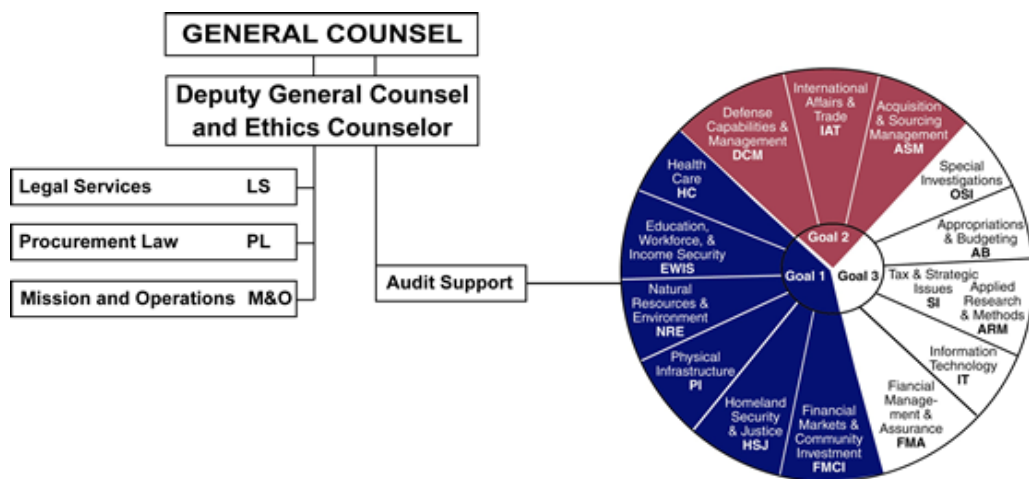

about **OGC**

OGC provides a wide variety of legal services that help ensure efficient, effective, and economical government operations. OGC attorneys assist the Congress, federal agencies, and GAO analysts in interpreting the laws that govern the expenditure of public funds and the myriad of government programs and activities. GAO is non-ideological, non-partisan, and fact-based in its work. This independence ensures that OGC’s approximately 130 attorneys can reach impartial and unbiased judgments, consistent with the agency’s core values of accountability, integrity, and reliability.

ATTORNEYS

No other federal agency can offer attorneys an opportunity to deal with as wide a range of legal issues as GAO's Office of the General Counsel. An attorney can become involved in legal questions encompassing the entire range of federal activities, such as housing, drug enforcement, urban development, transportation, energy, power generation, consumer and environmental protection, homeland security, national defense, weapons procurement, international trade, and foreign aid. OGC attorneys advise GAO analysts, auditors, accountants, and other professionals who review these and other federal programs. Attorneys may answer legal questions for congressional committees, agency heads, and other leaders on such government matters as homeland security, executive privilege, appropriations, or government procurement. The work of GAO's attorneys makes a major contribution to ensure the efficiency, effectiveness, and the economy of government operations.

OGC attorneys frequently assist Members of Congress and their staffs in drafting legislation or analyzing government activities. They may, on occasion, testify before a congressional committee, and their work may require them to meet with individuals from other federal agencies or departments or one of GAO's field offices. Attorneys may also review legislative proposals before the Congress, report to the Congress on proposed rescissions and deferrals of government funds, or prepare reports on the adoption of major federal regulations. Attorneys also advise GAO's criminal investigators and resolve bid protests challenging federal agency procurement decisions and the award of government contracts. Attorneys also provide advice to the agency on a wide range of human capital issues and represent the agency in litigation before administrative tribunals and in court.

OGC's legal support for GAO's analyst community is instrumental not only in ensuring the legal sufficiency of their products, but also in the success, impact, and effectiveness of all GAO studies. OGC is a player on every GAO team effort, and has particular impact whenever significant legal issues are involved. For example, in voting to remain in the World Trade Organization, the House of Representatives used our finding that U.S. business has gained more than it has lost by U.S. participation in the Organization. As another example, GAO investigated reports of an unusual number of deaths in several nursing homes in California and, when some of the homes refused to let us see patient records, GAO subpoenaed those records. Our report found numerous instances of patient abuse and neglect, which led to closer monitoring by state and federal authorities, less predictable inspections and, where patients were in immediate harm, immediate sanctions against the nursing homes.

OGC's resolution of complaints about the award of government contracts—GAO's bid protest function—increases the transparency and protects the integrity of the federal procurement process. GAO's work has resulted in a body of decisions that essentially set out, for agencies and companies interested in doing business with the government, the standards for basic fairness in federal procurement competitions. Legal publications like OGC's Principles of Federal Appropriations Law, a treatise drawing on GAO's appropriations case law, provides essential guidance to federal agencies on the proper spending of funds appropriated to them by the Congress. OGC's in-house guidance and ethics counseling ensure that GAO's work and personnel practices comply with all applicable laws and that GAO is a model for other agencies.

SUMMER ASSOCIATE PROGRAM

Each summer, OGC hires up to 12 law students to serve as summer associates. In most instances, the summer associates will have completed their second full year of law school. Ordinarily, the summer associates serve a minimum of 10 weeks, but may work longer if their schedules permit. Typically, summer associates work in equal periods in two of OGC’s teams.

Summer associates perform duties similar to those of newly-hired attorneys. The work not only involves legal research and writing, but can include direct and primary responsibility for all legal aspects of a project, including those arising in its design, implementation, and report preparation. For example, a summer associate may serve as a member of an audit team or fully participate in drafting a bid protest decision. Summer associates will also interact with GAO analysts and congressional staff.

SUMMER ASSOCIATE PROGRAM

The summer associate program may also include group activities such as weekly staff meetings, private meetings with a Member of Congress and a Committee Counsel, exclusive tours of the Supreme Court and the Congress, and attendance at special meetings of the Federal Bar Association and the American Bar Association.

Since the summer program exposes summer associates to OGC’s actual work and working conditions, they are able to arrive at informed decisions about working for GAO. At the same time, we have the opportunity to observe the associates’ performance under actual working conditions. Summer associates who meet our criteria have a substantial advantage over other entry-level applicants for entry-level positions.

SALARY AND BENEFITS

Starting salaries for attorneys in the Office of the General Counsel are commensurate with education and experience. The base salary for entry-level attorneys in 2007 is \$68,400. This may be adjusted depending on an individual's qualifications. OGC's banded pay system provides pay potential that allows for compensation based on performance. We also offer incentive awards to recognize high-performing individuals.

Starting Salaries

Subject to the availability of appropriated funds and other factors, OGC participates in a student loan repayment program. The program will repay up to a limit of \$10,000 per eligible employee per calendar year with a lifetime aggregate of \$60,000. More information about the student loan repayment program is available on the Office of Personnel Management's website.

Student Loan Repayment

Annual leave (vacation) is based on length of government service—employees earn 13 days of vacation each year for the first 3 years of service, 20 days for 3 to 15 years of service, and 26 days after 15 years. GAO recognizes 10 legal holidays each year. Employees earn 13 days of sick leave each year.

SALARY AND BENEFITS

GAO offers an excellent health insurance program, for which GAO pays a portion of the premium; the opportunity to select life insurance coverage; and excellent retirement benefits through the Federal Employees Retirement System.

OGC invests in employee's continuous learning, providing the information and resources they need for professional growth. Intensive training programs enable attorneys and staff to handle a wide range of assignments and keep them up-to-date on challenges in the law and major public policy issues.
