## MARKETABLE PHOSPHATE ROCK IN AUGUST 2008

U.S. marketable phosphate rock production in August was 2.76 million metric tons (Mt), which was 14% higher than that in July, according to the U.S. Geological Survey. Phosphate rock production for the period January through August 2008 was 4% higher than that in the same period of 2007.

Phosphate rock used in the United States in August was 2.71 Mt, which was 3% higher than that in July. Phosphate rock used in January through August 2008 was 2% higher than that in the same period of 2007. There have been no reported sales of phosphate rock by domestic producers since late 2006 because all phosphate rock is used internally by domestic producers to manufacture phosphoric acid or elemental phosphorus. U.S.

producer stocks were 3% higher than those in July and were 11% lower than those in August 2007.

Imports of phosphate rock were estimated based on U.S. Census Bureau figures and export data from the Moroccan producer. Morocco supplies more than 99% of the phosphate rock imported into the United States; however, the U.S. Census Bureau suppresses some of the phosphate rock data from Morocco.

Apparent consumption of phosphate rock in 2008 was projected to be 34.2 Mt, based on annualized data. Apparent consumption of phosphate rock was 33.8 Mt in 2007.
