## **OVERVIEW**

The San Francisco Bay Area Television News Archives is a collection of moving image materials, including local news, and selected documentaries and programs. Core collections include footage from two local television stations: the KQED (PBS affiliate) Film Archive, a collection of approximately 1.2 million feet of 16 mm local newsfilm created between 1967-1980, as well as selected documentaries and other footage, and the KPIX (CBS affiliate) Film Library, a collection of approximately 5-7 million feet of 16 mm local newsfilm created from the early 1950s to 1980, as well as selected documentaries and other footage. These two collections portray daily life, history, culture, and events in the San Francisco Bay Area from the early 1950s to 1980. Most of the local news footage consists of unedited outtakes and trims, rather than completed programs. For network programs, syndicated programs, and materials produced by other stations, consult Footage '89 and/or similar directories.

Additional collections held by the Archives include the KQED program, Over Easy, which focuses on issues of aging, and local Emmy Award-Winning programs from the Northern California Chapter of the National Academy of Television Arts and Sciences, 1974-date.

## THE SAN FRANCISCO BAY AREA TELEVISION ARCHIVES COLLECTIONS AND AVAILABILITY OF MATERIALS

The various materials in the San Francisco Bay Area Television Archives are a rich resource for study and research. Those using the collection are advised to set aside enough time to allow Archives/Special Collections staff to retrieve materials from those collections.

The collections are as follows:

## **KQED FILM ARCHIVES**

(a collection of selected local news and documentary FILM from 1967-1980). When using this collection, allow at least one day for retrieval of materials. Newsfilm created between 1966-June, 1970 has been transferred to videotape reference copies, and is available in the Media Access Center. Those wishing to view the videotape copies must first obtain a SPECIAL COLLECTIONS/MEDIA ACCESS CENTER CALL SLIP from Archives/Special Collections staff.

#### KPIX FILM LIBRARY

(a collection of selected local news and documentary FILM from ca. 1955-1980). This collection is in the process of restoration and is accessible as time and staffing permits. Retrieval of each item takes from 20-30 minutes. Allow at least one week for retrieval.

#### LOCAL EMMY AWARD WINNERS

(a collection of local Emmy Award Winners from 1974-date.) This collection is available on a limited basis, subject to the condition/fragility of the videotape and availability of equipment on which to use it.

#### **OVER EASY**

(A KQED-produced program concerning issues of aging, ca. 1977-1983). This collection is in the process of being transferred to 1/2 videotape reference copies, and will be available as soon as the entire collection has been transferred.

## **VIDEOWEST**

(a locally-produced precursor to MTV concerning rock music and other topical issues, ca. late 1970s.). This collection is unavailable until the original videotapes have been transferred to reference copies.

#### **PATCHWORK**

(a KQED-produced program with musician Laura Weber, concerning historical songs from around the country). This collection is unavailable until the original 2" videotapes have been transferred to reference copies.

## GUITAR, GUITAR

(a KQED-produced program with musician Laura Weber.) This collection is unavailable until the original 2"videotapes have been transferred to reference copies.

## BASIC GUIDELINES FOR USE OF THE ARCHIVES

## **COLLECTION ACCESS**

The materials in the San Francisco Bay Area Television News Archives were donated to San Francisco State University for the use of its faculty, students and staff. Users of the materials must have a specific project or topic for research.

- 1. All patrons must fill out the various sections of this document before using the Archives.
- 2. Students need faculty authorization to use the Archives.

## **COPYRIGHT**

All patrons wishing to use the material in productions must have permission of the television station/producer/entities who hold copyright to the material, and must credit the San Francisco Bay Area Television News Archives and the originating entity in their productions.

The copyright law of the United States (Title 16. United States Code), governs the making of photocopies or other reproductions of copyrighted materials. Most television programs, including news, documentaries and educational programs, are copyrighted. Release rights may or may not exist.

Under certain conditions specified in the law, libraries and archives may be authorized to furnish or to allow copying of films and video tapes of television programs and program out-takes. One of these specified conditions is that the material is "not to be used for any purpose other than private study, scholarship or research."

Materials in The San Francisco Bay Area Television News Archives are restricted. The patron must comply with the following requirements:

1. Authorization from the proper authority at the station that holds copyright. Faculty use in a classroom of unauthorized copies may or may not be copyright infringement and is the responsibility of the faculty member.

If a patron uses this material or a copy of it in excess of "fair use," that user--and the originating station if the user is authorized by the station--may be liable for copyright infringement. San Francisco State University and its employees have no control over the ultimate use of loaned or copied archive materials and have no liability thereof.

- 2. San Francisco Bay Area Television News Archives materials used/quoted MUST be cited in the following prescribed manner: SAN FRANCISCO BAY AREA TELEVISION NEWS FILM ARCHIVES: (COLLECTION NAME).
- 3. Patrons using Archives materials in productions are required to deposit a copy of their production in the Archives along with a shot list of footage used.
- 4. Patrons are expected to do their own research. The San Francisco Bay Area Television News Archives does not do research for patrons nor provide researchers. San Francisco State University's Broadcast Communication Arts, Cinema, and Journalism Departments may be able to provide names of potential researchers.

## **PROCEDURES**

## MATERIALS ACCESS AND USE

Many materials in the San Francisco Bay Area Television News Archives have not yet been processed, and may not be available. Some of the film is located in remote storage and will require extra time for paging.

- A. Film will be used in Archives/Special Collections, and will be handled ONLY by Archives Staff. The user will respect the fragile nature of the film/video material, and will refrain from damaging it in any way.
- B. Videotapes. Patrons should use the Archives/Special Collections indices and finding aids to locate item numbers. If the videotapes are located in the Media Access Center the patron will need to request a Special Collections/Media Access Center call slip in Special Collections to take to the Media Access Center before using the videotapes.
- C. Film. Patrons should use the Archives/Special Collections indices and finding aids to locate item numbers.

## COPYING

A. The patron must obtain all necessary permissions before any film/video is used in productions. All patrons must have proper authorization from the originating station/entity:

# COLLECTION DEVELOPMENT POLICIES/PROCEDURES SPECIAL COLLECTIONS J. PAUL LEONARD LIBRARY SAN FRANCISCO STATE UNIVERSITY

Special Collections at the J. Paul Leonard Library consists of four separate collections:

- 1. the Frank V. DeBellis Collection, a library-museum of Italian subjects and authors representing the civilization and culture of Italy from antiquity to the present (this collection belongs to the entire California State University system--not just to San Francisco State University);
- 2. the Labor Archives and Research Center, which collects, organizes, preserves and makes accessible the documents, files, photographs and ephemera of the Northern California labor movement from the turn of the century to the 1950s;
- 3. Special Collections/Archives, which has four major individual collections: the San Francisco Bay Area Television Archives, the Marguerite Archer Collection of Historical Children's Books, University Archives materials, including the San Francisco State University Strike Materials Collection, and our "rare and fine books;"
- 4. the Art Collection, which includes the Simeon Pelenc Collection of water colors, oils and drawings, the H. Wilder Bentley Collection of prints, the Lloyd Meadow Mask Collection, the John Magnani Collection of jewelry, ceramics and hand crafts, the Juliette Bredon collection of textiles, the Roy Kahn Collection of prints and lithographs.

## Acquisition policies:

1. The deBellis Collection acquires materials concerning the history and culture of Italy, without limitation as to date. It acquires <u>comprehensively</u> the major aspects of political and societal history; history of the fine and minor arts; literature and literary history/criticism; music and music history/criticism; recordings of music by Italian composers and of Italian folk music. It acquires <u>selectively</u> representations of outstanding personages, minor aspects of cultural/historical periods, and subjectsw not included in comprehensive collecting.

The deBellis Collection acquires trade editions; fine and hand press editions; 15th-19th century books in original and facsimile editions; manuscripts; microfilm/microfiche; music: cylinder, 78 rpm (acoustic, electrical), tape, LP, CD recordings; periodicals and serials; prints and drawings; ephemera; artifacts; coins. DeBellis acquires materials in mint condition if new; good condition or repairable if used or rare. There is no emphasis on first editions, association copies or other "collectable" characteristics.

As standards for history and criticism materials, the deBellis Collection uses authoritative editions of academic quality of writing, making significant and

permanent contributions. As standards for literature, the deBellis Collection prefers collected editions in the original languages.

Selection of materials for the deBellis Collection is done by the Curator, Raymond Van De Moortell in consultation with the Collection Assistant, Colomba Ghigliotti. The selection should be consistent with the Collection's needs and the above policy statement. Gifts to the Collection are accepted by the curator. Gifts also must conform to the policy statement.

2. The Labor Archives and Research Center collects, organizes, preserves and makes accessible the documents, files, photographs, and ephemera of the labor movement centered on (but reaching beyond where relevant and important) the San Francisco Bay Area and northern California. Specifically excluded from its areas of collection are materials related to the motion picture industry and the United Farm Workers.

The Labor Archives acquires new items in the following manner:

- a. Transfer of collections-this includes transfer of both ownership and copyright. (Sixty percent of the collections are acquired in this manner);
- b. Deposit of union records--the Labor Archives acts as a depository for the archives of Bay Area unions. Ownership of the records is retained by the union, although the deposit is considered a permanent one. Permanent deposit is a widely used practice designed to protect state-supported universities and unions from FBI and other federal subpoena. (Forty percent of the collections are acquired in this manner);
- c. Purchase--on rare occasions, the Labor Archives purchases primary and secondary source materials deemed to have value for research and/or instruction.
- 3. Special Collections/Archives acquires only in areas of already established collections: a.) Bay Area life, culture, society and history, especially as captured by moving image documentation; b) the history of San Francisco State University, and c), historic children's literature and texts. Examples of fine printing are not collected, per se, although items of particular value from the main collections are transferred to Special Collections/Archives from time to time.

No money currently is expended to acquire materials for the Special Collections/Archives Department, nor are gifts or other donations actively solicited. Often individuals and institutions who learn of our collections will donate appropriate materials which fit into our areas of collecting. In addition, curriculum support materials which are unique, of special historical interest, and/or are of considerable financial value may be placed in Special Collections/Archives for special handling and close monitoring of use.

4. The Art Collection consists of three types of materials: fine art, art reproductions, and posters. All of the fine art (original art works) were

donated as gifts. The art reproduction collection consists of mechanically produced copies of fine art works, most of which were purchased in the 1960s. The poster collection includes works acquired in the 1960s as well as some recent purchases (1980s) supported by Friends of the Library funding.

The Library previously had an Exhibits/Graphics specialist to curate all art. Since the elimination of this position and under present budgetary/preservation constraints, no new art has been purchased or recommended for purchase. Gifts to the Collection are carefully scrutinized and may only be accepted if disposition is at the discretion of the Library.
