2001 MEDICAID MANAGED CARE ENROLLMENT REPORT

Summary Statistics as of June 30, 2001

This report is composed annually by the Finance, Systems, and Quality Group (FSQG) of the Centers for Medicare & Medicaid Services (CMS). The Enrollment Report profiles Medicaid managed care programs on a plan-specific basis as of June 30, 2001. The information was collected from State Medicaid agencies and CMS Regional Offices. Data is presented for all States, the District of Columbia, Puerto Rico, and the Virgin Islands. Data is not presented for the following territories: Guam, Northern Mariana Islands, and American Samoa.

2001 ENROLLMENT FACT SHEET (MAJOR CHANGES FROM 6/30/2000 – 6/30/2001)

- ALABAMA – The State Medicaid Enrollment increase was due to SOBRA kids and the 1115 family planning waiver that added women below 133% of poverty-level.
- ARIZONA – The State Medicaid Enrollment increase was due to the increase in population and changes in income determination for eligibility; (2) Ventana¹ Health System no longer participates in the Medicaid program.
- DISTRICT OF COLUMBIA – George Washington University Health¹ and American Preferred¹ no longer participate in the Medicaid program.
- FLORIDA – (1) The State Medicaid Enrollment increase was due to outreach and expansion of Medicaid eligibility for children and teens; (2) Charter Glade (PCCM) and MedChoice¹ no longer participate in the Medicaid program.
- GEORGIA – The State Medicaid Enrollment increase was due to eligibility expansion.
- ILLINOIS – Illinois Masonic Community Health Plan¹ and Neighborly Care Plan¹ no longer participate in Medicaid Program.
- INDIANA – (1) The State Medicaid Enrollment increase was due to the successful outreach for the Hoosier Healthwise managed care program; (2) Maxicare¹ (MaxiHealth) no longer participates in Medicaid Program.
- KENTUCKY – Kentucky Health Select and HMO program no longer participate in the Medicaid program.
- MAINE – Nylcare Health Plans of Maine, Inc.¹ no longer participates in Medicaid Program.
- MASSACHUSETTS – (1) The State Medicaid Enrollment increased was due to outreach efforts; (2) Behavioral Health Partnership enrollment decreased due do to enrollees receiving behavioral health services through a MCO instead of PHP.
- MARYLAND – (1) The State Medicaid and Managed Care Enrollment increase was due to SCHIP enrollment; (2) Prime Health¹ and Freestate Health¹ no longer participate in the Medicaid program.
- MICHIGAN – American Family Care¹, Blue Care Network¹, Good Health Plan¹, Health Alliance Plan¹, Oakwood St. John's Health¹, Physician's Health Plan of South Michigan¹,

Pro-Care Health Plan¹, Select Care MCO¹, and Ultimed HMO of Michigan¹ no longer participate in the Medicaid program.

- MINNESOTA – Group Health, Inc.¹ no longer participates in the Medicaid program.
- MISSISSIPPI – (1) The State Medicaid Enrollment increase was due to efforts to re-enroll eligibles who lost eligibility for Medicaid when TANF was implemented and SCHIP enrollment.
- MISSOURI – The State Medicaid and Managed Care Enrollment increase was due to outreach conducted for MC+ For Kids
- MONTANA – Blue Cross and Blue Shield¹ no longer participates in the Medicaid program.
- NEVADA – The State Medicaid Enrollment increase was due to State's growing population, a downturn in the State's economy that led to increase unemployment, and the growth of TANF eligible population.
- NEW JERSEY – The State Medicaid Enrollment increase was due to the inclusion of retroactivity and increase in the enrollment of parents for SCHIP children.
- NEW YORK – Compre-Care¹ and HUM Healthcare Systems¹ no longer participate in the Medicaid program.
- NORTH CAROLINA – The State Medicaid and Managed Care Enrollment increase was due to reinstatement of individuals for at least 1-month due to Work First.
- OHIO – (1) The State Medicaid Enrollment increase was due to an overall increase in caseload and the impact of Preferred Option, which was initiated in the early spring of 2001 in four counties; (2) Emerald HMO¹ and Total Health Care Plan¹ no longer participate in the Medicaid program, (3) Dayton Area Health Plan¹ is now CareSource.
- OKLAHOMA – Bluelincs¹ no longer participates in the Medicaid program.
- OREGON – (1) The State Medicaid Enrollment increase was due to normal growth and economic circumstances; (2) Regence HMO¹ and Tillamook Counseling Inc.² no longer participate in the Medicaid program; (3) Multnomah CaapCare³ is now Multnomah County Verity⁴.
- PENNSYLVANIA – The State Medicaid Managed Care Enrollment increase was due to the managed care expansion to new regions.
- PUERTO RICO – The State Medicaid Managed Care Enrollment increase was due to the expansion of service areas.
- SOUTH CAROLINA – The State Medicaid Enrollment increase was due to SCHIP population.

- TENNESSEE – The State Medicaid Enrollment increase was due to normal growth and freeze on disenrollment process for certain waiver population groups.
- TEXAS – Magellan Behavior Health, Inc.⁴ no longer participates in the Medicaid program. Access is now Humana.
- UTAH – Altius¹ no longer participates in the Medicaid program.
- WASHINGTON – (1) Kaiser¹ and Regence¹ no longer participate in the Medicaid program; (2) Clark United Providers¹ is now Columbia United Providers¹; (3) Qual-Med¹ is now Molina¹.
- WEST VIRGINIA – Chartered Health¹ is now Health Priority¹.
- WISCONSIN – Physician Plus¹ no longer participates in the Medicaid program.

Terms used in "Managed Care Entity" column

<i>PCCM</i>	<i>Primary Care Case Management (PCCM) Provider</i> is a provider (usually a physician, physician group practice, or an entity employing or having other arrangements with such physicians, but sometimes also including nurse practitioners, nurse midwives, or physician assistants) who contracts to locate, coordinate, and monitor covered primary care (and sometimes additional services). This category include PCCMs and those PHPs which act as PCCMs.
<i>PHP</i>	<i>Prepaid Health Plan</i> provides less than comprehensive services on an at risk basis or one that provides any benefit package on a non-risk basis. For example, Medical-only PHP, Dental PHP, Transportation PHP, Mental Health PHP, Substance Abuse PHP, etc. Comprehensive services are defined in 42 CFR 434.21(B). There are several types of PHPs that States use to deliver a range of services. For example, a Mental Health (MH) PHP is a managed care entity that provides only mental health services. This category does not include those PHPs which contract as primary care case management.
<i>Commercial MCO</i>	A <i>Commercial MCO</i> is a health maintenance organization, an eligible organization with a contract under §1876 or a Medicare-Choice organization, a provider sponsored organization or any other private or public organization which meets the requirements of §1902(w). These MCOs provides comprehensive services to commercial and/or Medicare enrollees, as well as Medicaid enrollees.
<i>Medicaid MCO</i>	A <i>Medicaid MCO</i> provides comprehensive services to Medicaid beneficiaries, but not commercial or Medicare enrollees.
<i>HIO</i>	<i>Health Insuring Organization</i> provides for or arranges for the provision of care and contracts on a prepaid capitated risk basis to provide a comprehensive set of services.
<i>“Other” Managed Care Entity</i>	<i>“Other”</i> Managed Care Entity is used if the plan is not considered either a PCCM, PHP, MCO or HIO.

Terms used in "Reimbursement Arrangement" Column

Full Capitation (FUL)--A plan is paid for providing services to enrollees solely through capitation.

Partial Capitation (PAR)--A plan is paid for providing services to enrollees through a combination of capitation and fee-for-service reimbursements.

Fee-For-Service (FFS)--A plan or Primary Care Case Manager is paid for providing services to enrollees solely through fee-for-service payments plus in most cases, a case management fee.
