FOREWORD

AS OF JANUARY 4, 2006, TABLES 8 -11 HAVE BEEN REVISED.

This Sweetener Market Data (SMD) report is a compilation of sugar supply and distribution data for September 2005. These data are reported to USDA monthly by all sugar beet processors, sugarcane processors, and cane refiners located in the United States. Commercial sugar users, distributors, and traders are not required to report their stocks, imports, or exports. Such reporting is required by the Federal Agriculture Improvement and Reform Act of 1996.

Previous monthly data for imports of direct-consumption on Tables 1 and 7 - 11 are sourced from the Customs Bulletin Board. The Foreign Agricultural Service provides the estimate of imports of refined sugar for the current month.

September 2005 Sugar Market Review

Monthly Summary:

Beginning stocks in September are lower than a year ago, down 541,557 STRV. Total production is down 11,424 STRV. Beet sugar production is 34,603 STRV higher this September and raw cane sugar production is down 46,027 STRV. Total imports are up 204,140 STRV. Total supply is down 348,840 STRV from last September.

Total deliveries in September are 178,842 STRV higher than a year ago. Deliveries for domestic human consumption are higher this September by 180,853 STRV. Total sales for export decreased 11,078 STRV from a year ago. Total use is higher by 615,331 STRV from September 2004.

Fiscal Year (FY) to Date Summary:

Total FY '05 production to date is down 773,406 STRV with beet sugar production down 81,607 STRV and raw cane sugar production down 691,799 STRV. Total imports are up 149,030 STRV while imports for direct human consumption are up 78,247 for the same period last FY. Total supply is down 398,267 STRV from FY 2004.

Cumulative sales for export to date have decreased 29,458 STRV compared to the same period last FY. Total FY deliveries to date are up 353,298 STRV, just as deliveries for domestic human consumption are up 367,681 STRV from last FY. Total FY use is down 46,086 STRV from the same period in FY 2004.
