- I. <u>Purpose:</u> The purpose of this Memorandum of Understanding (MOU) is to establish the relationships, arrangements, and general procedures under which the Department of Justice, Federal Bureau of Prisons (FBOP) and the Corps of Engineers, Department of the Army (Corps) will operate in executing FBOP assigned tasks.
- II. Statutory Basis: This MOU is consistent with and is entered into under the provisions of the Jobs Bill (PL 98-8), the FBOP's authority to house prisoners (18 U.S.C.-4003 and 4042), and the Flood Control Act of 1965 (Section 219, P.L. 89-298).
- III. Policy: At the option of the FBOP, the Corps will provide design and/or construction management services which will be funded by FBOP. Nothing in this MOU shall be construed as requiring FBOP to use the services of the Corps, nor to require the Corps to accept the work assignments from FBOP. However, both agree to work together to define and describe the scope and magnitude of the construction management support required.
- IV. General Scope: This work may consist of real estate acquisition, Environmental Impact Assessment (EIA) preparation, constructibility review, and construction management of two 500 person capacity medium security correctional facilities at a total cost of approximately \$60 million. The exact location of these facilities is to be determined.

## V. Responsibilities:

- A. FBOP is responsible for items such as:
- l. Requirements Definition: FBOP will provide an adequate definition of requirements which will form the basis for design, real estate services, and environmental impact statement preparation.
- 2. Providing Funds: FBOP will provide the necessary funds to accomplish the work, and pay administrative costs.
- 3. Program Management: FBOP will provide priority, need dates, necessary approvals, and acceptance of the products. Upon completion of the work, each facility or product shall be accepted.
- 4. Design: FBOP will be responsible for design of the facilities (unless otherwise requested).

- B. The Corps is responsible for aleas (as mutually agreed) such as:
- 1. Project Management. The project will be assigned to the appropriate district for design and construction.
- 2. <u>Contracting</u>. The Corps will award all contracts and serve as the Contracting Officer.
- 3. Construction Management: The Corps will provide normal supervision and administration.
- 4. <u>Design Review:</u> The Corps will be responsible for design reviews, which normally take place at standard design milestones.
- 5. Real Estate Services: The Corps will provide Real Estate Services, as requested, using standard Corps real estate procedures.
- 6. Environmental Impact Statement: The Corps will provide an EIS, as requested. The FBOP shall retain lead agency responsibilities.
- VI. Funding: All work accomplished by the Corps under this MOU will be funded by SF 1151, Non-Expenditure Transfer Authorization. Budget Execution Reports will be furnished monthly on SF 133 in accordance with OMB Circular A-34.
- VII. Reports and Documentation: The Corps shall provide such normal and reasonable progress, financial and related reports as required by FBOP.

## VIII. Public Information:

- A. Justification and defense of the FBOP program before Congress, the Executive Branch of Government, and State Governments (EO 12372) shall be the responsibility of FBOP.
  - B. Public Affairs shall be the responsibility of FBOP.
- C. The Corps may provide information to FBOP to support contacts with Congress, The Executive Branch, and private citizens, but will in no way have direct contact or responsibility for such contacts.
- IX. Amendments and Termination: This MOU may be modified or amended by written agreement between FBOP and the Corps. It may be terminated by mutual written agreement or by either party giving 30 days written notice to the other. In the event of termination, the FBOP shall be responsible for the costs of closing out ongoing contracts, and the costs for demobilization of personnel and facilities fully dedicated to FBOP programs. The Corps shall retain contract administration responsibilities for contracts awarded by the Corps until such contracts have been terminated or their performance is completed.
- X. Effective Date: This MOU shall be effective upon signature by the principal FBOP and Corps officials. It shall remain in effect indefinitely; however, upon the request of either party, usually not more often than annually, both parties shall review this MOU to assure that it continues to reflect the appropriate understandings and procedures to recognize and provide for current needs and capabilities.

XI. Actual lork Description. After the signing of this Memorandum of Understand and before any work is performed, the Corps and FBOP shall agree, in westing, to the exact scope of actual work.

I am writing you to clarify the funding procedures to be employed in connection with our providing real estate and construction support services for the construction of your two new correctional facilities. Please refer to the joint Memorandum of Understanding (MOU) sent you by LTG Bratton's letter of 21 December 1983.

The following should be substituted for Section VI of that MOU:

VI. <u>Funding.</u> All work accomplished by the Corps under this MOU will be on a reimbursable basis. Monthly billings will be via SF 1080, "Voucher for Transfers between Appropriations and/or Funds."

The above wording was agreed to by our staffs (with Department of Justice representatives in attendance) to replace the SF1151 procedures cited in the MOU. This clarification is administrative in nature only and does not affect the basic intent of the MOU.

- 1. The Federal Bureau of Prisons (FBOP) has requested the Corps of Engineers to survey Federal land available in the "Northeast Corridor" for construction of a 500-person capacity medium security correctional facility. The FBOP is more specifically looking for sites from Washington, D. C. to Boston, Massachusetts, with a band of approximately 100 miles. A copy of the FBOP letter requesting the survey is enclosed. The letter encloses a site selection criteria list.
- 2. Request a Site Investigation Report be prepared for the FBOP. The report should include as a minimum the following:
  - a. Location.
- b. Site description, including number of acres and utilities available to site.
  - c. Accessibility to site.
  - d. Agency controlling site.
  - e. Status of land (i.e. excess, reported to GSA).
  - f. Availability of site.
  - g. Base map depicting site.
- 3. A briefing map is required showing all locations in the Site Investigation Report. The FBOP considers this project one of their urgent requirements. The report must be completed expeditiously and five copies of the report submitted to DAEN-REA-L. Every effort must be made to finish the report within 60 days. If the report is not completed in 60 days, request a progress report be provided to DAEN-REA-L.

SUBJECT: Request by Federal Bureau of Prisons (FBOP) for Real Estate

Site Investigation

PURPOSE: To inform the Assistant Secretary of the Army (Civil Works)

of an FBOP Request for Real Estate Site Investigation.

#### FACTS:

1. The FBOP has requested the Corps of Engineers to survey Federal land in the "Northeast Corridor" to identify sites for construction of a medium security correctional facility. The survey will be accomplished pursuant to the Memorandum of Understanding executed by the Assistant Secretary of the Army (Civil Works) on 6 December 1983.

2. The "Northeast Corridor" includes potential sites from Washington, D. C. to Boston, Massachusetts. We have requested the North Atlantic Division to prepare a Site Investigation Report for the FBOP. The report will be completed in approximately 60 days.
