This report provides statistics for land enrolled in the Conservation Reserve Program (CRP) as of the end of fiscal year 2004 (September 30, 2004). The report also includes a summary of FY 2004 CRP related activities, FY 2004 CRP outlays by payment type, enrollment changes since FY 2003, continuous CRP enrollment activity, outlay and sign-up history, CRP practice and payment provisions, and environmental benefits index (EBI) history.

The enrollment tables are based on contract data developed and maintained in CRP data files by Farm Service Agency (FSA) county offices and are based on the physical location of the CRP contracted land. Some adjustments have been made to correct mis-coded data in active contract files.

The report was prepared by Alex Barbarika, Natural Resources Analysis Group, Economic and Policy Analysis Staff (EPAS), Farm Service Agency (FSA), U.S. Department of Agriculture. 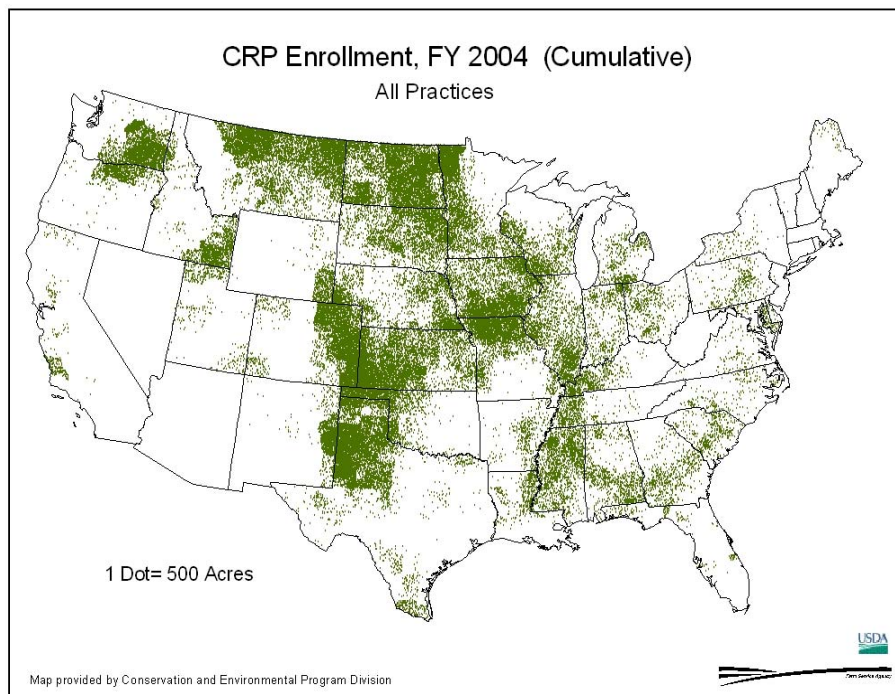

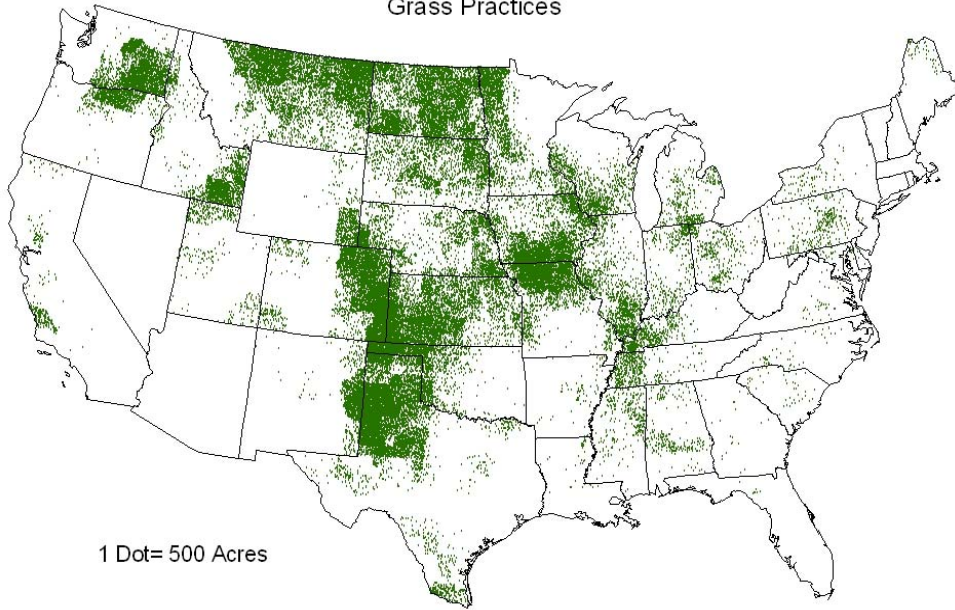

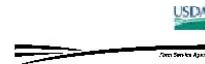


CRP Enrollment, FY 2004 (Cumulative) Grass Practices

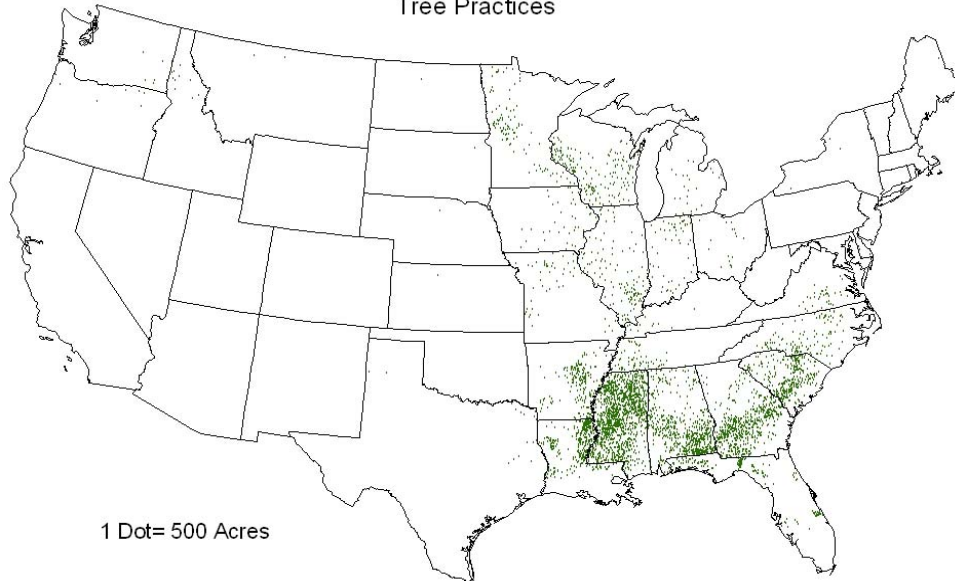

CRP Enrollment, FY 2004 (Cumulative) Tree Practices



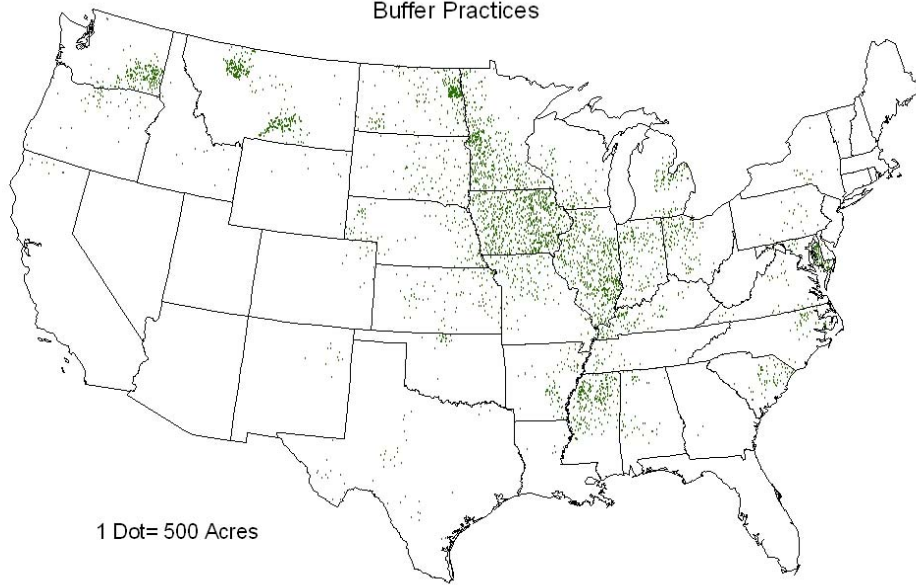

Buffer Practices



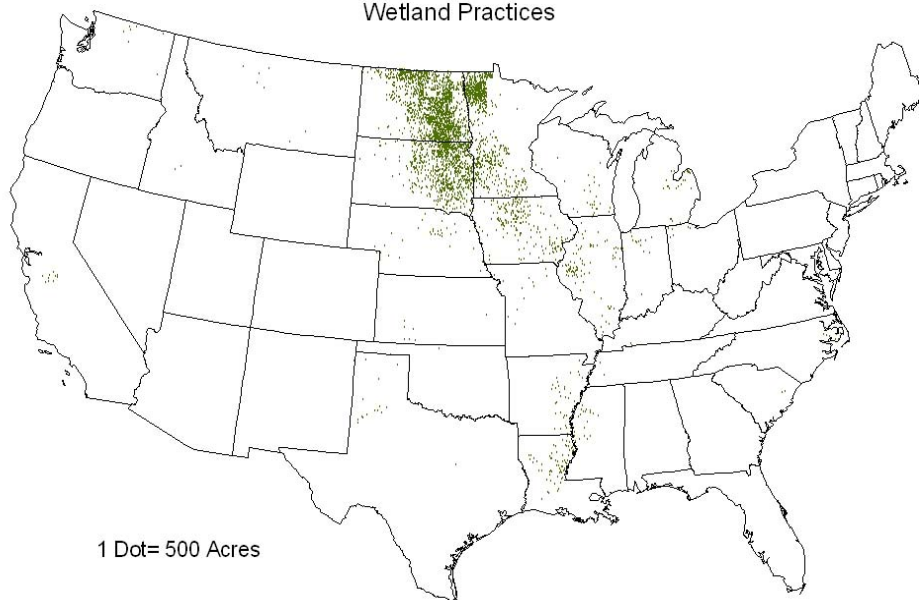

General Signup. Producers with eligible lands compete nationally for acceptance based on an environmental benefits index (EBI) during specified enrollment periods. Producers may submit offers below soil-specific maximum rental rates to increase EBI ranking.

Continuous (Non-CREP) Sign-up. Producers with eligible lands may enroll certain high priority conservation practices, such as filter strips and riparian buffers, at any time during the year without competition. In addition to annual soil rental payment and cost-share assistance, many practices are eligible for additional annual and one-time up-front financial incentives.

Conservation Reserve Enhancement Program (CREP). Under CREP agreements, Federal/State partnerships, implement projects designed to address specific environmental objectives through targeted CRP enrollments. Sign-up is held on a continuous basis, general sign-up practices may be included, and additional financial incentives are generally provided.

Farmable Wetland Program (FWP). Producers enroll small non-flood plain wetlands under modified continuous sign-up provisions.

CRP ACTIVITIES, FY 2004

- ◆ General sign-up:
 - Held general sign-up 29, from August-September 2004; 1.2 million acres accepted.
 - Contracts start October 1, 2005.
- ◆ Continuous sign-up, including farmable wetland program, increased 390,000 acres, reaching 2.9 million acres
- ◆ New and expanded CREP agreements:
 - New agreements signed with Ohio (Scioto River Basin), Pennsylvania (Ohio River Basin), New Jersey, and New York (12 watersheds).
 - Total acres under CREP agreements increased 205,000 acres to 1,799,000 acres.
 - CREP enrollment increased 92,000 acres to a cumulative total 596,000 acres.
- ◆ SIP's and PIP's (signing and practice incentive payments):
 - Incentives adopted in 2000 to increase continuous CRP enrollment continued for 2004.
 - Total SIP and PIP outlays through 2004: \$384 million.
- ◆ Sign-up for Bottomland Hardwood Tree initiative (up to 500,000 acres) began December 2003.
- ◆ Administration reported farmers and ranchers produced a net increase of 131,400 acres of wetland from 1992 to 2002.
- ◆ Published rule implementing long-term policy changes enacted in the 2002 Farm Bill. Final rule implemented increased enrollment cap (to 39.2 million acres), managed haying and grazing provisions, and expanded conserving use definition.
- ◆ Held "CRP: Planting for the Future" national conference in conjunction with U.S. Geological Survey. Over 200 participants attended the 3 1/2 day conference.
- ◆ Initiated Conservation Effects Assessment Project (CEAP), a 5-year effort to study the collective environmental benefits of USDA conservation programs.
- ◆ August 2003, President Bush announced:
 - USDA would offer opportunity for re-enrollment and extension of CRP contracts, beginning with contracts set to expire beginning in 2007.
 - Establishment of Northern Bobwhite Quail initiative. Enrollment of up to 250,000 acres of upland bird buffers begins in FY 2005.
 - Establishment of Wetland Restoration initiative, providing for enrollment of up to 250,000 acres of large non-floodplain and Playa wetland complexes under CRP continuous sign-up provisions. This is in addition to the flood-plain wetland (250,000 acres) initiative implemented in FY 2003.
- ◆ Also, in August, public asked for comments on re-enrollment, extension strategies.
