# **Garnishment Processing**

Social Security Administration

## Policy - Section 459

Mandates that Title 2 benefits are subject to being garnished because of a legal action brought by an individual in a State court to provide child support and/or make alimony payments

## Court Order Garnishment System

- National system for Social Security, established in March 2006.
- Automates withholding from beneficiaries in compliance with State or court ordered garnishment requests.
- Adjusts Title 2 benefits
- Issues payments to appropriate payees as designated in the garnishment order.
- Sends notices to the garnished beneficiary and the court.

## **COGS History**

- 18 garnishment screens were developed to input transaction data and view queries.
- 180,000 garnishment orders were converted so future processing against those orders could be automated.

## Income Withholding Order

- Beneficiary's own Social Security Number.
- The name of the beneficiary to be garnished.
- The case number for the garnishment order.
- Weekly/monthly withholding amounts.
- Additional factors for calculations.
- Payment address.
- Notice address.

#### Initially Establishing A Garnishment Order

- COGS will verify if there is a T2 record based on the SSN entered.
- If there is not an existing T2 record, COGS determines whether a claim was ever filed against that SSN.
- treat was ever med against treat Sort.

  If the T2 beneficiary is receiving benefits, COGS will set up a record to withhold garnishment payments.
- record to withhold gamishment payments. If the T2 beneficiary is not currently receiving benefits, there is an indicator placed on the T2 record. In the event benefits do become payable, we will withhold for gamishment. The COGS system calculates the garnishment payment based on where the garnished beneficiary lives. The rules for determining how much to withhold from the garnished beneficiary are maintained on COGS.

OPERATING MONTH – Is the month for which SSA is calculating the payment. If the operating month is SEPTEMBER, we are calculating the September 2007 Garnishment monthly payment that is payable on October 3, 2007.

When the last day of the operating month occurs—end of COM—the Garnishment Database is interrogated to determine all monthly payments that need to be made on active garnishment orders.

#### **Daily Payments**

The daily payments are generated from the COGS system every day. These daily payments can consist of a repayment for a return check, withholding from past due monies for a 12 beneficiary, or unpaid monies on COGS that are now due.

The daily payments are made from the first day of COM till the last day of COM. Any daily payment generated after the last day of COM until the end of that calendar month are held to the first day of the next calendar month. For example:

Daily's cannot be paid before 10/1/07.

PAYMENTS ARE SENT TO TREASURY TO BE DISBURSED.
