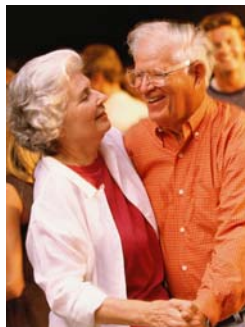


**Dear Family Caregiver:**

**New Oxygen Rules**

If you rent oxygen equipment, Medicare payments (and your coinsurance) for this equipment now stop after 36 months. But suppliers are required by Federal law to continue providing oxygen and oxygen equipment for up to 5 years as long as you medically need it, and to keep the equipment in good repair. **The supplier can't charge you anything for these services.**

## Don't Get Stuck on Hold

Medicare is here to help 24 hours a day, 7 days a week at 1-800-MEDICARE (1-800-633-4227). But before you call, check out **Medicare's new tip sheet** - it explains how to make the most of your call and **get the right answers, fast.**

If you're calling for a loved one, know that Medicare can't share their personal information unless your loved one gives permission, either in person or by having a completed authorization form on file. You can find both the **form** and the 1-800 tip sheet at [www.medicare.gov](http://www.medicare.gov).



## CAREGIVER TIP

Without a completed **"Authorization to Disclose Personal Health Information"** form, Medicare can't share personal health information, even with family members. Get the form at [www.medicare.gov](http://www.medicare.gov).

**Do it before you need it!**



## Part B Covers Heart Screenings

You can help lower your risk of a heart attack or stroke with Medicare-covered cardiovascular screenings. Medicare covers tests to screen for cholesterol, lipid, and triglyceride problems every 5 years. **There's no cost for the tests** (but you generally have to pay your share for the doctor's visit).

## Could You Be At Risk for Glaucoma?

Glaucoma is one of the top four causes of blindness in the U.S. **Medicare Part B covers glaucoma screenings** once every 12 months for people at high risk, including people with diabetes or a family history of glaucoma.

## Medicare Calendar

### Medicare Advantage Open Enrollment: Jan 1 - Mar 31

**What you can do:** All people with Medicare can join, drop, or switch Medicare Advantage Plans. You **can't** add or drop Medicare prescription drug coverage as part of this change.

- Compare plans online at [www.medicare.gov](http://www.medicare.gov).
- Call different plans in your area to compare.

### General Enrollment Period: Jan 1 - Mar 31

**What you can do:** Anyone eligible for Medicare can get Part A (Hospital Insurance) or Part B (Medical Insurance).

**Remember, Medicare eligibility isn't based on income - everyone can join.**

**Shopping around may get you better coverage, at a better price.**
