# Summary Report of Occurrences Reviewed From June 9 – 13, 2008

Summary: 25 occurrences at 15 sites reviewed during this period.

## **Significant Occurrences (1)**

### Near Miss – 1 occurrence at 1 site

• <u>EM – East Tennessee Technology Park (Significance Category 1).</u> On June 10, while performing equipment verifications in support of building characterization, two subcontract personnel entered a restricted area that was posted "DANGER – Do Not Enter - Floor Unsafe – Fall Hazards Beyond this Point." They crossed the barricades without approval and without fall protection and went into an area of degraded floor panels. They later safely exited the restricted area without incident. Work by this subcontractor on the operations floor of the K-25 Building has been suspended. All barricades and postings to the restricted area were verified intact and all work crews were reminded of the restrictions prohibiting access to the area.
