Summary Report of Occurrences Reviewed

From October 13 – 20, 2006

Summary: 27 occurrences at 13 sites reviewed during this period.

Significant Occurrences (3)

Injuries – 2 occurrences at 2 sites

- <u>Lawrence Berkeley National Laboratory (Significance Category 1</u>). On October 17, 2005, a fatality occurred when an employee fell from an upper story of Building 50-B. No further information will be released, pending a police investigation.
- <u>EE National Renewable Energy Laboratory (Significance Category 3)</u>. On September 22, 2006, a site employee was injured in an offsite motorcycle accident during official business travel. The employee was admitted to the Intensive Care Unit of a Salt Lake City hospital where he was listed in critical condition. The employee apparently suffered multiple, traumatic injuries from the accident including head and orthopedic-type injuries (e.g. spinal and pelvic fractures). The employee is slowly recovering, but is expected to require significant long-term care.

Occupational Safety/Industrial Hygiene Concerns – 1 occurrence at 1 site

• <u>Sandia National Laboratories (Significance Category 3)</u>. On October 16, 2006, it was determined one of four personnel air monitoring samples taken during stainless-steel welding operations at the Z Tank Upgrade Project exceeded the American Conference of Governmental Industrial Hygienists threshold limit value (TLV) for hexavalent chromium. Concerns were expressed regarding sampling methods, TLVs, and sampling results.
