## Summary Report of Occurrences Reviewed From November 17 – 21, 2008

Summary: 24 occurrences at 13 sites reviewed during this period.

#### **Significant Occurrences (2)**

#### Injuries – 1 occurrence at 1 site

• <u>NA – Y12 National Security Complex (Significance Category 3).</u> On November 17, a steam leak occurred on the third floor of 9204-2E. When a utility operator attempted to isolate the leaking line by shutting off a valve upstream of the leak, the pipe broke loose from the valve, causing steam burns to his face and neck area. The utility operator was wearing safety glasses and gloves at the time. He was taken by ambulance to a local hospital for treatment of his injures and released.

### Electrical Safety – 1 occurrence at 1 site

• <u>NA – Los Alamos National Laboratory (Significance Category 2).</u> On November 17, a worker sustained an electrical shock to his hands while attempting to secure a flickering light bulb on a survey camera being used to perform underground video surveying operations at Technical Area 54, Regional Well R-38. He and another worker were standing in water during the surveys. The worker used another camera to continue the surveys and did not report the shock until the following day. He was taken to the occupational medicine facility for evaluation and then released with no restrictions. The LANL Electrical Safety Officer indicated that the worker may have received a shock exceeding 100 volts DC in a wet environment.
