## Connecticut Producers Count

As you know, 2007 was a Census of Agriculture Year. You have until February 4, 2008 to return forms or complete this Census online. Through this census producers reveal the value and importance of agriculture to the nation. Your answers help influence decisions on the direction of future farm, food, energy, trade and rural development policies. The National Agricultural Statistics Service, which conducts this census, uses the information only for statistical purposes and publishes data only in tabulated totals. The report cannot be used for taxation, investigation or regulation. Even the Freedom of Information Act cannot be used to disclose an individual participant's information. This information is used by the USDA to appropriately staff their service centers and assist in targeting programs and services to the people and places that need them most. Community Planners use the information to target needed services to rural residents. Legislators use the information when shaping farm policies and programs. Farmers and ranchers can use the information to assist them in making decisions about the future of their own operations. Your answers help to shape the future of agriculture for years to come. # Farm Loan Program Rules have been streamlined!

January 1, 2008, Producers, Farmers and Ranchers will find it easier to apply for FSA's Farm Loan Programs. Over the past few years there has been a focus to streamline areas of the Farm Loan Programs such as the Guaranteed and Emergency Loan Programs by revising the loan making and servicing requirements and procedures. These changes are in an effort to better serve our applicants and borrowers. Some of the areas which have been streamlined are:


- Modifying requirements to more closely conform to those used by other lenders;
- Reducing federal regulations by more than 80 percent;
- Ensuring all forms are available online;
- Reducing the number of forms required by nearly 50 percent;
- Consolidating guidance into six handbooks instead of nearly 40 instruction manuals.

### Controlled Substance Provisions

Any person who is convicted under Federal or State law of a controlled substance violation could be ineligible for USDA payments or benefits. Violations include planting, harvesting, or growing a prohibited plant.

### Payments to Deceased Producers

FSA must be notified immediately upon the death of producers who are participating in FSA programs. Failure to notify FSA and make modification to program contracts may result in a loss of benefits for the share of the deceased producers and the other producers in the program contracts.

The U.S. Department of Agriculture (USDA) prohibited discrimination in all its program and activities on the basis of race, color, national origin, age, disability, and where applicable, sex, marital status, familial status, parental status, religion, sexual orientation, genetic information, political beliefs, reprisal, or because all or part of an individual's income is derived from any public assistance program. (Not all prohibited bases apply to all programs.)
