## DISASTER PROGRAM BUY-IN DEADLINE

The Farm Service Agency is accepting "buy-in" fees for the Supplemental Revenue Assistance Program (SURE), Livestock Forage Disaster Program (LFP), and other disaster assistance programs. Producers can establish 2008 eligibility for the new disaster assistance programs by paying the buy-in fee no later than Sept. 16, 2008, 90 days after the date of enactment, as required by the 2008 Food, Conservation and Energy Act of 2008 (the 2008 Act).

The SURE Program will replace the current Crop Disaster Program (CDP) and covers both production losses and economic losses due to fluctuating commodity prices. Producers will be required to obtain at least the catastrophic level (CAT) of Crop Insurance or non-insured crop disaster assistance (NAP) coverage for all crops in all counties in all states in which they have an interest.

THE LFP Program will be available to eligible livestock producers who suffered grazing losses due to drought on either native or improved pastureland with permanent vegetative cover or planted to a crop specifically for providing grazing. For 2009 and subsequent years, producers will be required to purchase NAP insurance for grazing land by the applicable crop closing date.

Producers who do not have insurance coverage (CAT or NAP) can "buy-in" for 2008 only. The fees are $\$ 100$ per CAT crop up to $\$ 300$ per producer per administrative county, or $\$ 100$ per NAP crop up to $\$ 300$ per administrative county. The maximum fee is $\$ 900$ per producer for all counties less any previously paid fees for CAT and/or NAP. Fees do not provide the producer crop insurance or NAP coverage; it only affords eligibility for the 2008 disaster programs.

## NON-INSURED CROP DISASTER ASSISTANCE PROGRAM

USDA's Noninsured Crop Disaster Assistance Program (NAP) provides financial assistance to producers of noninsurable crops when natural disasters cause low yields, loss of inventory, or prevented planting.

Producers are reminded that in order to remain eligible for NAP assistance, the following crop information must be reported annually: name of crop; type and variety; location and acreage of the crop; share of the crop and the names of other producers with an interest in the crop; type of practice used to grow the crop; date the crop was planted in each field; and intended use of the commodity. In addition, the following production information must be provided annually: the quantity of all harvested production of the crop in which the producer held an interest during the crop year; the disposition of the harvested crops, such as whether it is marketable, unmarketable, salvaged or used differently than intended; and verifiable or reliable crop production records (when required). Failure to report acreage and production information may result in reduced or zero NAP assistance.

If a crop or planting is affected by a natural disaster, you must notify your local Farm Service Agency office and complete form CCC-576, Part B (the Notice of Loss portion of the Notice of Loss and Application for Payment) within 15 calendar days of the: natural disaster occurrence; final planting date if your planting was prevented by a natural disaster; date damage to the crop or loss of production becomes apparent to you.

The administrative fees for NAP have increased to $\$ 250$ per crop, $\$ 750$ per county, and $\$ 1,875$ per producer for all counties. Coverage will not begin until the later of 30 calendar days after application for coverage is filed for the crop or the date the crop is planted not to exceed the final planting date.

The following 2009 NAP application closing dates have been extended to December 1, 2008 :
Sage, strawberries, Value Loss crops (Ornamental Nursery, Aquaculture, Christmas Trees, Ginseng, Turf Grass Sod, Mushrooms, Floriculture, Strawberry Rootstock), barley, oats, rye, wheat, alfalfa, apples, blackberries, blueberries, caneberries, grapes, mixed forage \& grass (grazing/haying), honey, lespedeza, peaches, pecans, plums, raspberries.

## PAYMENT LIMITATIONS

USDA payments and benefits are subject to producer eligibility and limitation provisions as defined by law. Documents and forms to determine eligibility and limitation are reviewed on an annual basis. It is the producer's responsibility to report changes in the farming operation that may affect payment eligibility and payment limitation.

The following limitations apply to Direct and Counter-cyclical Program payments for the 2008 contract year. For all covered commodities: $\$ 40,000$ for direct payments and $\$ 65,000$ for counter-cyclical payments. The Environmental Quality Incentive Program has a $\$ 450,000$ payment limitation. The Conservation Reserve Program annual limit is $\$ 50,000$ per person.

Entities such as corporations, limited partnerships, trusts and estates are required to provide names, addresses, and ID numbers of their members. These entities should also identify every payment under more than one entity.

Adjusted Gross Income - Effective through 2008, an individual or entity shall not be eligible for certain program benefits during a crop, program or fiscal year if both of the following apply.

- The three-year average adjusted gross income for the individual or entity exceeds $\$ 2.5$ million; and
- Less than 75 percent of the average AGI is derived from farming, ranching or forestry operations.
