**County Committees:** The Farm Service Agency county/area committees are responsible for the administration of Federal farm programs at the local level.

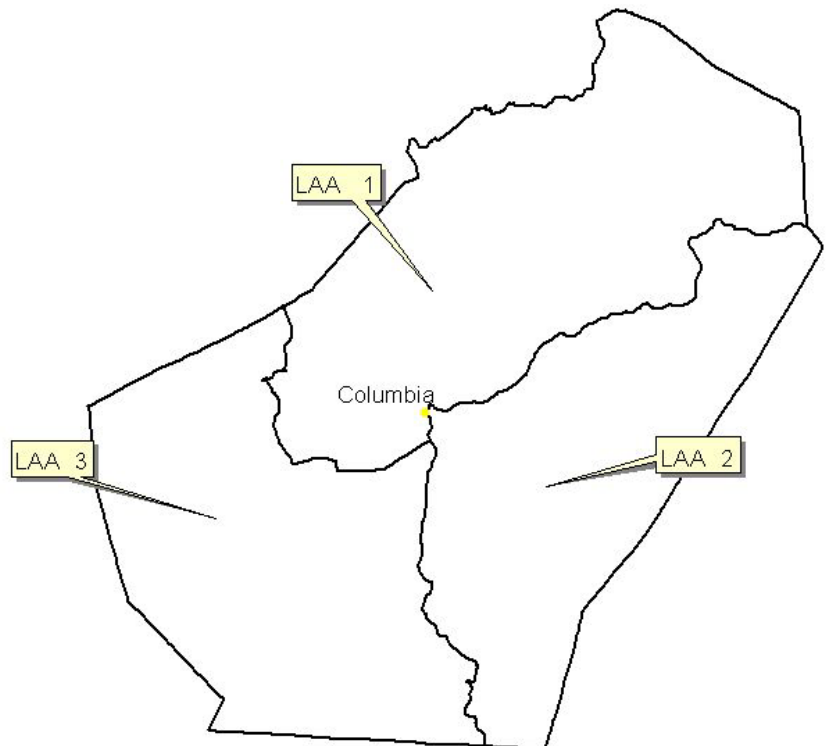
**Committee Nominations Open:** Nominations for candidates to run for the Farm Service Agency committee election representing producers in Local Administrative Area (LAA) 3 will be accepted from June 15 through August 1, 2008. LAAs are election areas. Elections are held each year to elect or re-elect a member whose term will expire.

Adair County will be holding an election for a person to represent LAA 3 beginning January 1, 2009. That position is currently held by Maxie Campbell. LAA 3 includes the portion of Adair County that is South of a line from Green County along HWY 61 N to the Milltown Rd to Milltown Church Rd to HWY 80 West to Bliss Rd to the Louie B Nunn Parkway east to Hwy 55 S to HWY 704 and along HWY 704 to the Cumberland County line.
