Bourbon County will be holding an election for a person to represent LAA1 and LAA5 beginning January 1, 2009.

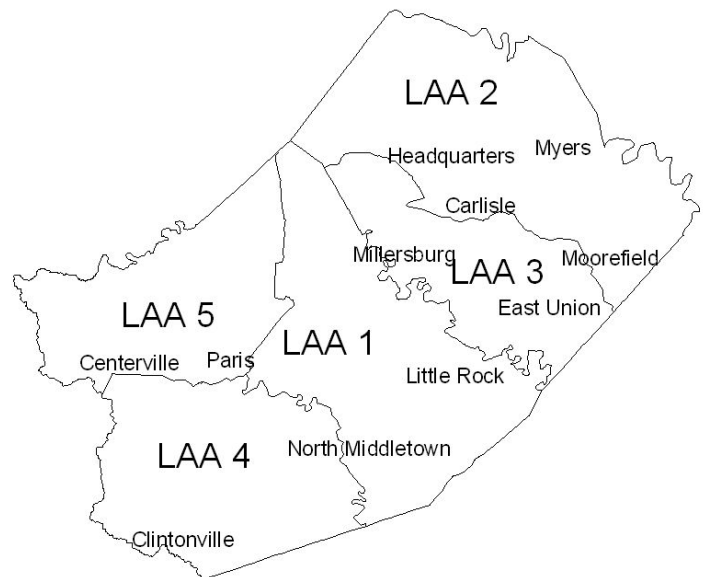
Those positions are currently held by:
