County Committees: The Farm Service Agency county/area committees are responsible for the administration of Federal farm programs at the local level.

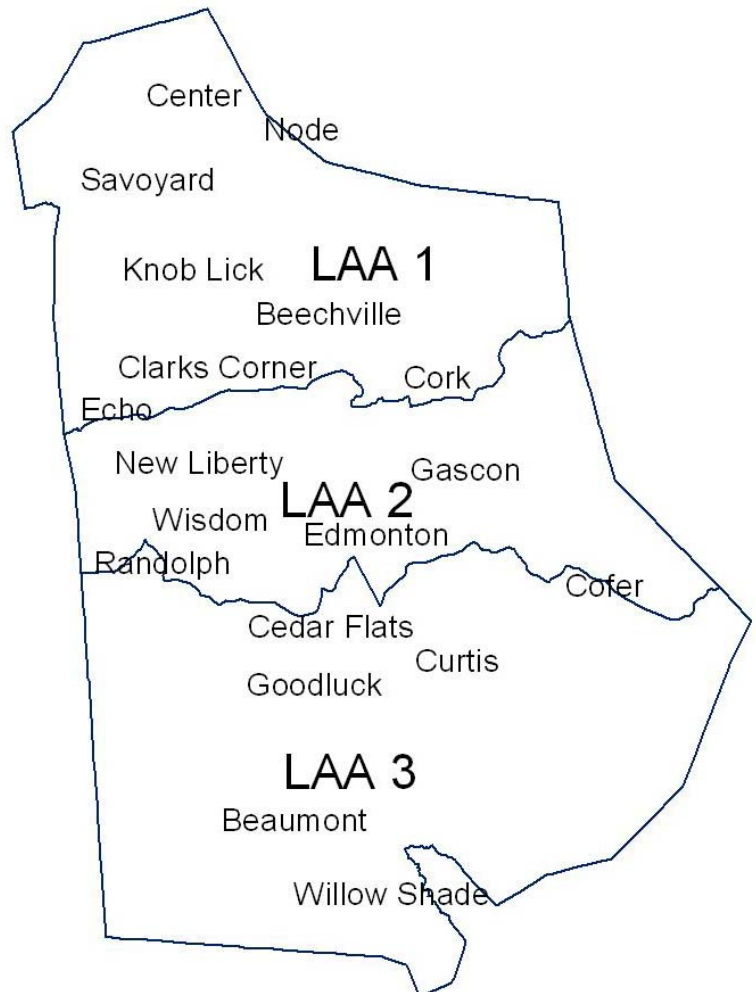

LAAs are election areas. Elections are held each year to elect or re-elect a member(s) whose term will expire.

Metcalfe County will be holding an election for a person to represent LAA 1 beginning January 1, 2009. That position is currently held by Lenwood Jones who has served his term limit of 9 years. LAA 1 includes the area From Hart and Green County Line on North to Echo, Toby Hill, Les Nickols, Foundation Mitchell Roads and HWY 544 on south side
