County Committees: The Farm Service Agency county/area committees are responsible for the administration of Federal farm programs at the local level.

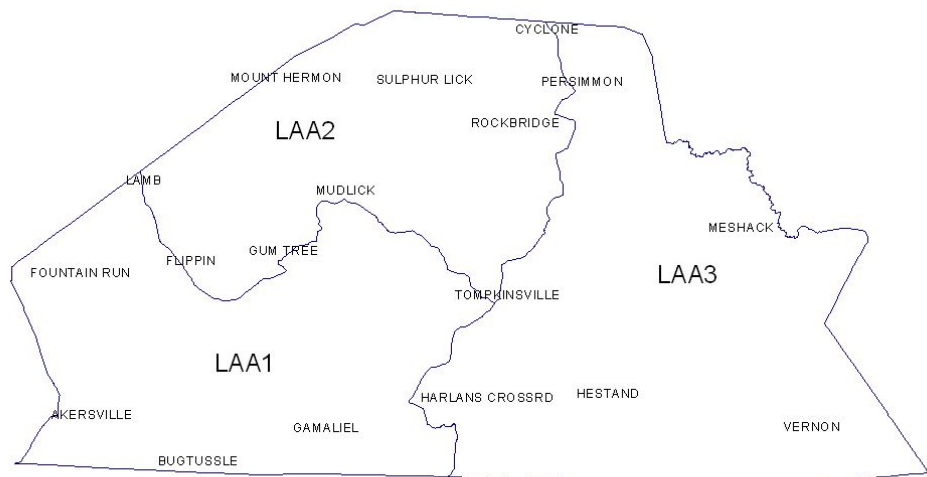
