**County Committee:** The Farm Service Agency county/area committees are responsible for the administration of Federal farm programs at the local level.

**Committee Nominations Open:** Nominations for candidates to run for the Farm Service Agency county committee election representing producers in Local Administrative Area (LAA) THREE will be accepted from June 2<sup>nd</sup> through August 1, 2008. LAA's are election areas. Elections are held each year to elect or re-elect a member(s) whose term will expire.

**Ohio County** will be holding an election for a person to represent LAA (3) beginning January 1, 2009. That position is currently held by L.C. Midkiff. LAA (3) includes the area: consists of all farms with headquarters beginning at the Daviess County line and Highway 231 north and west of a line following Highway 231 south to Union Street in Hartford and then Oakwood Drive to Highway 69 then north to Fordsville to Highway 54 and then east on Highway 54 to Highway 110 at Shrever then following Highway 110 to the Breckenridge County line.
