



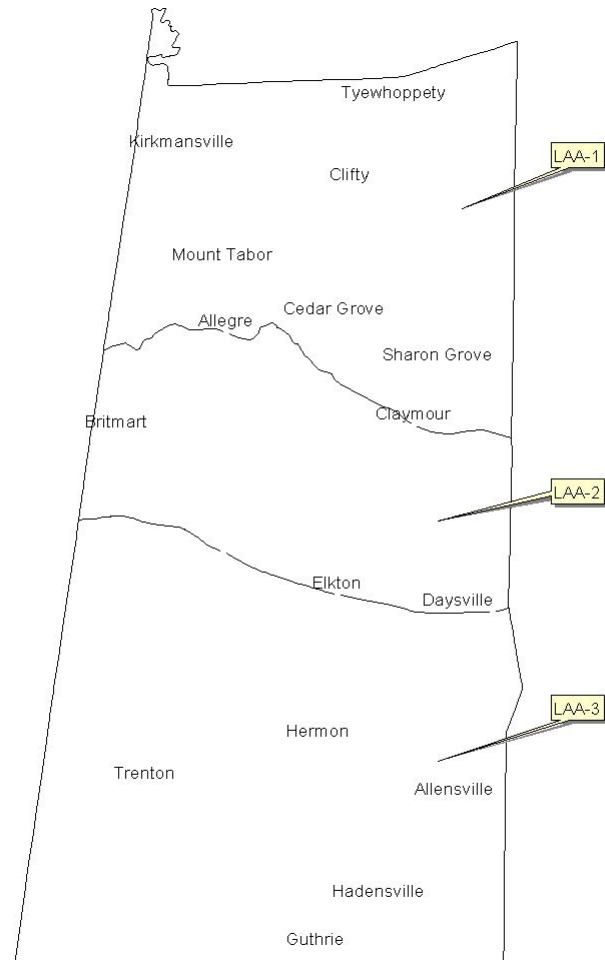

County Committee Elections

Todd County will again be holding county committee elections for the upcoming calendar year. This election will be held to determine the person to serve in Local Administrative Area (LAA) # 2, held by incumbent Ralph Robertson, who currently serves in the chair position. Todd Shackelford, LAA-3, will serve as vice-chair, and Don Laster serves as regular member from LAA-1. Each committeeman invites you to contact them regarding issues in your LAA, or contact the county office at 101 Elk Fork Road. The Todd County Committee meets every month, usually on the first Wednesday of the month unless a conflict warrants a change of meeting date. ITEM 3 The nominee must check one of the boxes to indicate a preference regarding the settling of tied votes.

ITEM 4 The nominee must sign and date.

ITEM 8 Completing this item is voluntary.

ALL FORMS MUST BE RECEIVED IN THE COUNTY OFFICE OR POSTMARKED BY AUGUST 1.

NOTE: *The following statement is made in accordance with the Privacy Act of 1974 (5 USC 552a) and the Paperwork Reduction Act of 1995, as amended. The authority for requesting the following information is 7 CFR Part 7. The information will be used to obtain nominees for County FSA Committee.*
