Webster County will be holding an election for a person to represent LAA Two beginning January 1, 2009. That position is currently held by Larry Melton. LAA Two includes the Liberty, Lisman, Shelton, Tilden, Dixon, and the west side of the Slaughters areas.

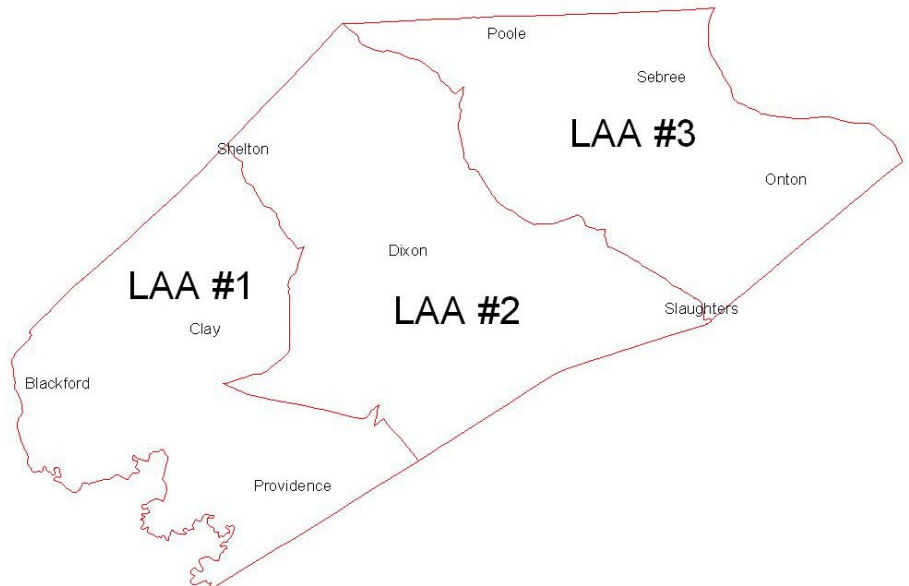

Beginning at the Union County line to Hwy. 857; follow Hwy 857 South to Hwy. 132 going East, at Free Union follow Crab Orchid Creek South, follow Crab Orchid Creek South to Slover Creek – East, follow Slover Creek to Hwy 41A, go on Hwy 41A South and turn East onto Corinth Church Rd toward Hopkins County line, follow Hopkins County line North to Slaughters, at Slaughters take Hwy 138 West to Carnel Brooks Rd take Carnel Brooks Rd to Rakestraw Bottoms Rd follow Deer Creek to Hwy 2839 then turn onto Hwy 56 toward Union County.

NOTE: *The following statement is made in accordance with the Privacy Act of 1974 (5 USC 552a) and the Paperwork Reduction Act of 1995, as amended. The authority for requesting the following information is 7 CFR Part 7. The information will be used to obtain nominees for County FSA Committee.*
