COUNTY COMMITTEES: Farm Service Agency (FSA) County Committees are responsible for administering federal farm programs at the local level.

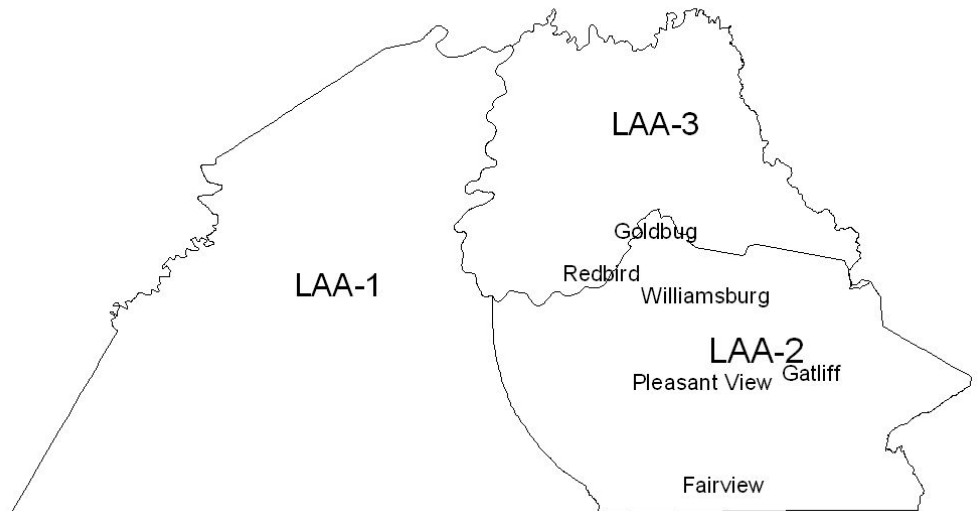
COMMITTEE NOMINATIONS OPEN: Nominations for candidates to run for the Farm Service Agency County Committee election representing producers in Local Administrative Area (LAA) 2 will be accepted from June 16 through August 1, 2008. LAA's are election areas that hold elections each year to elect or re-elect a member whose term will expire.

Whitley County will be holding an election for a person to represent LAA 2 beginning January 1, 2009. That position is currently being held by Nancy Shelley. Mrs. Shelley has served three terms and is no longer eligible to run for the committee. Therefore, her position will be vacant. LAA 2 is the southern section of Whitley County.
