## About the Contributors

Daniel L. Burghart (co-editor) is a Senior Fellow at the Center for Technology and National Security Policy at the National Defense University. A specialist in Russian, Commonwealth of Independent States (CIS) and Central European Affairs, he served for 30 years as an Army Foreign Area Officer before retiring as a Colonel in June 2003. Dr. Burghart has been a professor at the National War College, Senior National Security Policy Advisor at the Defense Threat Reduction Agency, U.S. Defense and Army Attaché to Kazakhstan, and a Mission Commander at the On Site Inspection Agency, where he led arms control inspections in the republics of the Former Soviet Union. He also has been the Senior Russian Military Analyst and Eurasian Branch Chief on the Army Staff, Professor of Russian and East European Studies at the Military Academy at West Point, and Director of Area Studies at the U. S. Army Russian Institute. In addition to a B.A. in Political Science from the University of Illinois, Dr. Burghart has a dual Masters in Political Science and Russian Area Studies from the University of Wisconsin and a Ph.D.. in Russian and International Studies from the University of Surrey. He has published articles in defense and civilian journals and is the author of the book *Red Microchip: Technology* Transfer, Export Control and Economic Restructuring in the Soviet Union.

Theresa Sabonis-Helf (co-editor) is a Professor of National Security Strategy at the National War College in Washington, DC. She was previously Energy and Environment Policy Advisor for a Harvard Institute for International Development project, based in Central Asia. She received her Ph.D.. in Political Science from Emory University, her M.P.A. in International Relations from Princeton University, and her B.A. in Literature from Emory University. She has worked as a policy analyst, and as a visiting fellow at the U.S. Agency for International Development. Dr. Sabonis-Helf is a specialist in Environment Policy; Energy Policy and Energy Security; Climate Change Policy; and International Political Economy. She has lived and worked in seven countries of the former USSR, and has published articles on post-Soviet energy and environmental issues, as well as on post-Soviet culture and contemporary history.

Sylvia Woody Babus is a Professor of Behavioral Sciences in the Department of Leadership and Information Strategy at the Industrial College of the Armed Forces at National Defense University. She is a graduate of the University of Chicago, and earned M.A. and Ph.D. degrees in International Relations and Sino-Soviet studies from Columbia University. Dr. Babus has taught political science and international relations at the University of Manitoba in Winnipeg, Canada, and at Goucher College in Towson, Maryland. During 10 years at the State Department's Foreign Service Institute, she supervised training for Foreign Service Officers in negotiation, multilateral diplomacy, executive-congressional relations, arms control, and political military issues. Her assignments at State included tours in Belgium and Kyrgyzstan, as well as two years as a Foreign Service Officer in Uzbekistan. From 1998 to 2001, she managed democracy-building assistance programs in Ukraine and Belarus as a Civil Society Advisor for the U.S. Agency for International Development Mission in Kyiv. Her publications include an undergraduate text on current affairs, as well as works on Soviet-Third World Relations, Gorbachev, Soviet ideology and foreign policy, Central Asian security issues, and training of U.S. Government officials for interagency work.

Robert Brannon has served for 30 years in the U.S. Navy. During three years in Russia as the U.S. Naval Attaché, he was present for the economic crash of August 1998, the post NATO intervention in Kosovo armed riots at the embassy, and the submarine Kursk disaster. He has an M.A. in International Relations and is a Ph.D. Canididate in World Politics at The Catholic University of America, where he is currently working on a dissertation in Post-Soviet Russian civil-military relations. Following a year at Harvard University's Kennedy School of Government as the senior national security research fellow, Captain Brannon now is an instructor in the Department of National Security Studies at the National War College, where he holds the Chief of Naval Operations Chair.

Emily Ewell Daughtry will join the Office of the Legal Advisor at the U.S. Department of State in September 2004. Previously, she worked for six years at the Center for Nonproliferation Studies (CNS) of the Monterey Institute of International Studies, where she specialized in issues concerning Central Asia, export controls, and nuclear smuggling. From 1998 to 1999, Ms. Daughtry founded and served as Co-Director of the CNS office in Almaty, Kazakhstan. She holds a J.D. from the University of Califor-

nia, Los Angeles and a B.A. in Russian and East European Studies from Middlebury College.

Gregory Gleason is Professor of Political Science and Public Administration at the University of New Mexico. He is the author of Federalism and Nationalism: the Struggle for Republican Rights in the USSR (1991), Central Asian States: Discovering Independence (1996), and Markets and Politics in Central Asia (2003) as well as scholarly articles in Europe-Asia Studies, Problems of Post-Communism, Asian Perspective, Comparative Strategy and other journals. Dr. Gleason has had research sponsored by the National Science Foundation, the National Council on Eurasian and East European Research, and the U.S. Institute of Peace and also has conducted research under the auspices of the Academies of Science of the USSR, the Russian Federation, Uzbekistan, Kazakhstan, and Tajikistan. In addition, he has worked as a consultant to the United States Information Service, Sandia National Laboratories and Los Alamos National Laboratory. Dr. Gleason has worked in various capacities on market and political reform projects sponsored by the U.S. Agency for International Development and the Asian Development Bank. He currently focuses on the politics of Eurasian integration.

Genevieve Grabman is a public health lawyer with expertise in Central Asia. She has a Master of Public Health from Johns Hopkins University and a Juris Doctor from Georgetown University. From 1996 to 1998, she served as a U.S. Peace Corps Volunteer in Kyrgyzstan where she worked at the United Nations Children's Fund in health and human rights programming. Following her Peace Corps service, Ms. Grabman was the Kyrgyzstan program manager for a health sector reform project supported by the United States Agency for International Development (USAID) and the World Bank. She later was a consultant with the POLICY Project, a USAID reproductive health and HIV/AIDS initiative, where she helped integrate human rights law in developing countries' health policies. Currently, Ms. Grabman is a legislative and policy associate at the Center for Health and Gender Equity.

**Kevin D. Jones** previously worked in Central Asia for the United States Agency for International Development (USAID) as the Private Sector Advisor, Kyrgyzstan Country Office. In this position he oversaw the implementation of the enterprise development, fiscal reform and regional

He was directly involved in the land privatization process as an advisor to the host countries policy makers, land reform development projects, and U.S. government officials. Prior to USAID, he was a Sustainable Economic Development Peace Corps Volunteer in Kyrgyzstan, providing private farmers with business and economic assistance. Jones is currently pursuing a Ph.D.. in International Economic and Security Policy from the University of Maryland,

Roger D. Kangas is a specialist on Central Asia and the Caspian Sea basin at the George C. Marshall Center in Germany. Dr. Kangas graduated from the School of Foreign Service at Georgetown University and earned his Ph.D.. in Political Science at Indiana University. Nancy Lubin is President of JNA Associates, Inc., a research/ consulting firm dealing with issues of the newly independent states (NIS), especially Central Asia and the Caucasus. She has lived, worked and traveled throughout this region for 30 years—as a Congressional staffer, university Professor, and now for JNA—and consults for international donors, the media, private foundations, the U.S. government, and corporations ranging from Fortune 500 to smaller, start up companies. She has been a Fellow at the U.S. Institute of Peace, the Woodrow Wilson Center, and elsewhere, and holds a Ph.D. from Oxford University, a B.A., Magna Cum Laude, from Harvard University, has studied at the Universities of Moscow and Leningrad, and was one of the first Westerners to conduct doctoral research for one year in Uzbekistan (1978-79). He was previously Director of the Program on European Societies in Transition at the Atlantic Council of the United States. During 26 years in the United States Foreign Service, he served twice in the Political Section of the Moscow Embassy, as a specialist on domestic Soviet and Russian politics. Michael Ochs has been a Professional Staff Advisor at the Commission on Security and Cooperation in Europe [Helsinki Commission], U.S. Congress since 1987.
