Milk Income Loss Contract Program signup underway

Signup for the Milk Income Loss Contract (MILC) program began December 22, 2008 and will continue through the expiration of the program, September 30, 2012. However, in order for producers to have maximum flexibility in choosing a contract start month, contracts must be signed no later than January 21, 2009.

The 2008 Farm Bill reauthorized the MILC program and made three key changes in operations.

There is now a 'feed cost adjuster', which increases the \$16.94/cwt benchmark price upward depending on the cost of feed rations. When the monthly National Average Dairy Feed Ration Cost exceeds \$7.35/cwt then 45% of the excess will be added to the \$16.94 price when figuring MILC payment rates. The production limits per operation increased to 2.985 million pounds per fiscal year from October I, 2008 through August 31, 2012 and then reverts back to the original 2.4 million pound limit for September 2012. Also, if an individual or entity has annual non-farm adjusted gross income exceeding \$500,000 they will not be eligible for MILC benefits. Dairy producers can apply for MILC at their local FSA office. Remember that January 21, 2009 is the deadline to complete your contract and choose any month as your contract start month.

DCP Program signup underway (ACRE signup to begin in Spring)

Enrollment for the 2009 Direct and Counter-cyclical Payment (DCP) Program for farms with commodity base acres began December 22, 2008 and will continue until June I, 2009. No late-filed applications will be accepted. DCP payments are computed using base acres and payment yields established for each farm. Direct payment rates are established by statute regardless of market For 2009, eligible producers may request to receive an advance direct payment of 22%. Countercyclical payment rates vary depending on market prices and are issued only when the effective price for a commodity is statutorily set below its target price.

Producers eligible for DCP will also be eligible to enroll in the Average Crop Revenue Election (ACRE) Program. Enrollment for ACRE will begin in the spring. ACRE provides a safety net based on revenue losses and acts in place of the pricebased safety net of DCP counter-cyclical payments. ACRE payments are computed on the crops planted each year rather than the historical base acres. ACRE payments are issued when both the State and farm incurs a revenue loss from price and/or production losses. The total acres a producer may receive ACRE payments on may not exceed the farm's total base acres. In exchange for participating in ACRE, producers forfeit 20% of the farm's direct DCP payment, all countercyclical payments and marketing assistance loan rates will be reduced 30%.
