## **PRIVACY ACT NOTICE**

### **AUTHORITY**

Section 4, 1944 Flood Control Act as amended, PL 87-874.

### **PURPOSES**

This application is used in considering the issuance of permits for mowing, landscaping and other activity involving vegetation by private landowners located adjacent to Corps real property and/or lakes.

### **ROUTINE USES**
