SESSION 00-05 OF ALTERNATE REPRESENTATIVES

SUMMARY RECORD

The Council, represented by its Alternate Representatives, met via conference call on 6 June 2000. Mr. William Nitze (United States) chaired the meeting. Ms. Norine Smith and Mr. José Luis Samaniego represented Canada and Mexico respectively. Ms. Donna Tingley represented JPAC and Ms. Janine Ferretti, Executive Director, the Secretariat. Mr. Cristóbal Vignal, Council Secretary, acted as Secretary of the session. Other officials of the Parties and the Secretariat were also in attendance.

Item 1 Adoption of the agenda

The Alternate Representatives adopted the agenda at the beginning of the session based on the provisional agenda. The agenda as approved can be found in Annex A.

Item 2 Approval of summary record

The Alternate Representatives approved the summary record of Session 00-03. Adoption of the summary record of Session 00-04 was postponed to the next session in order to incorporate the Parties' decision concerning the PRTR multi-stakeholder task force.

Item 3 Report by the Executive Director

In the interest of time, the Executive Director deferred her report to the next session.

Item 4 Report by the Chair of JPAC

The JPAC Representative indicated that at its upcoming session in Dallas, JPAC will be focussing its attention on the following issues: matters related to Articles 14 and 15; enforcement cooperation and the revised draft Guide on Elements for Improving Environmental Performance and Compliance through Effective Environmental Management Systems; the North American Fund for Environmental Cooperation; and methods for project evaluation.

On behalf of the JPAC Chair, Ms. Tingley further indicated that the Chair of JPAC had not yet completed canvassing the members for their views on the proposed Articles 14 and 15 experts working group. She indicated that JPAC would be discussing this specifically in Dallas and that it would be premature at this time to infer JPAC's views.

The Alternate Representatives accepted JPAC's invitation to present a brief report to the public at the beginning of the JPAC Session on 11 June.

Item 5 2000 Regular Session of the Council

The Alternate Representatives made final adjustments to the general program of the session. The host country confirmed that the United States will be hosting a welcoming reception on Sunday evening at the Sheraton hotel. A private dinner for the ministers will be held following the welcoming reception; a separate dinner will be organized in parallel for the Alternate Representatives. A private dinner for the Alternate Representatives may also be held on Saturday evening, subject to the availability of the Canadian Alternate Representative.

The Alternate Representatives also reviewed the provisional annotated agenda for the Council's in-camera session and proposed minor changes to the draft Council Resolutions. The Secretariat indicated that the Report of the Internal Review of NAFEC is available in English and that the Executive Summary will be available in the three languages prior to the Council Session. The Alternate Representatives agreed that these documents should be made available to the JPAC.

Item 6 Article 14 and 15 Working Group

The Alternate Representatives discussed various options related to the creation of a forum where issues arising in the context of Articles 14 and 15 can be addressed, and agreed that this matter should be further explored by the Council during at its forthcoming session.

Item 7 French version of revised Articles 14 and 15 Guidelines

Mexico concurred with the linguistic review of the French version of the Articles 14 and 15 Guidelines conducted by Canada and the Secretariat. The United States indicated that it would endeavor to sign-off on the French version prior to the Council Session.

Item 8 NAAEC Article 10(6) public inquiries – Methanex Corp.

The Parties undertook to finalize the draft response to the letters dated 28 June and 28 December 1999 from Sierra Club of Canada et al. by 9 June 2000.

Item 9 Other issues

The Alternate Representatives summarized the results of the Article 10(6) meeting of Environment and Trade Officials and confirmed that the next meeting will take place following the North American Symposium on Understanding the Linkages between Trade and Environment in October 2000.

The United States undertook to draft a response to the letter of 27 April 2000 addressed to the Council by various NGO's.

Item 10 Next session of Alternate Representatives

The next session of Alternate Representatives will be held on Sunday 11 June in Dallas.
