FINANCIAL ASSISTANCE

Limited financial assistance is available for not-for-profit organizations and individuals requiring financial assistance to participate in the Regular Session of the Council and parallel events. The deadline to apply for financial assistance is **21 April 2002.**

Funding will be limited to one representative per organization and will be awarded in accordance with the following criteria of the CEC Framework for Public Participation. (Note that preference will be given to applicants who have not received financial assistance in the past, and that government representatives are not eligible for financial assistance):

- a) Ensuring a wide range of views and interest—public participants should be selected from different sectors representing a broad range of views in each country;
- b) Demonstrated expertise with the topic(s) to be dealt with at the public meeting;
- c) Ability to present specific, concrete and constructive proposals.
