SUMMARY RECORD

SESSION 99-11 OF ALTERNATE REPRESENTATIVES

The Council, represented by its Alternate Representatives, met in Montreal on 18-19 November 1999. Mr. William Nitze (United States) chaired the meeting. Ms. Norine Smith and Mr. José Luis Samaniego represented Canada and Mexico respectively. Mr. Jonathan Plaut represented JPAC and Ms. Janine Ferretti, Executive Director, the Secretariat. Mr. Marc Paquin, Secretary to the Council, acted as secretary of the session. Other officials of the Parties and the Secretariat were also in attendance (see Annex A).

Item 1 Adoption of the agenda

In accordance with the Council Rules of Procedure, the Alternate Representatives adopted the agenda for the session at the beginning of the session based on the provisional agenda. The agenda as adopted is attached as Annex B.

Item 2 Report by the Executive Director

In accordance with the Council Rules of Procedure, the Executive Director reported on Secretariat activities, including on the status of Article 14 submissions, and highlighted matters requesting the attention of the Council. The Executive Director's notes are attached as Annex C.

In response to a question raised by the Chair of JPAC, the Executive Director indicated that the Seattle host organization is sponsoring a Trade and Environment session before the WTO Ministerial and that the Secretariat will be participating in one of the panel discussions.

The Parties then discussed tentative dates for the regular session of the Council of next June.

Item 3 Report by the Chair of JPAC

Under this item the JPAC Chair provided an update to the Alternate Representatives on JPAC activities. He indicated that the election of the Chair of JPAC for 2000 was well underway and that the process should be completed by the end of November. The JPAC Chair also mentioned that JPAC forwarded to the Secretariat a letter received from the Great Lakes Fishery Commission concerning aquatic invaders. He further indicated that the *Environmental Health Coalition* had also sent a letter regarding issues of timeliness and confidentiality in the context of the Article 14 submission process related to *Metales y Derivados*. He stressed the novelty of such a letter being addressed to the JPAC. He then underlined the comments received from the public in general, and first nation groups in particular, on the Mercury NARAP. He finally reported that the US White House had recently appointed Mr. Steve Owens as a member of JPAC to fill in one of the two US vacancies on the committee.

Final version - 1 - 1711/99-11/038 (17/05/01)

The United States indicated that it is in the process of identifying a candidate to fill the second US vacancy.

Mexico commented on how slow, altered and controversial the Article 14 process had become compared to what the original intent was of promoting cooperation amongst the parties and having interpretative issues put before Council, for review and discussion without delay, when they arise. Mexico further indicated that the review process of the 2000-2002 program plan it conducted with its NAC led to very enriching exchanges.

Item 4 Adoption of summary records

The Alternate Representatives approved the summary records of sessions 99-09 and 99-10.

Item 5 Review of 2000-2002 Program Plan

The Alternate Representatives reviewed the Proposed 2000-2002 Program Plan and approved, in principle, various proposed projects for the year 2000. The Secretariat was tasked with redrafting some project descriptions. The Alternate Representatives agreed to continue their review at their December meeting.

Item 6 Children's health and the environment

The Alternate Representatives discussed the proposed project on children's health and the environment and agreed, subject to availability of funds, to task the Secretariat with the preparation of a report on the matter. The Alternate Representatives further agreed to provide a central point of contact for coordination and assistance to the Secretariat in the preparation of the report. The report is to be ready in time for its release at the next regular session of the Council next June.

Item 7 NAAEC Articles 14 and 15

Item 7.1 Submission no 97-006: friends of the Oldman River

The legal group was tasked by the Alternate Representatives to advance the discussion on a number of issues of interpretation of the Agreement and the Guidelines related to the development of factual records, and to report back to the Alternate Representatives. The Alternate Representatives took note of the preliminary view of the legal group and agreed that the JPAC Chair could share their report with the members of JPAC working group on Articles 14 and 15. They further agreed to task the Secretariat with analyzing the practical implications of applying the preliminary view to pending and future submissions. The Alternate Representatives further agreed that the language contained in the report reflects the preliminary view of the legal group, that it is therefore not definitive, and despite some consensus, does not yet reflect a Council decision on the matter, as the United States still needs to consult on these issues.

More specifically, with respect to submission SEM-97-006, Canada indicated that it will not be in

a position to make a decision on whether or not to instruct the Secretariat to develop a factual record before December 13 1999, because there is a related pending case before the Federal Court of Appeal for which the appeal period has not yet expired. Canada noted that this pending case is linked to the factual matters of the submission SEM-97-006. The Alternate Representatives therefore agreed to postpone their decision on the matter to their next session. Canada indicated that it will, in the meantime, draft a proposed resolution for consideration by the Alternate Representatives.

Item 7.2 Procedures for the development of factual records

The Parties provided an update on where they are in the development of their position in relation to procedures for the development of factual records. Mexico reiterated its basic support for the concepts contained in Canada's first proposal. Canada indicated that it had recently circulated a revised proposal to the other Parties though it did not expect comments at this meeting. The United States indicated that it is close to completing its internal consultations as there was only one point for which there wasn't yet inter-agency agreement and that a written proposal would be ready shortly for distribution to the other Parties. The Alternate Representatives agreed that there was not a decision taken on the guidance requested by the Secretariat on guideline 15, so action will await until such decision is taken. Mexico reiterated the proposal of having an interpretation of treaties specialized group to deal with the outstanding matters of general application to the development of factual records.

Item 7.3 Assertions of confidentiality

This issue was discussed under item 7.2.

Item 8 Council's response to pending public inquiries

This item was not discussed.

Item 9 1998 Annual Report

This item was not discussed.

Item 11 Other issues

No other issues were discussed under this item.

Item 12 Next sessions of Alternate Representatives

The Alternate Representatives confirmed their attendance to the workshop on Environment and Trade to be held on 13 December 1999 at the CEC Secretariat. The workshop will be followed in the morning of 14 December by an Environment and Trade officials' meeting pursuant to Article 10(6).

Item 13 Meeting with PRTR National Representatives

The Alternate Representatives met with PRTR national representatives to discuss the PRTR project. The meeting first began with presentations by the CEC Secretariat on the PRTR project. Then, the PRTR representatives from Canada, Mexico and the United States presented an overview of their domestic PRTR regimes.

These presentations were followed by a detailed discussion where it was agreed that the PRTR project would be finalized at the next session of Alternate Representatives.

Item 14 Meeting with SMOC Working Group Representatives

The Alternate Representatives met with representatives of the SMOC working group to discuss the SMOC project. It was agreed that further discussion on this project will take place at the next session of Alternate Representatives.

Item 15 Closure of the session

The Chair closed the session.

Notes for Report of the Executive Director Meeting of the Alternate Representatives

November 18, 1999

FOLLOW-UP TO COUNCIL MEETING

• Secretariat prepared a revised draft of the Children's Health and Environment initiative reflecting the discussion of the Alternate Representatives in October. This version takes a broader approach while at the same time recognizing the need to be focussed and concrete. Attached please find this version. Please note that the cost estimates for this broader initiative is \$120,000. The broader approach and process outlined represent a cost increase of \$70,000 over the previous proposal.

PROGRAM

Trade and Environment

- Experts are confirmed for the December Trade and Environment workshop. The Secretariat will distribute a background note prior to meeting.
- Next week meeting of Wildlife trade group in Montreal to consider the Traffic report and next year's activities.
- The Seattle host organization is sponsoring a Trade and Environment Session for the WTO Ministerial. We will be participating in one of the Panel Discussion.

Biodiversity

- Mexico and the US both formally inaugurated their national NABCI committees with events in Monterrey and Virgina, respectively. Canada will follow shortly. Senior level representation and good CEC recognition as a catalyst for this important initiative.
- Government marine officials are currently meeting in La Paz to develop a plan of action for the creating the Marine Protected Area Network.

Pollutants and Health

The Mercury action plan has generated substantial comments. The Secretariat will
circulate the packet of comments to delegations prior to Friday's session. As one of the
probable central announcements of the next Council meeting, the Alt Reps may want
ensure that the mercury action plan provides a strong foundation for advancing SMOC
work.

- GEF has authorized the project proposal the CEC developed with the Pan American World Health Organization and UNEP. Technically known as the PDF Block B grant, it will enable the development of a larger project aimed at eliminating the use of DDT in Mexico and Central America. The CEC will be contributing \$100,000 to this effort. GEF, PAHO and participating organizations will be providing \$690,000. We are expecting that GEF would contribute around \$4.5 million dollars to finance the final project.
- IDRC has informed us of its decision to provide possibly up to \$220,000 in support of the implementation of the DDT action plan in Mexico.
- EPA is contributing something close to \$100,000 to complete the mercury backtrajectory split module to our roughly \$50,000 contribution. STAPALAPCO is contributing around \$38,000 to the development of the North American air management web site.

Law and Policy

- The enforcement working group decided to pilot the development of compliance indicators in the area of hazardous waste and is pursuing two options: the first involves data on US-CAN transboundary shipment of hazardous waste; the second involves US-MEX data on domestic transfer, storage and disposal facilities.
- Trilingual Turtle identification guide for customs inspectors and enforcement officials being prepared in cooperation with Environment Canada for distribution in early 2000.
- Following Cheyenne Wildlife Forensics Seminar, CEC is helping develop a directory
 of forensic labs and services. The meeting succeeded in spinning off another endeavor
 as forensic labs agreed to collaborate to establish a joint DNA database

SEM-ARTICLE 14 AND 15

The status of the twelve submissions currently under review is as follows:

- One Factual Record is being developed. The Secretariat is currently developing a factual record on submission SEM-97-001/BC Aboriginal Fisheries Commission et al. as instructed by the Council.
- Awaiting Direction from Council concerning possible development of a factual record for two submissions. On 19 July 1999 the Secretariat informed the Council that the Secretariat considers that SEM-97-006/The Friends of the Oldman River, warrants developing a factual record. On 29 October 1999 the Secretariat informed the Council that the Secretariat considers that SEM-97-003/Centre Québécois du droit de l'environnement, warrants developing a factual record. Pursuant to Guideline 10.2, on

- 3 December 1999 the Secretariat will place notice in the registry and public file that it has informed the Council that the Secretariat considers that submission 98-003 warrants developing a factual record.
- Reviewing six submissions to determine whether development of a factual record is warranted. The Secretariat is currently reviewing one submission concerning Canada (SEM-98-004/ Sierra Club of British Columbia, et al.) and five concerning Mexico (SEM-97-002/Comité Pro Limpieza del Río Magdalena, SEM-97-007/Instituto de Derecho Ambiental, SEM-98-007/Environmental Health Coalition, et al., SEM-98-006/Grupo Ecológico Manglar A.C., and SEM-98-005/Academia Sonorense de Derecho Humanos) in light of the response to determine whether development of a factual record is warranted.
- Awaiting Party's Response for one submission. The United States response concerning SEM-98-003/Department of the Planet Earth et al, is due in November 1999.
- Reviewing two submissions under Article 14(1). On 18 October 1999 Methanex
 Corporation filed a submission (SEM-99-001) concerning the United States which is
 now being reviewed by the Secretariat to determine whether it meets the criteria of
 Article 14(1). On 15 October 1999 the submitters for SEM-98-001/Instituto de
 Derecho Ambiental filed a revised submission which is being reviewed by the
 Secretariat to determine whether it meets the criteria of Article 14(1).

The attached chart provides a status update on each submission.

NAFEC

- 29 grants were made in 1999 bring the total to 127 (since inception).
- Happy to report much closer synergy between grants and CEC projects as requested by the Parties. For example, in the area of shade coffee, we were able to wed our policy work in the area of biophysical criteria and market study with on the ground shade coffee producers and retailers. (Attached are the recent Globe and Mail and Gazette articles.)

COMMUNICATIONS

• Annual Report is being distributed today. We are looking for Council's final approval by 30 November 1999.

ADMINISTRATION AND FINANCE

Erica Phipps, program manager for the PRTR program has joined the CEC staff. Jack

Person, financial comptroller has left the CEC. We are reviewing candidates with a goal of having someone in place in January.

• The third quarterly Financial Report has been sent to you earlier this week. All Parties have completed their 1999 commitments of US \$3,000,000 each. Funds on hand are US \$2,700,000, which is sufficient for three months of activities.
