SESSION 00-08 OF ALTERNATE REPRESENTATIVES

SUMMARY RECORD

The Council, represented by its Alternate Representatives, met on 13 and 14 October 2000 at the Instituto Mexicano de la Cultura in Washington, D.C. Mr. José Luis Samaniego (Mexico) chaired the meeting. Ms. Norine Smith and Mr. William Nitze represented Canada and United States respectively. Ms. Liette Vasseur represented JPAC and Ms. Janine Ferretti, Executive Director, represented the Secretariat. Mr. Cristóbal Vignal, Council Secretary, acted as Secretary of the session. Other officials of the Parties and the Secretariat were also in attendance (Annex A).

Item 1 Adoption of the agenda

The Alternate Representatives adopted the agenda based on the provisional agenda. The agenda as approved can be found in Annex B.

Item 2 Report of the Executive Director

The Executive Director reported that a copy of a letter from the International Institute for Sustainable Development (IISD) dated 5 September 2000 requesting Council to consider its petition of 25 August 2000 to the Arbitral Tribunal for Amicus Curae Friend of the Court Status in the Methanex Corporation and United States of America case under Chapter 11 of NAFTAhas been forwarded to the Parties. Copy of a letter dated 3 October 2000 from The Friends of the Oldman River informing of the Supreme Court of Canada's denied leave to appeal related to the matter referred in Submission SEM-97-006 was also forwarded to the Parties. The Executive Director updated the Alternate Representatives on collaborative efforts with UNEP in various areas.

Item 3 Report by the JPAC Representative

The JPAC representative expressed JPAC's hope that the referral memorandum pursuant to paragraph 5(b) of Council Resolution 00-09 be received by JPAC in time for JPAC to discuss it during its session being held in parallel. The Parties instructed the representatives of the ad hoc group working on this issue to proceed immediately with the finalization of the referral memorandum.

Item 4 Approval of summary records

The Alternate Representatives approved the summary record of sessions 00-07 of Alternate Representatives with the changes proposed by Canada.

Item 5 Sound Management of Chemicals

The Secretariat updated the Parties on the current status of the SMOC initiative. A representative of the SMOC working group updated the Parties on the views of this group relating to issues raised in a memorandum dated 1 June 2000.

The Alternate Representatives discussed these issues and tasked the GSC with preparation of a response.

Item 6 Proposed 2001-2003 Program-Plan

The Alternate Representatives exchanged views and provided guidance to the Secretariat on the proposed 2001–2003 Program Plan. Decisions related to the Program Plan are reported in a separate document. Special note was made of the successful first North American Symposium on understanding the linkages between Trade and Environment and Council expressed its commitment to hold a second meeting in the future so as to maintain the momentum of this initiative.

Item 7 Articles 14 and 15 of NAAEC: Referral memorandum to JPAC pursuant to paragraph 5(b) of Council Resolution 00-09

The Alternate Representatives approved the final English version of the draft referral memorandum to JPAC pursuant to paragraph 5(b) of Council Resolution 00-09 and agreed that it be presented to JPAC during its joint meeting scheduled the next day.

Item 8 Joint meeting with JPAC

Prior to the opening of the day's session on 14 October, a breakfast meeting was held with members of the JPAC. The Alternate Representatives presented JPAC with the referral memorandum pursuant to paragraph 5(b) of Council Resolution 00-09, copy of which is attached as Annex C.

JPAC updated the Parties on the discussions regarding the public review process for Articles 14 and 15 and the Lessons Learned work. The Alternate Representatives outlined various issues relating to the proposed NACEC Program Plan and Budget for 2001-2003. JPAC and the Alternate Representatives also took this opportunity to exchange views on matters related to NAFTA Chapter 11 and 10(6) of the NAAEC.

Item 9 Use of Outstanding Balance from Financial Year 1998

This item was not discussed.

Item 11 Other issues

No other issues were discussed.

Item 12 Next sessions of Alternate Representatives

In relation to Council Resolution 00-09 of the Commission for Environmental Cooperation (CEC), we would like to take this opportunity to thank you for the interest that the Joint Public Advisory Committee (JPAC), and you personally, have shown toward the process established by Articles 14 and 15 of the North American Agreement on Environmental Cooperation (NAAEC). As you are aware, the Parties, in accordance with the authority conferred by Articles 10 and 20 of the NAAEC, have held several meetings at which they exchanged views in an effort to improve the application of that process.

In accordance with paragraph 5(b) of Council Resolution 00-09 of the CEC "Matters Related to Articles 14 and 15 of the North American Agreement on Environmental Cooperation", approved at the VIIth Regular Session of the Council on 13 June 2000 in Dallas, Texas, and in order to guide the JPAC in reviewing the public history of submissions made under Articles 14 and 15 of the NAAEC, including all actions taken to implement those articles, the Council requests that the JPAC conduct a review in consultation with each Party, the submitter and the Secretariat, of each submission for which the submission process has been completed.

This review should identify lessons learned related to the following issues:

- Sufficiency of information to allow the Secretariat to review a submission under Article 14(1)(c).
- Processes followed by the Secretariat in gathering information for the preparation of a factual record.
- Timing of the public release of non–confidential information.
- Designation of confidential or proprietary information in connection with the Articles 14-15 process.

As Council noted in its resolution, public participation in this review is important and we are
encouraged by the public involvement to date. We look forward to seeing such involvement
continue.
