SESSION 98-03 OF THE COUNCIL 26 May 1998

SUMMARY RECORD

The Council, represented by the Alternate Representatives, met via conference call on 26 May 1998. Mr. José Luis Samaniego (Mexico) chaired the meeting and Messrs. Avrim Lazar and William Nitze represented Canada and the United States, respectively. Ms. Janine Ferretti, Interim Executive Director of the CEC and Mr. Marc Paquin, Council Secretary participated on behalf of the Secretariat. Ms. Lorraine Brooks attended as observer on behalf of the Chair of the JPAC. Other government officials were also in attendance.

Item 1 Opening of the session and adoption of the agenda

The Chair opened the session and the agenda for the session was adopted based on the provisional agenda with the following change: Item 7 was moved up after Item 1. In-depth discussion on item 6 was deferred to the next session to allow more time for the Parties to review the revised version of the Proposed Annual Program and Budget 1998.

Item 2 Strategic Planning Process

The Alternate Representatives agreed to hold the brain storming session of the strategic planning process on 8 June 1998 at the Far Hills Inn in Val-Morin. It was further agreed that a trinational conference call will take place in the morning of 18 June 1998 and that the executive drafting committee will meet in Mérida on 23 June 1998. The process will also involve bilateral conference calls.

The Alternate Representatives also agreed to hold an informal meeting in the evening of 7 June 1998 at the Far Hills Inn.

Item 3 Approval of summary records (97-10, 98-01, 98-02)

It was agreed that Mexico will circulate proposed language for Item 2 of the summary record of session 97-10, that relates to the three main decisions the Secretariat make with regard to Article 14 submissions. The summary record for session 98-01 was approved by the Alternate Representatives. With regard to the summary record for session 98-02, Mexico would like the Secretariat to reflect with additional details the decisions taken at the session. In order to assist the Secretariat in doing so, Mexico will share its notes from the meeting with the Secretariat.

Item 4 Statement by the Chair of JPAC

The Chair of JPAC was represented by Ms. Lorraine Brooks as observer who did not make any statement.

Item 5 Report by the Interim Executive Director

The Interim Executive Director briefly updated the Council on Secretariat activities.

Item 6 Approval of the Annual Program and Budget 1998

The Alternate Representatives agreed to provide the Secretariat with their comments on the Annual Program and Budget 1998 (April 1998 version) by 29 May 1998.

Item 7 1998 regular session of the Council

The Alternate Representatives approved the provisional program, annotated agenda and program of activities opened to all registered participants at the regular session of the Council with minor changes which will be reflected by the Secretariat in the next version of these documents.

Mexico indicated that the Governor of the State of Yucatan will be present at the public opening of the session to welcome the Council and the participants and conduct the opening of the session.

The Alternate Representatives requested that an executive summary of the State of the Environment (SOE) report be prepared in view of the regular session of the Council. The Secretariat will distribute by 1 June 1998 the SOE executive summary as well as the summary of the Phase II of the Emissions Trading Project.

Mexico will provide shortly a background paper on item 12.2 of the regular session of the Council, relating to the CEC's administrative procedures.

The Alternate representatives agreed to send out the program of activities for the registered participants and that the first hour of the Council session on Thursday, 25 June will be held before public.

Item 8 Report of the Review Committee under Article 10(1)(b)

The Alternate Representatives instructed the Secretariat to draft, for their signature, a letter to the Review Committee enjoining it to forward as soon as possible an advance copy of the original version (English) of its report to the Council to facilitate the preparation of the Parties for the brainstorming session on the CEC's three year strategic plan and the regular session of the Council, with the understanding that translation of the report should be undertaken with celerity.

Item 9 Article 14 submissions

Further to the Secretariat's release of a document entitled "Recommendation of the Secretariat to the Council for the development of a factual record in accordance with Articles 14 and 15 of the NAAEC", the Alternate Representatives instructed the Secretariat to amend said document to delete any reference to the word "recommendation" and to use the language of Article 15 of the agreement, send the amended version to the Parties and the submitters and modify the registry and public file accordingly. It was further agreed that the Parties will endeavor to select, in the course of the review of the Article 14 guidelines, a suitable noun to identify the document

prepared by the Secretariat under Article 15(1) and to replace the word "recommendation" used thus far.

Canada indicated it would like to have a discussion on the BC Hydro submission before the regular session of the Council and wished it could be discussed at the next Alternate Representatives session. Canada further indicated that it hoped to be able to provide information on its position with respect to the Council decision on the BC Hyro submission to the other parties next week.

Item 10 Other business

Under this item it was proposed by the Secretariat, for consideration by the Parties, that 1996 excess funds be directed to an "Emergency Relief Fund" to help Mexico cope with the very important forest fires currently active in Mexico. Mexico and the US agreed in principle. Mexico indicated that it will propose language to address that matter appropriately. Canada indicated that its normal practice is to apply any surplus funds against its next year's contribution as provided for in the financial rules but agreed to give consideration to the proposal.

Under this item, Mexico indicated that it is in the process of finalizing the appointment of its national advisory committee as provided for by Article 17 of the NAAEC. Mexico further indicated that it was awaiting said appointments before selecting the recipients of financial assistance for the regular session of the Council.
