#### SE Coordinators' Webinar

The next SE Coordinator Webinar will be **July 22, 2008 from 2:00 – 3:30 EDT**. This Webinar will review results from the SE Coordinators' survey, provide a tutorial for joining *STD Prevention Online*, and feature the Implementation and Monitoring Group's (IMG) new 2009 Guidance for Evidence-based Action Planning (EBAP). To prepare for the webinar, please see the attached revised EBAP guidance which includes the following changes: (1) adding an objective to the EBAP framework; (2) recommendations for the minimum number and type of EBAPs your program may want to highlight; and (3) new examples of EBAPs. #### **Public Health Program Support Courses**

The Division of STD Prevention, Program and Training Branch (PTB) has created an updated course schedule for 2008. Upcoming courses include Introduction to STD Intervention (ISTDI), Advanced STD Intervention (ASTDI), STD Intervention for Supervisors (STDIS), and Principles of STD Supervision. PTB continuously solicits programs interested in sponsoring these courses. Please note that Host Programs are encouraged to register appropriate staff members for the courses. To ensure the best learning environment, no more than 50% of the participants can be from the host area. Any slots that are still available four weeks prior to the training are made available to the host program. # HIV/STD Partner Services (PS) Recommendations & PS Implementation Alternatives Learning Tour

Delivery of PS for HIV has often differed from delivery of PS for other STDs. These differences have led to confusion among public health professionals, fragmented services for clients, and concerns about this important prevention strategy among members of communities affected by both STDs and HIV. CDC has developed a single, integrated set of recommendations for both HIV and STD programs. The revised recommendations are based on extensive review of the literature, program experience, and stakeholder input. The integrated guidelines use common strategic logic for PS, but recommend different approaches for the various infections. Although the revised recommendations provide a single, unified set of recommendations to serve as the basis for HIV and STD PS programs, developing them is only one part of the process. To ensure that the recommendations are appropriately implemented when the recommendations are published later this year, a cross-divisional implementation team is meeting to develop plans for communications, training, technical assistance, and capacity building to support these recommendations.

David S. Novak, the Syphilis Elimination Program Coordinator is a member of the implementation team conducting a series of sites visits designed to learn more about health department collaborations with community-based organizations (CBOs) to provide Partner Services. The workgroup will visit four sites this summer: Massachusetts, Houston, Chicago, and Los Angeles. The goal is to provide technical assistance information to other health departments which may want to include CBOs in their plans for providing PS.
