### EXECUTIVE OFFICE-AGRICULTURAL QUARANTINE LIST OF ZOOSANITARY REQUIREMENTS

Country of Origin: United States of America

Tariff Section-Zoosanitary:

05.05C Skins (fresh, salted, dried and whitewashed) and other parts of the bird, with its feathers or down, feathers or parts of feathers (including cut out feathers) and down, crude or cleaned only, disinfected or prepared for its conservation: Dust and feathers' waste or parts of feathers: coming from runner birds (ostrich, emu and nandu)

The good or goods should be accompanied by a Phytosanitary Certificate, given by a Veterinary Doctor, Officer in the Animal Health Services of the country of export, and authenticated by the Panamanian Consul in the same country, in which it is certified that the following requirements will be followed:

That:

1. the goods come from healthy animals, raised in the United States of America;
2. the installations, where the animals come from, were free of the following diseases, during the year previous to the date of shipment

Salmonella (*S. enteritidis*, and *S. typhimurium*)

Avian tuberculosis

Avian Pox

3. the slaughterhouse where the animals were processed, from which the good comes from, is officially authorized for the exportation of skins by the export country and approved by the Ministry of Agricultural Development, considering international laws:
4. have the official certificate of the corresponding authority of the country of export as suitable for human consumption or use;
5. have been packed in special waterproof and sealed boxes or containers showing in a clear way the identification of the establishment where they were produced, the authorization number given by the Ministry of Agriculture in the country of export, also the lot number and the elaboration date and that the goods were properly packed for its transportation in normal containers or means, isothermic or the refrigerator type which guarantees the conservation temperature, refrigeration or freezing, according to each case. These containers and thermo refrigerated means were previously washed and disinfected, using products approved by the origin country. The containers and the thermo refrigerated means were sealed accordingly, so that these seals will only

be removed by the corresponding sanitary authorities, in the country of transit or country of destination, or otherwise have been packed in plastic bags, authorized for human consumption, showing the identification of the establishment where the goods were processed the authorization number of same, given by the Ministry of Agriculture in the country of exportation, also the lot number and the elaboration date, when they were packed in the special boxes or sealed waterproof containers;

6. the vehicles and containers were washed and disinfected previous to the shipment of the goods or goods, using products authorized by the country of exportation. Containers have been stamped or sealed so that only the respective sanitary authorities can remove these seals at the country in transit or at the country of destination.

#### Additional requirements

1. In those cases in which the authorities of the Ministry of Agricultural Development (Animal Health), considers necessary, samples of the goods in each container should be taken for the respective analysis of the "organoleptica" (taste and smell?) characteristics, to determine additives, toxic residues and for the sanitary bacteriological analysis.
