

AUTHENTICATION OF HEALTH CERTIFICATES FOR PET
DOGS AND CATS:

For those who are planning to work and reside in Saudi Arabia and wish to take their pet dogs or cats with them, the following procedures should be followed:

I. The Veterinary Health Certificate (or International Health Certificate-
APHIS FORM 7001):

- a) Must indicate that the pet was examined and has been vaccinated against all possible diseases, and that it is in good condition.
- b) Must be authenticated (endorsed) by the Department of Agriculture in applicant's county or State with official Stamp and Seal.
- c) Must be authenticated by the State Department Authentication Division:

- d) Must be certified by the Consular Section of the Royal Embassy of Saudi Arabia.

FEE: Approximately \$8.50 Per set of documents, apyable to the Embassy
Of Saudi Arabia. Company checks and money orders only.

- II Must include a dated letter from the veterinary private practitioner addressed to the Director of Custom, Saudi Arabia. (Form on next page may be used.) It must identify the animal(s); the veterinarian; the State; and the owner's name. It must state that the rabies vaccine was produced in the United States for national distribution and manufactured in establishments that conduct tests for safety and potency in the manner acceptable to the United States Department of Agriculture. This letter must also be endorsed by the Department of Agriculture in applicant's county or State with official Stamp and Seal.

- III. Must include the rabies certification that has been authenticated (endorsed) by the Department of Agriculture representative in that State with official Stamp and Seal.
