#### TRCs Are Being Traded and Used Today

- ~ 10.5 Million MWh TRCs were contracted in the US in 2003
- Retail sales in Green Markets:
  - twelve-fold increase last year
  - 1.8 Million MWh Green-e certified TRCs in 2003



# History of TRCs in US

- 2000
  - Bonneville Environmental Foundation forms 'Green Tag Program'
  - 'Green Tickets' sold in CA by APX
  - EPA first large commercial purchaser of TRCs
- 2001
  - TX begins RPS program using TRCs (ERCOT tracking Program --Mandatory market)
  - CRS issues White Paper on TRCs best practices

### History of TRCs in US (cont.)

- 2002
  - NEPOOL/GIS formed (issues & tracks TRCs Mandatory market)
  - Green-e certifies first TRC Enduse Products (voluntary market):
    - 7 companies with certified products
    - 150,000 MWhs of Green-e certified TRCs sold
    - 45% sold to residential customers



# History of TRCs in US (cont.)

- 2003
  - 18 companies with certified products
  - 1.8 million MWh of Green-e certified TRCs sold
  - 95% sold to non-residential customers
  - 84 large Companies purchasing significant quantities of TRCs

### **TRC Price Ranges**

- Mandatory (compliance) Markets
  - \$48/MWh CT
  - \$40/MWh MA
  - \$14/MWh TX
  - \$4.50 to \$6.50/MWh in PJM



# Why the Price Disparity?

- Geography of low-cost renewables
- Supply/demand
- Volume of purchase
- Voluntary vs. compliance markets
- Regulatory (e.g. penalties for noncompliance with RPS)
- Type & vintage of renewables
- Solar set-aside in RPS





#### Buzzworthy: Consumer Product Labeling

 In 2004 Green-e launched the Product Labeling Initiative.



- Many vendors are using the "Made With Renewable Energy" Green-e logo.
- Many more consumer products (Odwalla juice, Silk Soy Milk, Fat Tire beer, etc.) contain info on packing encouraging customers to buy RECs

# **Buzzworthy: POP Tags**

- "Mini-tags" or "Point of Purchase (POP) Tags" -- Small quantities of RE attributes sold at point-ofpurchase to offset the consumer's energy use and/or emissions from a particular activity.
- Green Mountain and BEF have sold 100 kWh blocks of wind RECs at ski resorts so customers can offset their ski lifts energy use.
- Potential uses: offsetting emissions from airline travel, grocery store purchases, rental car usage, etc.





#### Buzzworthy: Emissions Values of RECs

- Will RE be assigned CO2 value in future Cap & Trade schemes?
- You could contribute to lowering GHG levels for your City, County, or State – are you ready?



### **Barriers & Challenges**

- Need accurate and verifiable generation
  data
- Need a credible mechanism for issuing certificates
- Need a method for tracking certificate
  ownership
- Need to know what certificate represents
- Need to protect against double counting




# **Tracking Systems**

- Verify Type of Generator
  - Generator registration/verification
- Issue TRCs to Generators
- How many TRCs were purchased?
  - Verify property rights and amount in specific accounts
  - Verify types of TRCs in accounts
- Was there any double counting?
  - Good within tracking system boundaries



#### TRC Tracking in North American



- An equivalent of a financial banking system is needed for TRC issuing & tracking.
  State, provincial, regional or national TRC "issuing bodies" need common practices for handling accounts, transferring assets.
- A North American Association of Issuing Bodies (NAAIB) is being considered to ensure compatibility among systems and provide credibility to the emerging TRC market

#### Types of RE Programs/Policies Tracking Systems can Support

- Renewable Portfolio
  Standards (RPS)
- Green Pricing Programs (G-P)
- Public Benefit Funds (PBF)
- State Production Tax Credits (PTC)



#### Types of RE Programs/Policies Tracking Systems can Support (cont.)

- Information Disclosure Labels
- Integrated Resource Planning (IRP)
- Green Marketing: Certification/verification
- GHG Trading Programs: Issuing CO2 allowances to RE



#### North American Association of Issuing Bodies (NAAIB)

- Protects against double counting in North America
- Facilitates Imports/Exports among the member tracking systems
- Provides structure for new tracking systems





- Facilitates national and international markets for TRCs and Carbon Offsets
- Provides credibility for TRCs
- Supports RE financing options



#### **Certification/Registration**

- Product Certification:
  - TRC Standards & Definitions
  - Labeling & Information
    Disclosure
- Registration or Facility Certification
  - Is Generating Facility that produced the TRCs what it says it is?
  - Usually Certify and Verify



#### Verification

#### Product Verification:

- Compliance Review
  - What TRC Claims are being made?
  - Are they legal & easily understood?
  - Was the consumer properly informed?
- Separate Audit:
  - How many TRCs were sold compared to what was purchased?
  - Were the types of TRCs purchased consistent with the claims made to customers?
