



HPTF Directive – June 2001

(abridged)

- to promote an exchange of information on environmental health issues between health professionals and organizations;
- to inform the Commission and its Boards concerning the credibility and adequacy of environmental health training and education being provided to health professionals;
- to inform the Commission and its Boards of developments in professional practice and public health policy; and
- to advise the Commission about emergent clinical and public health issues in the area of transboundary health.

Results



DIDACTIC

- 3 studies:
 cholesterol, FP
 topics, screening
- none altered physician performance

- INTERACTIVE & MIXED
 - 6 studies interactive,
 (4 pos. effect on physician perf.)
 - 7 mixed (5 pos., on PP; 2/3 on HCO)

Results

- SINGLE
 - 7 interventions
 - 2-6 hrs in length
 - 2 had positive effects on PP

- MULTIPLE
 - 10 interventions in total
 - 8 used two sessions; 2 used multiple
 - 7 produced change in PP; 3/4 effected change in HCO

Table 1: The CH²OPD² mnemonic for taking an environmental exposure history

Code	Category	Question
С	Community	Do you live near a hazardous waste site or any industrial facilities that give off chemical odours?
Н	Home	Is your home more than 40 years old? Have you done renovations? Do you use pesticides in your home or on your garden or pets?
Н	Hobbies	Do you work with stained glass or oil-based paints or varnishes?
О	Occupation	Describe your workplace air quality and what you do
Р	Personal habits	Do you or family members smoke? What sort of personal care products do you use?
D	Diet	What is your source of drinking water? How often do you eat tuna or sportfish?
D	Drugs	Besides what I have prescribed, are you taking any over-the-counter or home remedies?
