

IMPORT HEALTH REQUIREMENTS OF THE BAHAMAS FOR GOATS EXPORTED FROM THE UNITED STATES

The goats must be accompanied by a U.S. Origin Health Certificate issued by a veterinarian authorized by the U.S. Department of Agriculture and endorsed by a Veterinary Services (VS) veterinarian. The certificate must carry the names and addresses of the consignor and consignee and complete identification of the animals. In addition, the certificate must include the following certification statements and the results of the indicated testing:

CERTIFICATION STATEMENTS

1. The goats were inspected by me on date _____, which is within 30 days prior to the date of export, and were found healthy and free of evidence of any communicable disease, including ectoparasite infestation, and to my knowledge the goats have not been exposed to any infectious disease of goats within the last 60 days.
2. The goats were isolated from the rest of the herd (s) of origin and from animals of other species for at least 30 days immediately prior to the date of export.
3. The herd (s) of origin is (are) clinically free of brucellosis (*B. melitensis*), caprine arthritis and encephalitis (CAE), Johne's disease, leptospirosis, listeriosis, and Maedi-Visna (ovine progressive pneumonia, OPP), and tuberculosis.
4. The animals for export have been enrolled in the Scrapie Flock Certification Program after meeting the requirements of the first program inspection. The flock/herd has not, during the 5 years prior to export, been designated a scrapie-infected or scrapie-source flock/herd and is not currently designated a scrapie-exposed flock/herd. The animals for export showed no clinical signs of scrapie on the date of inspection.
5. The goats were treated for ectoparasites on date _____, which is within 30 days prior to the date of export, with (state active ingredient) _____.
6. The goats were treated for internal parasites on date _____, which is within 7 days prior to the date of export, with _____, (a) product(s) which provide(s) broad-spectrum coverage against cestodes, nematodes, and trematodes.

TEST REQUIREMENTS

Within 30 days of export, the goats must be tested in a USDA approved laboratory or laboratories as indicated below and found negative:

1. Tuberculosis: Intradermal caudal fold test using bovine PPD tuberculin.
2. Brucellosis: Serum agglutination test (e.g., Card test) at a VS-certified laboratory or *B. abortus* complement fixation test (cold) at a 1:10 dilution.
3. Leptospirosis: Microagglutination test at a 1:100 dilution for serovars *canicola*, *grippotyphosa*, *icterohaemorrhagiae*, and *pomona*.
4. Caprine arthritis/encephalitis (CAE): Agar – gel immunodiffusion test.

EMBARKATION CERTIFICATION

At the port of embarkation, a VS port veterinarian must attach to the U.S Origin Health Certificate a completed VS Form 17-37, Certificate of Inspection of Export Animals, showing:

1. The name and address of the consignor.
2. The name and address of the consignee.
3. The number and species of animals to be shipped.
4. A statement that the animals have been given a careful veterinary inspection at the port of embarkation and found free of evidence of communicable disease and exposure thereto within 24 hours of exportation.

OTHER INFORMATION

1. The goats must be accompanied by a medical history of the herd(s) of origin which should be documented by the veterinarian(s) servicing the herd(s) and contain information such as the herd health maintenance regimen, as well as stating any herd health problems.
2. None of the goats may be older than 3 years.
3. The Veterinary Division of the Department of Agriculture of the Bahamas must be notified of the shipment at least 7 days prior to the scheduled date of arrival.
4. Incomplete documentation or the finding of communicable disease or ectoparasites among the animals at the port of entry may result in them being refused admission.
5. Any outbreak of foot-and-mouth disease, rinderpest, or other exotic disease of ruminants in the U.S. will immediately nullify the import permit.

6. Copy of the health certification documents, laboratory reports and permit should be left with the Customs Officer on arrival.
