Cov ntawv kws koj xaa tuaj rua peb yuav tsum qha: (1) cov nyaj tau txais npaum le caag, (2) lub npe ntawm tug tuabneeg twg kws tau txais, (3) nub twg tau txais cov nyaj kws khwv tau lug, hab (4) cov nyaj kws khwv tau lug ntawd tau txais pis tsawg zag lawm.

Yog yuav qha txug has tas koj tsev tuabneeg khwv nyaj tau npaum le caag hli taag lug nuav, luam hab xaa rua peb lawv le nraag qaab nuav:

- **Tau txais nyaj / tug nqe zug / cov nyaj hli lug ntawm txuj num:** Dlaim tws sau them nyaj kws nyav txais taag lug nuav qha txug has tas laav nyaj pis tsawg zag; Lub naab ntawv kws nyav txais taag lug nuav qha tau has txais nyaj pis tsawg zag; Dlaim ntawv kws tug tswv num qha tseeb has tas tug nqe zug taag nrho yog pis tsawg hab koj tau txais pis tsawg zag; Ntaub ntawv ua laag ua luam los sis ua laj ua teb, xws le ntawv cais ua tsheej pawg los sis phoo ntawv se.
- **Nyaj ua tsi taug dlejnum / nyaj laug / nyaj su dlejnum:** Dlaim ntawv sau txug nyaj ua tsi taug dlejnum su dlejnum, has txug tau txais le caag; ntawv ceeb toom txug tau txais nyaj laug.
