CPO REPORT FOR 23 AUGUST 2002

As you know, Richard Carmona received Senate confirmation and became our Surgeon General on 23 July 2002. This afternoon, Friday 23 August, there will be an all hands videoconference to welcome, introduce, and hear from VADM Carmona. The Conference will be held at 3 PM in the FDA studio located at 16071 Industrial Drive, Gaithersburg, MD. All CPO's are expected to attend.

IHS has been field-testing a new field utility uniform similar to the DoD khaki colored BDU. If approved, this work uniform will be used during deployments and as directed by the uniform authority.

Medical Reserve Corps (MRC) is not to be confused with the PHS uniformed Ready Reserve. MRC is to be an all-civilian corps of private citizen medical volunteers to serve during disaster and emergency situations. They will be non-federal, are non-deployable, and will serve at the local/community level.

The Agency Recommendation (6th Precept) remains a hot issue! IHS loathes it, but seven other agencies are reluctant to let it go. Looks like it is no longer on hold and will be continued at least through this next promotion cycle.

The Office of the Surgeon General wants us more involved with DoD counterparts and our professional associations. In light of events since 9-11, we need to be represented and a big part of initiatives such as plans for disaster management and preparedness. All discipline liaisons have been briefed and kept abreast of information as it unfolds.

For the past several months, CPO's have been expected to provide a bi-weekly report to the OSG. This Environmental Scan, as it is called, keeps the OSG informed of issues important to the various categories, and the Surgeon General in turn uses this information to keep the Secretary informed. I urge you all to let me know of information and issues that would be of interest to the OSG and to the Secretary. The outline calls for an internal review (things going on in the Therapist Category), external review (Category and discipline-specific issues going on in our professional associations, DoD, VA, etc.), and any legislation that impacts our respective disciplines. Please send any tidbits. The next report is due August 27th. Discipline Liaisons have been very responsive and helpful, and Therapist scans are informative.

The call has gone out to all agencies requesting nominations for new Chief Therapist Officer. This time agencies have been more supportive of the position and responsive to the call, so I anticipate a selection board to be convened in September with a new CPO on board by 1 October. I have to confess that I am not anxious to relinquish this appointment, as it has been the capstone and highlight of my long career in public service, 17 years of which has been as a PHS officer. I am very thankful I was given this opportunity to represent all therapists of the United States Public Health Service, and my only regret is that we have been unable to tie up so many loose ends. Unfinished business of import that I hope to see come to fruition includes:

• The Healthy Lifestyle Initiative and establishing a permanent fulltime fully funded billet for a Commissioned Corps Healthy Lifestyle Coordinator;

- Overcoming the host vs. no-host barrier to establishing MOU's and placing our officers in VA and DoD positions;
- Working with the other categories to develop a process by which new disciplines can be approved for commissioning, and adding respiratory therapists to the Therapist Category;
- Accomplishing 100% Therapist Category enrollment in CCRF, and through a user friendlier edition of our Therapist Category Handbook enlighten others to the critical role we as therapists can play in a post disaster deployment.

As far as accomplishments, I would ask you all to look at the Category and see what we as a team have accomplished this past four plus years. The most important accomplishment to me is that we as individual disciplines have come together as a cohesive team, and have learned to appreciate and respect unique contributions each of us can make to our comprehensive team and to our mission. Now that we have come together, I challenge you to forge on in the spirit of camaraderie and cohesion as the movers and shakers you have become. Among the many things you have accomplished during my time as your CPO include:

- Appointed a Category Historian to compile a comprehensive category history with updates including pictorial history to be archived in the office of the PHS Historian.
- Accepted the Surgeon General's challenge to embrace, research, develop, and coordinate a Healthy Lifestyle program for the Commissioned Corps.
- Successfully lobbied for a two year Healthy Lifestyle Coordinator detail to the Office of the Surgeon General.
- Initiated contact with the VA, networked and negotiated to establish an MOU for PHS therapist officers, and made preliminary inroads for all PHS officers once the host vs. no-host barrier is surpassed.
- Initiated contact with the DoD Exceptional Family Member Program, networked and successfully negotiated positions for PHS therapists once the host vs no-host barrier is surpassed.
- Made significant inroads with the Army, successfully negotiating seats for two PHS
 therapists in the eighteen month US Army/Baylor Postprofessional Doctoral Fellowship
 in Orthopedic and Manual Physical Therapy, and opening the door for a PHS student in
 the sports medicine fellowship at West Point.
- Worked hard to effect change on such major issues as promotion precepts, appointment standards, recruitment and retention, standardized billets, commissioning new disciplines, fitness standards, readiness and disaster preparedness, "new corps" initiative, centralized command and control, and so on.
- Established a Category Web Page.
- Established teleconferencing hubs to enhance greater TPAC attendance and participation. Our Category, by the way has the distinction for greatest participation by percentage.
- Illustrated the impact and value added of a COA Category Day, which has since become a standard and an expectation for all Categories at our annual conference.
- Established Discipline Liaisons to assist and advise the CPO and the TPAC on discipline specific matters. They also represent the PHS Therapist Category, networking and meeting with their DoD and VA counterparts as part of a quad service team.
- Established an active mentoring program whereby officers new to the Corps may communicate regularly with an assigned senior officer on anything of concern to the new officer including career development.
- Developed Category T-shirts, evidence of identity, cohesion, and team building.
- Developed an evolving, working tool, "Handbook to the Therapist Category, Contributions and Capabilities During Disaster Response."
- Developed a model recruitment program.

- Developed and implemented two new awards: Junior Officer of the Year and Clinician of the Year.
- Developed a task force to research, propose, and implement a formal Therapist Category procedure to recognize and honor our retirees.

Thank you all for your dedication and the vital support you have given to this Category, the United States Public Health Service, and to me.
