#### II. REVIEW AND ADOPTION OF AGENDA:

The agenda was reviewed and adopted as written, following motion by CDR Balash and 2<sup>nd</sup> by CDR Pane. Voice vote per roll call was obtained.

#### III. REVIEW AND ADOPTION OF PREVIOUS TPAC MINUTES:

Meeting minutes of Aug 22, 2004 meeting had been provided via e-mails to all TPAC members and were approved via e-mail by all members. Minutes were posted to TPAC Web site on Oct. 15, 2004.

#### IV. OLD BUSINESS

#### Action Items

a. TPAC Web Page: CAPT (sel) Siegel reported that she and CDR Payne had a conference call with committee chairs on Tuesday and now are moving forward. Committee chairs are meeting with their subcommittees to establish the committee profile and the content to be posted on the web page. Administration Committee chair, CDR Shapiro is meeting with her subcommittees like Finance, providing information about Henry Jackson Fund and COA Task force efforts, LCDR Newman the chair of Information Management Committee is working on field rep roster with CDR Figueroa and category history with CDR Whitehurst-Lief. For Strategic Growth working with LCDR Melanson, will add vacancies on the web page at bimonthly intervals. LCDR Magel is providing information regarding long-term training and LT Maxfield is developing schools contact list. The Readiness Committee chair CDR Drinkard is also getting information from both the OFRD and Healthy lifestyles subcommittees to be posted on the web site. Professional Development information is already well represented. All in all she feels that she and CDR Payne have adequate information to move forward with the new design for the TPAC web page.

CDR Gaustad congratulated CAPT(s) Siegel and CDR Payne on their efforts.

b. Career Pathways: CDR Manrique reported that the Task Force met in October and Plan to do so again in November, working to delineate various pathways. She is looking for information from various liaisons to bring agency specific pathways for therapists working in those areas. Other services were also contacted and surprisingly their information is also relatively vague. However, this allows this task force to develop and present to TPAC strong recommendations for the career pathways for therapists working in both clinical and non clinical billets taking into consideration both the promotion precepts and the benchmarks. CDR Gaustad stated how important it is for us to move forward as one of the findings from the Lewin group report was also the lack of established career pathways for the PHS officers. CDR Manrique offered an open invitation to the category to provide her or any task force members with information that might be relevant from their OPDIV.

#### COA 2005 Task Force

CDR Shapiro reported that the task Force has met twice and she has attended the national category day planners meetings also. The agenda is virtually complete and we are waiting on confirmation of speakers. She informed that the date for proposal submission has been extended to Oct. 29, 2004 and requests that potential speakers please utilize the COA website to submit the proposals ASAP. She will be very happy assist in the process people encounter any difficulties. LCDR West is working on the vendor and exhibitor registration for our category. CDR Drinkard is working with LCDR McMillan on the healthy lifestyles booth, which this year will be in the exhibits hall. Dietician category will also be joining in for the same.

Regarding category day evening, CDR Shapiro requested the category members to please submit the survey that was sent out on the joint venture with the HSO category. CDR Gaustad encouraged everyone to join in as it would be not only highly enjoyable but also good opportunity for networking. He further requested that there be some sessions available on professional development topics like COERS and CV writing taking in consideration the benchmarks. He strongly encouraged junior officers to attend the COA conference in Philadelphia.

Deployment Notifications: CDR Gaustad first congratulated the category on the 68+% deployment readiness. Also there were eight therapist officers who deployed to the SE for hurricane support. He commended all on their outstanding performance and requested that the survey regarding lessons learned be completed and sent back to CDR Shapiro. CDR Payne and CAPT(s) Siegel have worked diligently to develop a simplified survey where not much writing is necessary. However, it would benefit the category to learn from members' experiences.

#### V. NEW BUSINESS

Category Readiness: Category readiness at present is 68+% as CDR Gaustad commended that we lead all categories and were personally congratulated by RADM Babb during the SG-CPO-PAC meeting on October 21, 2004. We need to move forward and assist those who are lacking a few items to complete for the basic readiness. The goal is 100% ready. CDR Shapiro reminded everyone that this current level of readiness is based on the Manual Circular 375 however, effective October 01, 2004 the new Manual Circular-377 (MC-377) is in effect and that we need to be compliant based on the new requirements. She encouraged everyone to please read it thoroughly and target the readiness based on the MC-377 requirements.

On question regarding the Flu Vaccine: she informed that there is a memorandum sent out by the ASH and the SG that due to unavailability of the Flu Vaccine, this requirement is being waived as a benchmark for basic readiness for current flu season only.

TPAC Elections: CDR Gaustad informed everyone that a call for self-nominations to the TPAC will be forthcoming shortly and he encouraged everyone to please submit to the call. CDR Shapiro informed that there are five positions are coming open for the TPAC membership. She will attempt to get the call out for the December issue as that would be a paper issue per CAPT Canton in OCCO.

USUHS Distance Learning MPH program: The Chief of Staff RADM Williams has approached the USUHS to offer a distance learning MPH program for the USPHS officers. In order to make it effective a need must be determined. Hence, all categories are being tasked to discern the number of officers interested in completing an MPH program via distance learning. CDR Gaustad asked CDR Manrique to get a survey out to the category to such effect and present results to him NLT October 29, 2004, which he will forward to CAPT McGarvey. (Action Item)

He further informed that this is preliminary survey and other questions like special pay and how the program would run etc. will be answered later. At present there is a recommendation from the Secretary and the SG's office for this to move forward however, in order that USUHS develops this program must have adequate need in the field for it to be cost justified.

Chiropractic White Paper: CDR Gaustad thanked the TPAC taskforce for preparing a well researched and objective document, and also thanked the TPAC membership for their critical analysis. The paper was sent out to the category about ten days ago. He further asserted that the paper was thoroughly researched and was not designed to be a propaganda tool, or to initiate any turf battles. He further informed that the physician and

dietician categories PAC's findings were similar to our PAC findings and were also presented to the SG-CPO-PAC. He invited CDR Fultz to comment.

CDR Fultz thanked TPAC for the opportunity to speak. He has written a detailed addendum to this white paper commenting on all items line by line. He respectfully disagrees with what CDR Gaustad said and also what the other PAC's think. He too has read the paper and read the same literature. He has difficulty with the conclusion statements. He further stated that physical therapy is a very broad scoped field and that there are only very few therapists with manual therapy skills/specialty. He further stated that currently there are 27 federal facilities where chiropractors are providing care to the beneficiaries.

CDR Gaustad acknowledged the comments and stated that he would read the addendum paper that CDR Fultz provided this morning and share it with the task force. Though not satisfied, CDR Fultz thanked the TPAC for opportunity to speak. There were no comments or discussion from the field.

#### VI REPORTS

A. **CPO Report-TPAC Chair Person Report** In absence of CAPT McGarvey, CDR Gaustad presented both the CPO and TPAC Chair reports simultaneously.

1. From yesterday's SG-CPO-PAC meeting where RADM Knouss and RADM Moritsugu stated that the Manual Circular 377 will be used for PY 05 readiness, promotion and eventually retention standards. He advised everyone to read the MC 377 thoroughly and familiarize themselves with the content and all requirements.

2. USPHS has contracted with mass media to start broadcasting public health service announcements as well as recruitment messages nationwide.

3. OCCFM is quickly moving forward with the Warrant Officer program. The proposals are due for completion by November-December timeframe and recruitment will begin in 2005. Therapist category is one of the categories, where the WO's will be asked to serve. Physical Therapist Assistants and the Certified Occupational Therapist Assistants would be examples for therapist category as being brought in the WO program.

4. Benchmarks review/revision: CDR Gaustad requested assistance of four senior officers to review and possibly revise the promotion benchmarks developed last year. CDR Balash and CAPT Cavanaugh (previous task force members) volunteered; also CAPT Hemingway and CDR Shapiro will be on the task force. (Action Item) CDR Gaustad will forward all information to the task force regarding meeting times and dates.

5. Vision statement: The TPAC charter is up for review and revision. Besides the Mission Statement that is currently present CDR Gaustad felt that a Vision Statement, given the transformation of the corps, would be extremely important to state where we would like to see our category go and grow to. He charged the category officers and civil service therapists to think of a vision statement and forward to the Administrative Committee via the Filed reps or directly. This will be an agenda item for next TPAC meeting.

6. Presentation at the Joint Operations Deployment Course (JODC): The Army has invited PHS therapists to identify one therapist to do a presentation jointly with the Army, Air Force, and Navy at the JODC at Ft. Sam Houston. Purpose of this course is to prepare the officers for deployment as well as sharing of the lessons learned by officers having deployed. This course takes the original Musculo-skeletal Spine course and applies it to the field setting. More details will follow. (Action Item for Education Subcommittee under Professional Development) Finally CDR Gaustad congratulated the category on all the accomplishments and willingness to take on the challenges ahead.

A comment from LCDR Ron West regarding the advanced degrees like DPT and MPH etc obtained by therapists and where to place them on the OPF. There was a discussion about the long term training form. A recommendation from CAPT(s) Siegel was to annotate the degree on the CV and submit transcripts and certificates to the OPF file room which can be entered on the 1st activity page. CDR Gaustad charged the Professional Development Committee and Education subcommittee to address this with OCCO and present findings at the next TPAC meeting (Action Item)
