## II. REVIEW AND ADOPTION OF AGENDA:

The agenda was reviewed and adopted following motion by CDR Balash and 2<sup>nd</sup> by LCDR Randall. Voice vote per roll call was obtained.

#### III. REVIEW AND ADOPTION OF PREVIOUS TPAC MINUTES:

Meeting minutes of Feb 18, 2005 meeting had been provided via e-mails to all TPAC members and were approved via e-mail by all members. Minutes were posted to TPAC Web site on March 15, 2005. A voice vote per roll call was obtained for approval of minutes as posted, following a motion by CDR Balash and 2<sup>nd</sup> by CDR Payne.

## **Invited Speaker:**

LCDR Peter Martineau is the therapist category liaison to OCCO. He is a staffing officer in the recruitment and assignment branch of OCCO. He informed that at present time there are numerous applicants from the other service requesting inter-service transfers. He is the Point of Contact for therapist applicants as well as for any open positions postings. He is also a contact for the associate recruiters. He offered that if any TPAC committee or subcommittee, like the recruitment, career development or, strategic growth committee, require information or statistics, should fell free to contact LCDR Martineau. He further informed that currently there are eleven open applications at various stages of processing. He explained the application process and open vs. closed application. He offered assistance to anyone who has questions or concerns regarding the applicants or placement issues. Also that with the transformation moving forward, the new applicants are expected to accept assignments for the need of the Corps i.e. the Therapist category. #### IV. REPORTS

## A. CPO Report

In absence of CAPT McGarvey to a previously scheduled meeting, CDR Gaustad included CPO Comments within the TPAC Chair report.

## B. TPAC Chair Report

CDR Gaustad congratulated the category in achieving 74.17% basic ready qualified status as of April 14, 2005. He commended the Readiness Committee and the OFRD Subcommittee for the extra effort with phone calls and assistance to officers. He strongly encouraged the category to achieve or better exceed the required 75% mark on May 01, 2005.

He welcomed CDR Michelle Hooper as the new Audiology Discipline Liaison and thanked CDR Weaver for years of service as the audiology liaison and congratulated him on the job well done.

The COA 2005 is approaching fast! We must attempt to have as strong a presence as possible. Therapist category is again leading with the BMI booth. CDR Drinkard will provide details on that. The evening social will be an excellent venue to re-establish old ties. We must all attempt to attend.

Congratulations again to CAPT McGarvey for being selected to receive the Catherine Worthingham Fellow Award. This award is given to a clinician for his/her outstanding contributions to the profession in clinical research and contributions consistently for a period of five or more years.

There is nothing new to report on the Warrant Officer issue at present time. There will be another meeting next and then in May to establish the appointment standards and definitions etc.

There is no progress on the 6<sup>th</sup> Precept issue. The CPO's and JOAG, again are reanalyzing the purpose and the intent of the precept. JOAG recommendations were that it is important to recognize officer's work but not necessarily use the assignment as a promotion tool but rather as a recruitment tool. As we all know there was a strong opposition to this initiative but it will be looked at further by the work group yet to be established.

CDR Gaustad informed the category that LCDR Jake Magel from the Shiprock Service unit has resigned his commission to join a private physical therapy, spine center as well as involvement with academia in Salt Lake City, UT. He thanked Jake for all his dedication and contributions to the Corps, and wished him the traditional "Fair Winds and Following Seas" To complete LCDR Magel's unfulfilled term on the TPAC LCDR Mike Faz was the first alternate and will be appointed to the TPAC as a voting member beginning July 01 2005. There was a discussion to not leave a position vacant and appoint the alternate immediately. CDR Gaustad asked CDR Payne to look at the current policies and procedures manual and attempt to modify the phrase concerning appointment of the alternates to fulfill a term. The updated wording will be presented to TPAC for vote during next TPAC Meeting on June 24, 2005. The newly elected officers' names were announced however, they are not officially members of the TPAC until the appointment is approved by the OSG.

CDR Gaustad thanked the eighteen officers who self nominated for the TPAC membership and encouraged them to continue to apply. The following members were elected: CDR Scott Gaustad, CDR Liza Figueroa, CDR Michelle Hooper and, LCDR Terry Boles. The alternates are; LT Teshara Bouie, CDR Jessie Whitehurst-Lief and LT Alicia Souvignier. TPAC looks forward to working with new members.

The following officers were welcomed into the Corps: LT Damien Avery, PT, BOP, FMC Butner, NC; LT Jessica Feda, PT, BOP FMC Rochester, MN; LT Ivy Chan NIH; LT Karen Killman, IHS Zuni NM; LT Irene Jordett, PT IHS, Anchorage, AK. Reserves on extended active duty are LT Joe Rasor at PIMC, Phoenix, AZ; LT Jenny Elton at Tripler Army Hospital, HI

The Surgeon General has declared 2005 as the year of the child. CDR Gaustad asked the category to come up with some ideas if we may want to demonstrate support as a category to this initiative. A task force was formed to look into this issue and come up with a power point presentation that would give a universal message from our group about the year of the child, childhood obesity and other issues in a multidisciplinary approach. With CDR Pickering as the chair and members including: LT Souvignier, LT Murdoch, LT Tanzillo, LCDR Faz, CDR Michelle Smith, CDR Garner the task force was established to leave the door open for more volunteers.

## COA 2005 Task Force

CDR Shapiro reported that at the COA conference we will have a very busy but productive category day with excellent speakers as well as retirement ceremony, awards and paper presentations. The evening social event onboard the Spirit of Philadelphia is planned and approx 130 officers have thus far registered for the dinner cruise. The transportation available to the ship and the dress is casual.

## V. Committee reports: (Written Reports are attached)

**Administration Committee:** CDR Shapiro reported that the Elections are complete and the results are as follows: New Elected officers to the TPAC are: CDR Scott Gaustad, CDR Liza Figueroa, CDR Michelle Hooper and LCDR Terry Boles. Their appointments of course are pending the OSG Approval. The process has begun and we are awaiting response from the OSG A full committee report is attached.

Finance Subcommittee: Entering in the annual fund raising drive for 2005. The goal is to raise \$ 2,000 for this year. **Strategic Growth Committee:** LCDR Dahl reported for LCDR Melanson that the vacancies will be posted on the web site and there will be a recruiting booth at the APTA conference.

Professional Development Committee: CDR Manrique submitted a written report.

**Information Management Committee:** LCDR Newman deferred to the submitted report and acknowledged and congratulated CAPT Keith Varvel on his retirement after a successful career of 29 plus years with the USPHS.

Readiness Committee: CDR Drinkard congratulated all the officers who completed Basic Readiness requirements. He asked officer to contact CDR Drinkard or CDR Shapiro if any further assistance is required. He also provided update on the Healthy Lifestyles Booth at the upcoming COA conference in Philadelphia. Dieticians will be working with us. Please contact LCDR Henry McMillan to volunteer at the booth. There will be BMI measurement and possibly the Body Composition. We will also probably have a portable instrument that measures the resting energy expenditure.

## VI. OLD BUSINESS

TPAC Elections: Previously reported

Commissioning Standards: CAPT Cavanaugh provided status report that PT appointment standards have been updated and good feedback received. Discipline Liaisons of other specialties are being contacted to solicit input into OT, SLP and AUD.

Awards: CDR Balash reported that the Awards Task Force has submitted various documents to TPAC members for approval and comments on the matrix. One the approval from the TPAC members is obtained the guidelines will be sent to the Awards Board members to use for voting on the awards.

CCMIS Web Site: LCDR Newman reported that the task force is currently working on updating the Therapist Category information on the USPHS.gov web site. The draft is being prepared to be submitted to the TPAC members and CAPT McGarvey for review and comments and approval. It should be sent out with in the next couple of weeks.

Charter/P&P Manual: CDR Payne reported that he is in the process of reviewing the document himself and then send it to the Task Force. He informed that there are not many changes except those that he is able to update from the TPAC meetings. CDR Gaustad encouraged people to submit recommendations for any changes.

Mission/Vision Statement: CDR Gaustad had nothing to report at this time. He feels certain that the Task Force will be ready to present its recommendations at the COA conference on the Category day.

#### VII. NEW BUSINESS:

CDR Gaustad again addressed the participation by the Civil Service therapists in the TPAC functions. He recommended that a task force be formed to review this issue. LCDR Newman commented that from the therapists in her area, the comment is that TPAC primarily discusses officer issues which are not of much relevance to the CS therapists. Task Force team leader will be LCDR Newman and members will be CDR Gaustad, CDR Shapiro and LCDR Richardson.

Respiratory Therapists issue was brought forward that if they should be considered for commissioning in the USPHS. LCDR West informed that from previous findings, the reason that the Respiratory Therapists were not originally recommended was because of their education level not being at a minimum of Bachelors Degree. The RTs are primarily of the associate degree level. Further discussion on this was tabled for next meeting.

## VIII. OPEN FORUM:

CDR Gaustad informed of his involvement at the JODC Course in San Antonio, TX and LT Stephanie Maxfield was also a participant. He encouraged the therapists to participate in this.

- ✓ Deadline funding needed by? (Suggest 6 8 weeks in advance)
- ✓ Where to send funding?: Check payable to? Address? Telephone#? Social Security# or Tax ID#? (HJF must pay the company directly. They will not reimburse government employees).

## **Finance Committee Topics:**

- There are two ways for the TPAC to pay for expenses:
  - A TPAC committee can request funds. After approval by the finance committee, the requesting committee must get an invoice and the HJF will pay the company directly (HJF will no longer reimburse government employees for expenses incurred).

- The COA Meeting planners depend on the PHS Categories for vendor contacts to fill the exhibit hall. In turn, the COA reserves some of the monies collected on the booth space for the individual categories. These funds are used for meeting expenses such as speaker honorariums, awards, recognitions, and retirement ceremonies. The 2003 COA Meeting, Therapist Category Program in Phoenix, AZ was funded in this manner (COA will not reimburse government employees for expenses incurred).
- We need help with finding benefactors to our HJF account and COA exhibitor's hall. Please let us know of any potential contacts. As COs we are not able to solicit for monies, however, we can explain the process for HJF donations or participation in the COA exhibit hall to local and national vendors with whom we come in contact. It is acceptable to ask if it would be all right for the HJF or COA to contact them. Currently, the large majority of funds collected for the Henry M. Jackson Foundation account are from three main sources:
  - Large donations of speaker honorarium and cash awards from Therapist Category members.
  - o Large donations from a prosthetist from Phoenix, Arizona.
  - o The collections from fund drives.
- It is requested that all educational seminars and continuing education workshops that are set up by Therapist Category Members or advertised by the TPAC Education Subcommittee request a generous donation to the Henry M. Jackson Foundation account from all participants. Recommended \$25.00 donation.
