#### A. <u>CPO Report</u>

CAPT McGarvey was away attending the Annual APTA conference. CDR Gaustad presented information from the CPO report.

#### B. TPAC Chair Report

CORPS Transformation: Works groups continue to forward information to the ASH for review. OCCFM continues to disseminate information re CORPS Transformation via:

- CCMIS website
- o USPHS website
- o CC Bulletin
- Three and Freeze Promotion Policy:
  - The existing policy was amended and immediately approved. Changes include referral to a retention board for officers scoring in the lowest percentiles. See the CC bulletin for more information
  - o Officers seeking assistance preparing for promotions may:
    - Review the Career guide on the Therapist Category website
    - Contact CDR Michaele Smith re the Therapist Category Mentoring Program
    - Review their OPF
    - Contact the Therapist Category CPO, CAPT McGarvey
- 12 new staff positions (10 in OCCO, 2 in OCCFM) will soon be available for Officers interested in working on CORPS Transformation.
- The SERT acronym has been changed to ERT (Emergency Response Team)
- Therapist Category Basic Readiness is at 79%. Officers may log onto the CCMIS website to check on missing Readiness criteria.
- Any Officer who has not responded to the readiness tier survey will automatically be placed in tier number 3.
- Official promotion results will be published soon
- OCCFM is revising the CCPM to include the following:
  - o Easy to read format
  - o Web-based
  - Search capacity
  - Cyclic review/policy update
- Manual Circular 377 (Readiness Standards) is being revised. CDR Shapiro will review the revisions and inform the TPAC of important changes
- RADM Halliday is the new Dental Category CPO
- CDR West reported he was detailed to serve on the Secretary's Transformation Action Team for Preparedness for the Month of April. This team was headed by RADM Craig Vanderwagen and tasked by Secretary Leavitt to address the DHHS response to the 10 Recommendations and 1 Critical Action that were given to DHHS from the Hurricane Katrina Lessons Learned White House Recommendations. (www.whitehouse.gov/reports/katrina-lessons-learned/)

The recommendations addressed by the team were numbers 57-66 and Critical Action #10. The recommendations from the team have been incorporated into the transformation of the Commissioned Corps. They were split into current changes and long-term changes for the DHHS. The current changes directly impact the Commissioned Officers to be trained in the National Incident Command Structure (hence the requirement to complete the IS-100, IS-200, IS-700, and IS-800), and rostered into ready and deployable teams (hence the Tiered rostering of the OFRD).

CDR West tried to ensure that therapist professions were recognized in the make up of the teams.

CDR West recommended that Category members prepare themselves and their families by having their license and important papers on file in there email archives and to have a 72 hour go bag for each member of your family. It was also recommended that each individual meet with their department and have a department deployment plan so that whole departments will not be depleted.

#### C. Administration Committee: No report at this time

#### D. Information Management Committee:

**Field Rep Coordinator:** CDR Figueroa reported that BOP has two field rep vacancies and NIH has one field rep vacancy. Contact CDR Figueroa for more information.

#### E. Readiness Committee:

CDR Shapiro reported that OFRD is requesting therapists to volunteer for Tier 1 Rapid Deployment Force (RDF). Agency concurrence is needed. All officers interested should contact CDR Shapiro at <u>RShapiro@comtdt.uscg.mil</u> with their Name, Rank, Geographic region, and Agency. OFRD will pursue agency concurrence.

CDR Shapiro urged Therapists Officers to finish the FEMA Online training by June 30.

#### V. OLD BUSINESS

#### TPAC Elections:

CDR Gaustad announced that the beginning of the TPAC operational New Year is July1. Seven new TPAC members will begin their terms.

CDR Manrique was unanimously elected as the new TPAC Chair. LCDR Randall was appointed chair of the Professional Development Committee. CDR Figueroa was appointed chair of the Information Management Committee LCDR Souvignier was appointed Recruitment Sub Committee Chair

Promotion Benchmarks:

CDR Gaustad reported that the PAC chairs forwarded a white paper with recommended revisions for promotion precepts 1 and 4 to the CPOs.

These revisions will go into effect in promotion year 2008.

CDR Gaustad reminded Officers that the Benchmarks are "What the Promotion Board reads"

#### TPAC Charter and Policy and Procedures Update

CDR Payne reported that the TPAC Charter was revised in accordance with the OSG model charter and the policy and procedures manual (P&P) was updated. These documents were sent to the TPAC members by email for comments.

CDR Payne motioned that the new TPAC Charter and Policy and Procedures be adopted. CDR Randall seconded.

The TPAC Charter and P&P were unanimously approved and adopted.

#### Sharing of Published Information on the Category Website

CDR Randall is to form a task force to determine whether published research articles etc can be posted on the Category website.

#### Transformation Task Force

LCDR Boles reported that OCCFM is now disseminating information on CORPS Transformation via the CC bulletin and CCMIS website. With these mechanisms in place there is no need to pursue other means of distributing information to the category.

Recommended Retirement Protocol

CDR Woodard asked that Officers planning to retire notify the Retirement Recognition Subcommittee ASAP. A standard format for retirement recognition at COA meetings is being planned.

#### TPAC Billet Descriptions

CDR Fultz reviewed the history of previous changes to Therapist Category billet descriptions as well as work toward expanding existing Board Certifications eligible to receive Board Certified pay.

CDR Gaustad initiated a Billet Description and Board certified Pay Task Force to:

1)Recommend Specialties to receive Board Certified pay

2)Review and Update current Billet descriptions for the Therapist Category

CDR Fultz was appointed Task Force chair

Other volunteer members include LCDR Tanzillo, LCDR Bottachio and LCDR Shultz CDR Fultz requested that Officers from the SLP and Audiology professions also volunteer to serve on the Task Force. CDR Gaustad asked the Task Force to report back to TPAC in DEC. <u>Appointment Board for New Accessions</u>

CDR Shapiro reported that OCCO has had difficulty obtaining the required number of Therapist Officers to serve on appointment boards.

Until the process can be managed electronically CDR Shapiro requested that DC metro Area Officers (with rank of 04 and higher) participate in a rotating roster.
