The agenda was reviewed and adopted with a motion by CDR Gaustad and seconded by CDR Shapiro.

III. REVIEW AND ADOPTION OF PREVIOUS TPAC MINUTES:

October 2006 meeting minutes were provided and approved via e-mail to all TPAC members. Minutes were posted to TPAC Web site in November 2006. The October 2006 meeting minutes were adopted by acclimation.

IV. GUEST SPEAKER(S): RADM Robert Williams, Surgeon General Chief of Staff RADM Williams discussed transformation:

- RADM Williams stated progress has been made and transformation continues to move forward with enthusiasm within the Department.
- The transformation implementation plan and time lines have been placed on the CCMIS website.
- Twelve transformation officers are developing policies and procedures in order to have everything in place for transformation by the end of 2008.
- Information will be posted periodically on the CCMIS web site and in the Commissioned Corps e-bulletin. There will also be a question and answer section on the website soon for officers in the field.
- Each PAC and CPO will be needed to address specific category issues in order to add an additional 1000 officers in the Corps.
- 400 to 500 officers should be able to be brought into the Corps through Agency proposals.
- Commissioned Corps My Story has been developed to improve Corps visibility in local communities. Contact your CPO or check the eOPF website for more information.
- Q&A: CDR Shapiro asked about a recent article in the COA Frontline concerning the
 recent negative publicity and hearings before Congress. RADM Williams stated the
 incident in question needs to be taken in context. It is hoped the community outreach
 and visibility plans will help address Congress' concerns and expose more citizens to
 the U.S. Public Health Service Commissioned Corps.
- CDR Fultz asked about the status of naming a new Surgeon General. RADM
 Williams reported there may be interest in the White House to name a new SG. It is
 hoped something early next year may occur.
- CDR Shelton asked if there have been discussions about ways to compete with civilian employers for new officers. RADM Williams stated incentives are being explored for hazardous duty, isolated hardship areas, and hard to fill billets including family support for new and current Corps officers.
- CDR O'Neill-Manrique asked if there will be tuition assistance possibilities. RADM Williams replied this is being looked at by transformation teams but is not included in current or near future budget requests.

V. REPORTS

A. CPO Report: CAPT McGarvey and CAPT Karen Siegel (CPO select) reported:

- The U.S. Army-Baylor program has been included in transformation recruitment
- The Surgeon General signed the report created by the Respiratory Task Force recommending RT appointment to the Therapist Category. The report has been sent to the ASH for review.
- Commissioned Corps and Therapist Category readiness levels have dropped below 70%. According to the Office of Management and Budget (OMB) the Corps must remain 70% readiness. Most therapist officers recently removed from basic readiness status were dropped because the four FEMA courses were not completed.
- The sixth promotion precept (3-H) was not approved for promotion year 2007.
- Emails were sent to officers notifying them of there readiness status after the 7 December readiness check by OFRD. The four FEMA courses as well as the original online readiness courses are necessary for basic readiness. The basic online courses are now on Blackboard, not CenterLearn.
- If an error exists in the OFRD data concerning your readiness status, contact OFRD or fax missing items to 301-443-1525. Check the OFRD website on a regular basis and resubmit items if they have not been posted within in one or two months after completion.

B. TPAC Chair Report

- Officers have until 31 December to complete their flu shot requirement for readiness.
- Contact CDR Theresa Minter, Division of Commissioned Corps Assignments, or Agency Liaison for questions about security clearance requirements.
- Therapist officers will compete for promotion before a hybrid board for promotion year 2007. For questions about promotion, contact your CPO, Agency Liaison, or PAC Chair.
- The 2008 promotion benchmarks are currently being worked on in the hope to avoid another last minute publication next year.

- **C.** Administration Committee: LCDR Dahl mentioned the self-nomination form for TPAC membership has been posted on the website.
- **D. Information Management Committee:** CDR Figueroa stated any clinics interested in using Inactive Reserve officers should contact LCDR Souvignier. CDR Smith attended the Quad Service meeting in September. The meeting minutes are included in the Field Rep Report.
- **E. Readiness Committee:** CDR Shapiro reported the Therapist Category readiness roster was updated on 11 December. She will send a category readiness email to the CPO and PAC Chair soon. CDR Shapiro stated category readiness needs remain at or above 70%. It is currently below 70%. Another health lifestyles newsletter will be published in an upcoming e-bulletin.
- **F. Strategic Growth Committee:** LCDR Boles deferred to his report but stated the category profile was updated in October. CDR Scott Gaustad is the new Strategic Growth Subcommittee Chair.
- **G. Professional Development Committee:** LCDR Randall reported category award nominations begin 1 January 07 and are due 1 February. The Retirement Committee is working on the COA retirement ceremony. LCDR Jessica Feda reminded everyone to contact her at ifeda@bop.gov and provide her with individual specialty certification information including certification number. LT Brian Elza is the contact for the McKenzie Part A course being held at Northern Arizona University next year.
- H. Therapist Category Liaison: No report.

VI. OLD BUSINESS

COA 2007 Planning: CDR Lief provided an overview of the therapist category day which now includes two professors from the University of Cincinnati. One will present on using biofeedback with stroke patients and the other will describe using teleconference in rehab settings. RADM Royal is scheduled to speak as well. There will be a panel discussion on non-traditional billets. The Commissioned Officer Foundation is the new sponsor for the entire conference this year. Hotel arrangements are forthcoming; the Millennium Hotel is planned. Online registration is now available. The body mass index booth will be present this year again.

<u>Billet Description Task Force:</u> CDR Fultz reported 58 current category billets have been reviewed. A position paper will be presented to the PAC for review approving recommendation for wound care specialty billets and special pay. The task force has used the four functional practice groups to develop career pathways. They are in the process of reviewing research and applied public health billets; future work will be related to mental health billets. The goal of the task force is to finish the review process next month and provide its findings with a career development matrix to the PAC for consideration.

<u>Legal Issues/Federal Government Therapist:</u> CDR Figueroa stated the task force will meet in January and report to the PAC in February. The group will review physical therapy scope of practice first and then other disciplines. Documents from other services and information related to IHS nurse scope of practice has been obtained for reference.

VII. NEW BUSINESS

<u>Functional Work Groups Task Force:</u> LCDR Richardson reported the task force will meet next month. Members include: CAPT Parks, CDR Drinkard, and CDR Jordan. CDR Fultz is an adhoc member.

Benchmark Resource Guide for Hybrid Promotion Board: The 2007 therapist promotion board will be partly composed of officers from other categories because of the lack of eligible therapist officers. A group of therapist officers are reviewing the second benchmark (education) in order to develop a reference document for non-therapist category board members. The group plans to present the document to the PAC in January for approval in order to be ready for the board by 1 February.

Extension of Manual Circular 377- Readiness: CDR O'Neill-Manrique reiterated officers are required to have a flu shot before 31 December in order to maintain basic readiness standards.

OPEN FORUM – CDR Shelton reported the IHS is creating a wellness center model and attempting to identify disciplines for the centers. Physical therapists have been identified as possible staff to provide services. Billet opportunities may occur as a result.

LT Scott Mitchell reported the U.S. Army-Baylor transitional-DPT program has expanded eligibility to anyone who graduated from the U.S. Army-Baylor program in the past.

- The last Education Subcommittee meeting was held on October 24th, 2006.
- Next meeting will be in mid-January 2007
- The Education Subcommittee has prepared an "Advanced Practices" page to be posted on the Education Subcommittee page. This page will highlight the therapist category's efforts as a whole and offer a means to share clinical presentations and information. The page is designed to focus on evidence-based practice. The page will include information on how to obtain clinical specialization, a list of therapists who have obtained specialty certifications, a list of therapist research citations, critically appraised topics, course information with feedback, and therapist presentations. LTJG Estevez is currently working with CAPT Siegel to ensure adequate posting of the material. More information will be forthcoming once the page is posted, so therapists will be aware of the site, understand how the page will work, and encourage participation/postings. I have attached a template of the page as an introductory measure for therapists to acquaint themselves. The Education Subcommittee highly encourages all therapists to take a quick look at the page and see how they might contribute to the page in the future. This site has the potential to be a useful resource for current evidence/research and course feedback with sufficient participation. - The committee is also preparing a "white paper" for TPAC approval. The paper will propose future design and need for an interdisciplinary PHS website which would allow distance clinical consultation and a means to share professional and clinical information. LTJG Estevez, LCDR Tarri Randall, LCDR Jessica Feda, CDR Manrique-O'Neill, and CAPT Siegel met in October 2006 via teleconference to discuss the basis of a proposal and future direction. The paper is currently in rough draft form and awaiting feedback/approval from the Education Subcommittee members. The Education Subcommittee hopes to present the paper to the TPAC leadership prior to the start of the new year.

- Please consider attending the McKenzie Part A course July 27-30th, 2007 at Northern Arizona University's Campus. More people are needed to attend in order to sponsor the course. See below:

This McKenzie certification is a four part course that is offered over a three year period on an annual basis for parts A(Lumber/thoracic), B(Cervical) and C(review) at a reduced rate. Part D is not sponsored. The course is taught by Mr. Greg Silva. It is held at Northern Arizona University's campus. Greg has been in the field of physical therapy for over 30 years and is also a former Public Health Service officer. He has had the opportunity to practice with Robin McKenzie and offers a unique perspective into the treatment of spine using the McKenzie method. If you have not attended one of his courses, this is an excellent opportunity to not only attend continuing education, but also to network with our colleague's in the IHS (Indian Health Service). As an attendee of the past class and an agency transfer from the IHS, I was lucky enough to attend Parts A,B, and C under his tutelage. If you have the opportunity to attend, this course proves to be another methodology that offers effective management strategies that can be employed in outpatient settings including the BOP.

Readiness: The therapist category basic readiness status as of December 6, 2006 is not available yet. We should have that report very soon. The readiness committee met on Nov. 30, 2006 to strategically plan to get our whole category basic ready qualified.
