II. REVIEW AND ADOPTION OF AGENDA:

The agenda was reviewed and adopted by acclimation.

III. REVIEW AND ADOPTION OF PREVIOUS TPAC MINUTES:

February 2007 meeting minutes were provided and approved via e-mail to all TPAC members. Minutes were posted to TPAC Web site in March 2007. The February 2007 meeting minutes were adopted by acclimation.

IV. GUEST SPEAKER(S): NONE

V. REPORTS

A. CPO Report: CAPT Karen Siegel reported:

- Meeting with AOTA on January 16, and spoke about OT mental health responder role and role of OTs in disaster response.
- Meeting with ASHA on March 2, and discussed role of SLPs in school settings, evidence based practice, and disaster response. There is interest in doing a feature in ASHA magazine about Commissioned Corps.
- Met with APTA which indicated it intends to have more outreach to federal PTs with uniform leadership on APTA management and leadership. The October, 2007, For Your Health magazine will have a cover article on the uniformed services including USPHS emergency response.
- RADM Royal will be the keynote speaker at the APTA Denver meeting.
- The US Army is forwarding a request for hand therapy and wound care board specialty pay for the 2008 fiscal year. If DoD responds and approves the proposal, the USPHS will be able to take the proposal to the Compensation Branch. More work may be needed to finalize specialty pay for wound care and hand therapy.
- There is pressure on transformation work groups to do a lot of work in a short period of time. All billets will be rewritten and based on the duties for that position, not the officer. All clinical billets will be changed this summer. Multidisciplinary billets will be rewritten later.
- The Commissioned Officer Foundation conference planning committee is working hard. Only 250 people from DHHS will be able to receive funding (at least one dollar) to attend the conference. Officers must not use a Government credit card during to attend the conference unless on official business.
- The last COA Frontline contained her article on deployment.
- The April *PT Magazine* focused on disaster response with no comment on the USPHS Commissioned Corps Therapist Category. CAPT Siegel is writing a letter to the editor concerning this matter. It is scheduled to appear in the July edition.
- OFRD reports there are no therapist billets for the USNS Comfort mission this summer. There is also a Pacific mission this summer with a public health infrastructure mission. No therapist billets are planned.
- The current category readiness level is 86%. Overall Corps readiness stands at 78.4%. Officers not basic ready qualified will be removed from promotion lists this year. OFRD will perform quarterly checks for readiness from now on.

B. TPAC Chair Report

- Field Medical Readiness Badges have been awarded.
- Assimilation boards will be convened soon.
- Uniform changes are forthcoming. The USPHS Commissioned Corps will align to the US Navy uniform and appearance standards. Beards will no longer be allowed. BDU changes will phase out the woodland design. The summer blue (salt and pepper) uniform will most likely be eliminated.
- Six new members have been elected and are awaiting Acting SG approval: CDR
 Martha Duganne, CDR Kathleen O'Neill-Manrique, CDR Jessie Whitehurst-Lief, LCDR
 David Byrne, LCDR Joseph Golding, and LCDR Monique Howard.
- Four current members will leave the PAC in July: CDR Jordan, LCDR Dahl, LCDR Faz, LCDR Randall.
- The therapist awardees have been selected; all will receive plaques at the COF conference;
 - CDR Jessie Whitehurst-Lief Therapist of the Year
 - o LT Heidi Fischer Junior Therapist of the Year
 - o CAPT Rebecca Parks Joseph Hoog Award

- **C.** Administration Committee: LCDR Dahl deferred to the report. CDR West stated the 6th annual fundraiser will be running until July 1. Monies will be held in the Therapist Category Henry M. Jackson Foundation Account. See attached fundraiser flyer (Attachment F).
- **D. Information Management Committee:** CDR Figueroa deferred to the report. LCDR Jodi Tanzillo highlighted items listed on the Information Management Committee report.
- **E. Readiness Committee:** CDR Shapiro deferred to the report.
- **F. Strategic Planning and Development Committee:** LCDR Boles deferred to the report but stated there are 34 vacancies listed on the TPAC web site. He reported the Retention Subcommittee is finalizing the final survey draft. LCDR Boles reported four previous scholarship recipients need placing but have failed their licensing boards. The fifth is in debt collection. There are six new students in the scholarship program: 4 PT, 1 OT, 1 PTA.
- **G. Professional Development Committee:** LCDR Randall deferred to the report.
- **H. COA Category Liaison:** CAPT Pickering reported the COA elections are ongoing. Please go to the COA web site to vote. CAPT Pickering stated only 250 funded officers from the Department of Health and Human Services are allowed to attend the COF conference.
- **I. JOAG Category Liaison:** LCDR Feda reported she is the TPAC liaison to JOAG. JOAG is for officers LCDR and below. JOAG members serve two-year terms; self-nominations begin in March. CAPT Dean Coppola is the Senior Advisor.

VI. OLD BUSINESS

<u>COA 2007 COF Meeting Planning:</u> CDR Lief reported the early bird registration deadline has been extended to 30 April. Emails have been sent to all speakers to ensure they are registered. A tentative schedule for booth coverage has been set.

Assimilation Task Force: See attached report.

Appointment Standards and Foreign Trained US Citizens: LCDR Boles reported for CDR Gaustad. LCDR Boles stated the task force mission was to review current and new appointment board standards for foreign trained therapists and provide recommendation to the TPAC concerning allowing foreign trained therapists into the USPHS Commissioned Corps. Uniformed Services' policies and professional organizations were reviewed and interviewed. LCDR Boles stated commissioned officers must be a US citizen or naturalized citizen. Therefore, the proposed new appointment board standards for the USPHS Therapist Category should stand and not be amended to reflect foreign trained graduates/ professionals. Task Force recommended that it is beyond the scope of their charge to recommend or pursue international academic programs to become accredited through their respective United States professional accrediting bodies.

VII. NEW BUSINESS

Recruitment/Central Call Center: LCDR Souvignier reported on new initiatives for recruiting. She stated a student reserve program will be established to allow students to join the Commissioned Corps while pursuing their commissionable degree. Students joining with this program will have the benefit of a base pay entry date beginning while in school. The new COSTEP program will function like the previous COSTEP program with no payback period. The Early Commissioning Program (ECP) may allow the Commissioned Corps to reinstall students in the US Army-Baylor Graduate Program in Physical Therapy or other officers in other discipline programs. With the ECP, students apply before entering their commissionable program. It does not include

undergraduate work. Students are paid at the Ensign (O-1) grade and incur a payback. There is no time limit for funding under the ECP.

Policy has been written for all recruitment/student initiatives but no final decision or approval as occurred.

LCDR Souvignier also reported about the centralized recruitment initiatives. On 9 April, the new Commissioned Corps call center went into effect. There is a new number for potential recruits with the goal to have a recruit speak to a person. The caller will then be referred to an Associate Recruiter Lead ultimately an Associate Recruiter. The new call line (800-279-1605) has been receiving 20-30 calls a day in conjunction with the new nation-wide recruitment efforts. The call center only mentions medical, nurse, pharmacy, and dental professions directly. It includes therapy in the "other health professionals" statement.

OCCO is working on centralizing recruitment. Ideas for this effort were recently requested from PAC members. Money is the limiting factor with the effort.

LCDR Souvignier reported there are now only 15 Associate Recruiters in the therapist category after the new standards for ARs were implemented. Officers interested in becoming an AR or with general recruiting questions should contact the current category AR Leads: CDR Melanson or LCDR Souvignier.

The USPHS web site (<u>www.usphs.gov</u>) is undergoing changes. Ideally it will be linked to the new electronic call to active duty system.

<u>Category Demographics</u>: CDR Shelton reported the category demographics were recently sent to TPAC members. CDR Shelton stated there was no accurate metric to measure board certification. He stated the readiness percentages do not add up to 100 percent because exemptions are taken out of the totals. CDR Shelton stated he is unable to find similar data from the other categories for comparison purposes. The information will be placed on the TPAC web site in the next month or so.

Awards Subcommittee –Consideration for Additional Duties: CDR O'Neill-Manrique requested consideration to expand the Awards Subcommittee duties to include awards such as AMSUS awards. CDR Balash stated there are currently four official category awards. The subcommittee also works with the TPAC chair to provide certifications of appreciation for outgoing TPAC members. It also works with the Therapist Category CPO to provide the outgoing PAC chair a certificate of appreciation. It will also work with the CPO for outside awards such as AMSUS awards. Officers interested in working with the Awards Subcommittee to address additional awards should contact CDR Balash.

OPEN FORUM – CDR West stated the therapist category coin will be available at the COF Conference. Information on the coin is on the TPAC web site.

Goal:

The goal for this group was to compile data on the status of our category in regards to assimilation. The purpose of compiling this information is to 1) assess whether or not a problem exists relevant to unacceptable numbers of Therapist Regular Corps officers 2) demonstrate our enthusiastic and deep-seated category commitment to the Commissioned Corps.

Background:

During the 23 February 07 TPAC meeting there was discussion regarding the assimilation of Therapists officers. The question was posed whether new Therapist Officers were educated and mentored concerning the importance of the assimilation process. A Task Force was formed and tasked to compile data specific to assimilation of officers in the Therapist Category and to make recommendations for change.

Please refer to Policy CCPM 23.3.7 (Regular Corps Assimilation Program) on the CCMIS web site.

To be eligible for assimilation an officer needs to have at least 2 years active duty before they can apply and 3 years before the board can review their application. The officer cannot be on a limited tour status and they must meet requirements such as readiness, licensure, security clearance, and medical requirements (Physical within 5 years and annual Medical History form).

Categories of assimilation status are:

- 1) Applicant = not yet reviewed by board
- 2) <u>Recommended and sufficiently high on the rank order list</u> = reviewed by board and placed on the list sent to the President for nomination
- 3) Recommended but not sufficiently high on the rank order list
- 4) Not recommended

Findings: as of February 27, 2007

- 135 Therapist officers
- 53% are Regular Corps (71 Regular, 64 Reserve)

- 6 of the Reserve corps are on the 2006 nomination list that has not been confirmed by the Senate.
- 13 of the Reserve corps are in the 2007 assimilation board year pool (Applicant status)
- 2 of the Reserve corps are in the 2008 assimilation board year pool (Applicant status)
- Through review of the Blue Book on the CCMIS web page and using the Original Entry Date into the PHS, there are 32 officers eligible for assimilation.
- 6 officers eligible to send their Assimilation application to meet the 2008 board.
- When the 6 officers on the 2006 list have executed the appointment affidavit after Senate confirmation we will be 57% Regular corps, leading the categories.
- Almost all applicants are recommended for assimilation.

* All category Regular Corps appointment standards are not equal. The percentages may not be completely comparable. The Eng, EHO, and HSO categories require additional requirements for Regular Corps appointment in addition to basic Reserve Corps appointment standards. Our category does not have additional requirements.

The PHS is very close to the 2800 Regular corps ceiling. Currently, the Corps does not have a force management plan by category for the Regular Corps. As of now it only has a permanent grade distribution force management policy.

The Assimilation Task Force met on 19 Mar 07 to review the findings. Highlights of the discussions at that meeting and via e-mail follow.

Discussion:

Potential reasons for not being assimilated when eligible are:

- 1) the officer does not recognize the significance of assimilation and has not applied
- 2) the officer may have applied and was not recommended.

Comments made that any officer not assimilated should be mentored because 1) shortcomings in their career may be identified through the mentoring process and allow opportunity for improvement, 2) mentoring provides needed education regarding the PHS and how to manage their PHS career.

There was a comment that officers with 199_ entry date and not yet assimilated be contacted to identify their intentions with an offer to assist them in the application process or be identified as not actively interested in assimilation and the reason why.

Comments that not all officers should be approved for assimilation, as assimilation is an honor that should be held by the most valued members of the Corps. Recognition of this status should begin with the supervisor and supervisors should recognize their responsibilities in the assimilation process.

Top-flight officers should be identified by the CPO, PAC and supervisors and encouraged to apply for assimilation.

It is not clear whether or not officers involved in the therapist-mentoring program are routinely counseled regarding the benefits of assimilation and the application process. Our mentoring program could be improved upon with more structured mentoring with specific check off lists of topics to be reviewed including assimilation; this would also allow for more accountability and congruence in what is being discussed with new officers.

Recommendations:

- Engage our mentoring program with more formal education on the assimilation process.
- Develop an educational tool for PHS Officers or supervisors of PHS Officers covering the rationale and process of assimilation and the need for supervisors to be prudent about providing an endorsement.

SUBJ: TPAC TASK FORCE ON FOREIGN TRAINED PROFESSIONALS

In January 2007, CAPT Becky Parks queried the Therapist Professional Advisory Committee if Foreign Trained Professionals (FTP(s)) could be commissioned in the U.S. Public Health Service. Her query was generated because of the significant need for highly competent rehabilitation professionals throughout HHS and non-HHS agencies. Also, there are currently no guidelines in the old or proposed new draft of the Therapist Category Appointment Board Standards specific to foreign trained graduates/professionals. At the February TPAC meeting, CDR Manrique-O'Neill and CDR Gaustad brought this query to the TPAC and subsequently a FTP Task Force was formed.

The members of the TPAC FTP Task Force are:

CDR Scott Gaustad, Leader CDR Jessie Whitehurst-Lief CDR Mercedes Benitez-McCrary CDR Rita Shapiro LCDR Alicia Souvignier

The goals of the FTP Task Force were twofold:

- To review the current appointment board standards and the new appointment board standards draft for guidance on eligibility and commissioning of FTPs in the U.S. Public Health Service Therapist Category.
- 2) To recommend or not recommend to the Therapist Category the appointment of foreign trained category professionals into U.S. Public Health Service. The recommendation would be based upon current professional boards and accrediting organization's guidelines as well as the commissioning guidelines of Medical Service Corps officers in the Navy, Air Force and Army.

The TPAC Task Force met March 29, 2007, at 1400 EDT to discuss the feasibility of whether foreign trained graduates and/or professionals in the fields of Physical Therapy, Occupational Therapy, Speech-Language Pathology and Audiology should be considered for commissioning in the U.S. Public Health Service Commissioned Corps.

Prior to our first meeting, members of the FTP Task Force were asked to contact the Therapist Category professional boards, accrediting organizations and the Department of Defense Officer

Recruiter Programs specific to the commissioning of Medical Service Corps (MSC/BSC) candidates. CDR Rita Shapiro was asked to contact the American Physical Therapy Association (ATPA) and U.S. Navy, CDR Jessie Whitehurst-Lief was asked to contact the U.S. Air Force, CDR Mercedes Benitez-McCrary was asked to contact American Speech Language and Hearing Association (ASHA), LCDR Alicia Souvignier was asked to contact the U.S. Army, and CDR Scott Gaustad would contact the American Occupational Therapy Association (AOTA), Office of Commissioned Corps Operations (OCCO) and Office of Commissioned Corps Force Management (OCCFM).

CDR Rita Shapiro reported that the U.S. Navy's policy on the commissioning of foreign trained graduates/professionals is consistent with that of the Army and Air Force policy. She reported to the group that for a FTP applicant to be considered by U.S. Navy he/she must be a U.S. Citizen, a member of their professional organization (i.e. APTA) and a graduate from an accredited professional program. CDR Shapiro reported that the American Physical Therapy Association's policy on FTP /FTG is that the individual must have a current Physical Therapy license, resident of the United States and a professional credentials evaluation.

CDR Jessie Whitehurst-Lief reported to the group that the Air Force will only consider Biomedical Science Corps applicants who have graduated from an United States accredited professional program, are U.S. citizens and who have or are eligible to sit for the applicant's respective professional license examination.

CDR Mercedes Benitez-McCrary reported to the group that the American Speech-Language and Hearing Association states the student/applicant must be a graduate from a United States accredited academic program in Speech-Language Pathology or Audiology. Applicants must also be a U.S. citizen.

LCDR Alicia Souvignier reported to the group via e-mail that the U.S. Army's "new" policy on the commissioning of foreign trade graduates is that the Army will not allow foreign trained graduates to be commissioned as Army officers. All applicants must have received their degree from a US-accredited program.

CDR Scott Gaustad reported to the group that the American Occupational Therapy Association and National Board for Certification in Occupational Therapy has no stated position; however, effective January 1, 2007, foreign trained O.T.s must meet all federal and state laws and must have a post-baccalaureate or higher degree to sit for the license examination.

CDR Gaustad also reported to the group that the Office of Commissioned Corps Operations stated that the Medical and Veterinarian Categories are the only 2 of eleven PHS Categories that have in their appointment standards specific guidance on the commissioning of foreign trained professionals. Both categories use the information and guidance from their respective professional foreign trained credentialing bodies, for instance, the Medical Category uses the Educational Commission of Foreign Medical Graduates (ECFMG) and the Veterinarian Category uses the Educational Commission of Foreign Veterinary Graduates (ECFVG) to determine eligibility for commissioning in the Public Health Service. LCDR David Magnotta, of OCCO, informed CDR Gaustad that except for the Medical and Veterinarian Categories, the other nine PHS category officers must be a graduate from an accredited college/university from one of the 50 states, District of Columbia, Puerto Rico or one of the United States territories.

CDR Gaustad also spoke with Ms Gladys Mells, a Human Resource Specialist at OCCO, who reviews foreign trained application packages. She stated that the current definition page in the Appointment Board Standards is not included in the new Standards. She recommended that PHS Categories be specific about appointment definitions in their respective appointment standards because she and the Assignment Branch of OCCO uses the Category's as well as the PHS's appointment standards for specific guidance.

LCDR Sheryl Fajardo of the Office of Commissioned Corps Force Management reported that OCCFM policies on foreign trained professionals are consistent with that of OCCO and that if a PHS Category would ever want to change their policy on FTPs, a Personnel Policy Management (PPM) Issuance would need to be submitted to OCCFM.

The FTP Task Force closely reviewed the current standards in the Appointment Board Standards Draft and felt that they are specific enough and are consistent with the Therapist Category's commissioning standards as well as our sister DoD services.

Foreign Trained Professional TPAC Task Force Recommendations:

- 1) Foreign trained graduates/professionals who are U.S. Citizens and have graduated from a United States accredited college or university with a Master's degree or higher in Physical Therapy, Occupational Therapy or Speech Language Pathology; doctoral degree in Audiologists, should not be restricted from applying for a commission in the U.S. Public Health Service. An advanced professional degree would not include the transitional degrees in Physical or Occupational Therapy.
- 2) Foreign trained professionals who do not meet the current and proposed new appointment board standards would not be considered for commissioning in the U.S. Public Health Service.
- 3) The proposed new appointment board standards for the Therapist Category should stand and not be amended to reflect foreign trained graduates/ professionals.
- 4) The Task Force unanimously felt that the proposed new appointment board standards are specific enough to provide the necessary guidance to OCCO, OCCFM and Therapist Category appointment board members with respect to foreign trained professionals.
- 5) The Task Force recommended that it is beyond the scope of their charge to recommend or pursue international academic programs to become accredited through their respective United States professional accrediting bodies.

The FTP Task Force adjourned at 1500 EDT and recommended that future meetings were not required.
