II. **REVIEW AND ADOPTION OF AGENDA:**

CDR Shapiro moves to approve the agenda; and CDR Whitehurst-Lief seconds the motion. Approved.

III. REVIEW AND ADOPTION OF PREVIOUS TPAC MINUTES:

August 2007 meeting minutes were provided and approved via e-mail to all TPAC members. Minutes were posted to TPAC website. CDR Shapiro moves to approve August meeting minutes; LCDR McMillan seconds the motion. Approved.

IV. OVERVIEW OF MEDICAL RESERVE CORPS LT Trombley

LT Trombly is a SLP who transferred from Chinle, AZ to a position with the MRC this summer. See PP presentation that was distributed via LISTSERV and Field Reps.

The Mission of the MRC is to improve health and safety of communities across the country by organizing public health, medical and other volunteers. The MRC program office is in the Office of the Surgeon General, which supports efforts to establish, implement and sustain local MRC units nationwide. V. OFFICE OF RESERVE AFFAIRS LCDR Timothy Jiggens

LCDR Jiggens is a Recruiting and Training officer with the ORA. The IRC consists of officers who have either left AD or commissioned directly into the IRC. There are currently 4000 IRC officers with an estimate of 100 officers in the Therapist Category. These officers make up Tier 4 in OFRD. The IRC officers cannot be ordered into a TDY position- they are utilized on a volunteer basis.

An agency that would like to call an IRC officer to duty needs to submit a 1662 through the agency Commissioned Corps liaison. The ORA updates the officers folder with the necessary CAD paperwork for a short tour. CDR Demitrus Culbreath is the officer that works with the details of this process.

The IRC has a blanket MOU with the Army, HHS Agencies, BOP, and Coast Guard. The time frame for CAD for these agencies is about a month: time for 1662 and ORA paperwork, then OCCU needs 10 days to cut orders. If the request is from an agency that does not have a blanket MOU, then process is going to be longer and more tedious.

At this point it is difficult to ensure that IRC officers keep current contact information with the ORA. Of the 100 therapists, only a fraction have good contact information. There is hope that with IT improvements that this tracking will also improve.

The cost of an IRC officer is roughly similar to a permanent Commissioned Corps officer. The service unit can decide how and if they want to pay travel, per diem, etc. It is not considered a PSC, so there are not the costs associated with move or dislocation.

VI. REPORTS

A. CPO Report: CAPT Siegel

<u>CA FIRES</u>: Thoughts go out to victims and firefighters. CAPT Siegel called to check on therapist officer CDR Sue Newman in the LA area, and she and her family are safe from the effects of the fire at this point.

<u>RESPIRATORY THERAPISTS</u>: After years of work by the category, RT is now a commissionable degree in our category as of Sept 07. CAPT Siegel has been in discussion with American Association for Respiratory Care, who will do a substantial roll out in an upcoming publication. CAPT Siegel has been working with the OSG for approval of the material in the press release. The AARC is enthusiastic about this new opportunity for RTs.

There are currently 2 applicants in the system for RT. CAPT Siegel states that CDR Fultz was helpful in providing a blanket billet for the category that the IHS is using at one service unit in order to advertise at an O3 level. It may be helpful for category members to make this billet available to the RT or HR departments at their service units. CAPT Siegel can provide this document to category members.

<u>COERS</u>: Reminder of upcoming due dates.

<u>READINESS</u>: We are at 90.5%, the number one category. We were almost at 95%, but about 8 officers dropped of for one issue, like CPR or License. This shows how easy it is to fall off—we must stay on top of our readiness. Plan ahead and recheck OFRD on a frequent basis.

<u>3H SURVEY:</u> Officers in 3H sites should have received a survey. Please complete and return.

<u>CCMIS WEBSITE</u>: New policies on uniforms are available. Please check with local leadership for feedback concerning BDUs on Friday. Just because we are authorized to wear BDUs, does not mean it is appropriate in every situation.

<u>MENTORING</u>: Several new officers that have been called to AD- we need more mentors. If you do not have mentee, please consider signing up. Please contact CDR Smith at <u>michaele_smith@nih.gov</u> if you are interested.

OFFICIAL CEREMONIES:

August: CAPT Siegel attended the farewell ceremony for ADM Agwunobi October 4: Attended the change of command for outgoing ASG Moritsugu, who retired. The new ASG is RADM Steven Galson. He brings a wealth of experience from the FDA. CAPT Siegel had the opportunity to speak with him yesterday at an award ceremony Celebrating People with Disabilities and thanked him for attention to issues important to our category.

PAC CHAIR MEETING:

CDR Gaustad attended the PAC meeting for CDR O'Neill-Manrique

- OCCO reported that officers who have scored low on promotion boards for over three years are being offered career counseling assistance.
- Work continues to transition category websites to the OCCO server.

Readiness Committee:** CDR Shapiro reports that her committee worked rapidly to notify officers that were at risk for falling of off readiness list, to help keep readiness status above 90% for the category. CDR Shapiro emphasizes the importance of keeping track of readiness and the following checklist.
- F. Strategic Planning and Development Committee: CDR Gaustad is proxy for LCDR Boles.
 - 1. CDR Gaustad suggested an update to the 2003 Billets Review taskforce findings. LCDR McMillan states that new billet structure from OCCO should be in effect by Summer 08. CDR Manrique is in support of starting this project, to help mid-career senior officers in career progression.

<u>ACTION ITEM:</u> Establish a Task Force to update the 1995 Facility Survey. CDR Gaustad will draft the request detailing the focus of the project. The request for Task Force members will be sent out to category via LISTSERV.

- 2. LCDR Cowher and the retention subcommittee established a category survey to update the retention survey from 2004. This will be distributed to all category members. Since the file is in Excel, BOP officers will need to use an Excel viewer, which BOP facilities should have available.
- 3. IHS Scholarship Students: 3 PT and 2 OT will graduate in 2008.
- **G. Professional Development Committee:** CDR Jessie Whitehurst-Lief deferred to report.

A. Healthy Lifestyles Task Force LCDR Golding

12 officers on taskforce will meet via teleconference in next couple weeksmembers will receive meeting information by email in near future.

B. Term Limit Taskforce

CDR Manrique reinstated the term limit task force of CDR Lief, LCDR Richardson and LCDR Souvignier to establish recommendation for policy change for 3 year term limit for subcommittee chairs.

<u>ACTION ITEM:</u> Taskforce will provide suggested policy for enforcing subcommittee term limit and distribute to TPAC members for approval. Taskforce will redistribute list of subcommittee chairs and length in position.

VI. NEW BUSINESS

A. TPAC Policy Procedure Manual – Readiness CDR O'Neill-Manrique

Discussion regarding the requirement for TPAC members to be basic qualified by OFRD and the disciplinary procedures when a TPAC member falls off of readiness list.

- C. 2008 AMSUS Planning update CDR Shipiro AMSUS will be located in San Antonio, TX in 2008 and the USPHS is the sponsoring agency. We want large participation from USPHS. Since we are sponsoring agency, we have a greater opportunity to present at the meeting.
- **D.** Establishing Therapist Role in Public Health CDR O'Neill-Manrique Suggestion to establish a task force related to therapy category and how our professions impact public health. Begin by looking at OFRD and how agencies request assistance. How do we advertise to these agencies about the benefit of utilization of the skills in our category? CDR O'Neill-Manrique would also like to expand this to the realm of Global Health, given that many in our category have the MPH degree.

<u>ACTION ITEM:</u> CDR Jordan, CDR Fultz, and CDR Whitehurst-Lief, and CDR O'Neill-Manrique will meet to clarify the mission of a potential Task Force to address this issue.

E. Promotion Board Guide Task Force CAPT Siegel

This guide is also helpful for board member inside the category in terms of reviewing other disciplines. There are some changes to PT/OT board certifications.
