#### II. REVIEW AND ADOPTION OF AGENDA:

CDR Shapiro moves to approve the agenda and LCDR Howard seconds the motion. Approved.

#### III. REVIEW OF PREVIOUS TPAC MINUTES:

February 2008 meeting minutes were provided and approved via e-mail to all TPAC members. Minutes are posted on TPAC website.

#### IV. CPO Report- CAPT Siegel

#### - Promotion Year 2008:

- o Promotion Boards have concluded. The anticipated release date for promotions will be after COF Symposium in June, but prior to 1 July 2008.
- Assimilation Boards will meet in May.
- The 2009 promotion benchmarks should be released soon, and will likely have few changes.

#### - Readiness:

- o March Statistics: Therapist Category is 91.6%
- o Dropped from 1<sup>st</sup> place to a tie for 4<sup>th</sup> place.

#### - Transformation:

- Web based billet system is forthcoming. It is similar to programs like Turbo Tax in design, with an interview system to find the best match for your billet. Expected to be released this summer.
- o COER redesign is in the formative stages.
- o Corps awareness program for supervisors (CAP). Designed for Commissioned Corps, Civil servants, and tribal supervisors.
- Discipline policy to address letters of reprimand and referrals to disciplinary boards is currently being written. This policy will make a formal process for addressing officers who do not meet readiness standards or who receive a not recommend on promotion boards.
- An MOU has been established with the DOD for mental health providers in MTFs.
   About 200 mental health positions will be filled by both transfers and new hires.
- MOU for the VA is close but not signed yet. Latest delay is concern over payment of death benefit, consistent with previous roadblock that therapist category encountered.
- Potential MOUs with State Health Departments: The State of Texas submitted letter to ASH to request EHOs.

- COF Symposium: Funding cap will not be lifted as the Rule of 50 does apply to the conference. The cap only applies to officers from HHS agencies. Uniform for the conference will be the Service Khaki.
- o Joxel Garcia, M.D., M.B.A. is the new ASH, approved by the Senate, and will be commissioned as an O-10.
- o RADM Galson, ASG, is maintaining a high profile on the issue of childhood obesity. Traveling a great deal as seen in the recent COA Frontline. He has been on local news promoting "Turn off the TV Week".
- o CPO Dietician Category expressed interested in continued collaboration with our category for the Fit for Life column in the CC Bulletin. Think of potential ideas for articles that we can contribute. Officers that have contributed in past have received an award. Watch for formal request through the Readiness Committee.
- Respecting our category Chain of Command can be challenging, since the PHS is decentralized. There have been several incidents with this recently. Better to think of it as a Chain of Communication. It is important to prevent conflicting information from multiple sources.
  - Please realize the importance of keeping the CPO abreast of any articles or public presentations which represent the Commissioned Corps. It is always best to obtain approval from the OSG. Notifying the OSG through the CPO of Therapist Category projects helps to shed positive attention to our category.
  - When in uniform at professional meetings remember that you are representing the category and the Corps. Answer questions about PHS and Therapist Category, but be sensitive if you are asked to comment on things at a policy level. Refer these requests to CPO or somebody within your agency. Know your limitations and keep within your scope. CPO does not necessarily handle all issues, but can be a clearing house and refer to the right person.
  - PHS workgroups and taskforces often require gathering of information from outside of the agencies or Corps systems. When you are asked to get information for a workgroup, make sure you have approval of group leader. If it is for TPAC, get chair /CPO approval. Unapproved comments to entities outside of the PHS at the wrong time can affect potential MOUs and other policy activities.

#### 1. Retention Survey- LCDR Boles

Thank you to LCDR Jim Cowher and subcommittee and Category for participating. 46 officers responded- 34%. Please see results in Attachment F. The subcommittee and category plans to review these results and develop a plan to address concerns that were identified by officers who participated.

#### 2. Appointment Standards-

Need to change wording to "shall receive 8 years" not "maximum of 8 years" for all disciplines OT, PT, and AUD. TPAC will make this recommendation. Please see report under Strategic Growth Committee Report.

#### 1. Strategic Growth Taskforce, LT Trombley

#### 2. Recruitment/AR Update, LT Chorosevic

JOAG Liaison Report - April 2008

The last JOAG meeting was held on Friday, 4/11/08.

Next Journeman Series Meeting: May 9<sup>th</sup> 1300 EST, watch the listsery for call-in information.

#### **Next Regular JOAG Meeting:**

COF Symposium June, 2008 (Sunday before the conference, watch the listserv for an announcement on time/location)

- JOAG is hosting a Forward Thinking Retreat at this year's COF Symposium. They are still accepting additional participants. Over 50 junior officers have signed on so far. It will be held on June 7-8th. This Forward Thinking retreat will conceptualize future planning for the Commissioned Corps over the next 20-30 years. During the retreat, junior officers will share their collective voices in developing a vision for the future of the Corps and have the opportunity to present their ideas to RADM Galson, Acting Surgeon General. This is a unique opportunity for junior officers to advance the mission of the Corps and direct the next generation of leaders. In addition, it is an excellent professional, leadership, and career development activity for individual officers and the participants will develop an invaluable skill set that will benefit them throughout their careers. - On Friday, March 28, the JOAG Executive Committee (EC) met via conference call with RADM Robert Williams, Acting Deputy Surgeon General, and RADM Carol Romano, Chief of Staff of OSG. OSG had requested the meeting to hear an update about JOAG. The EC discussed several of JOAG's projects with RADMs Williams and Romano, including the Forward Thinking Retreat, recent activities related to PAC Collaboration, two recently submitted projects – the Awards Guidance document, and the

PHS Outstanding Volunteer Service Medal proposal – and the Journeyman Speaker Series. In addition, we provided a summary of each committee's activities, based on the most recent committee report. RADMs Williams and Romano praised JOAG for all of its work and suggested a quarterly call with the JOAG EC in order to hear frequent updates.

- JOAG is looking for new voting members! JOAG will be filling 10 vacant slots at the beginning of the operational year on October 1<sup>st</sup>, 2008. Deadline for application is 15 May 2008. Please take a look at the JOAG website for application details. **The therapist JOAG position is available this term!**
- Awards Guidance Workgroup: The Commissioned Corps Awards Guidance document was discussed in the meeting with representatives from the Office of the Surgeon General. This document seeks to create a complete and unified source of information for preparing nominations for Commissioned Corps awards. Additionally, this document includes information on the importance of Commissioned Corps awards for Commissioned Corps officers. At this point, the draft document is still being reviewed by OCCO. When the awards policy POM is issued, Ms. Jane Sprouse, CAPT Dean Coppola, and CAPT Mike Montello will provide their comments on the document in a unified manner. When this awards guidance document is finalized, it will be incorporated into materials sent to new supervisors of Commissioned Corps officers. It may become a standard guidance document posted on the OCCO website, and in the long run, JOAG envisions that this document or a similar one could be a single official guidance document for preparing award nominations, replacing the agency-based guidance that exists today. That future for the document is unclear however, and far from certain. OSG seemed pleased with the process to date expressed interest in seeing the final document once the revisions were made incorporating input from OCCO as well the coming POM.
- The Journeyman Series: Junior Officers moving toward mastering their trade. A journeyman is someone who has completed an apprenticeship and is working on mastering their trade. It is also a program in the US Navy that allows sailors to experience different jobs within a career field. To date, the JOAG has held 2 sessions:
  - ➤ Friday, January 11, 2008: CAPT Shepherd (OIC/USNS Comfort) and CAPT Downs (OIC/USS Peleliu) briefed on their experiences during their mission and discussed the role that junior officers placed during those missions
  - ➤ Friday, March 14, 2008: CAPT Jerry Farrell (USN, retired), Executive Director of the Commissioned Officers Association (COA) and its affiliated PHS Commissioned Officers Foundation for the Advancement of Public Health (COF) discussed the roles and missions of COA and COF, with emphasis on where the organizations' activities converge and where they are separate. In the course of his discussion,

- he provided updates on current issues and activities of both COA and COF.
- ➤ The briefings are typically 45 minutes in length, with a 15 minute question and answer session. The meetings are held every other month preceding the JOAG Voting member meeting; a dedicated time for guest lecturers enabled the JOAG to provide its membership a full scale educational session while ensuring JOAG activities/operations could be fully exercised during allotted meeting times. LCDR DeBarros briefed that future planned series include award writing tips, preparation for a promotion board and force readiness. To date, feedback has been very positive on this initiative.

Selections for the Junior Officer of the Year Award, the JOAG Excellence Award, and the VADM Richard H. Carmona Inspiration Award have been forwarded to the JOAG Executive Committee and once endorsed by the EC will be forwarded to the OSG for further approval.

Junior Officer Scholarship applications for the Symposium are now being accepted. The scholarship only provides for the cost of the full registration, not the pre- conference events, travel, or housing, etc. Visit <a href="http://www.phscofevents.org/registration.cfm">http://www.phscofevents.org/registration.cfm</a> for more information on guidelines and the application process. Submission Deadline is May 7, 2008.

• The Communications and Publications committee is seeking a junior officer to serve as content manager for a feature series on the new website called "A Day in the Life", which will feature stories that capture "A day in the life of a junior officer". Those interested should email LCDR Lori Hall with a statement of interest. This obligation would run through the end of this operational year and beyond if, they wish. The content manager would also serve on the website transition workgroup. A listserv announcement with further details will be posted soon.

The Recruitment and Retention Committee has initiated two new workgroups: the Alumni Contact Program and the Career Onlines Resources Workgroup. The Alumni Contact Program is a recruiting avenue that maximizes professional contacts that each officer already has through their Alumni University or professional organization. This workgroup will construct easily accessible and modifiable letter templates that an officer can modify and send to their alumni contacts such as the dean, career counselor, career placement office, or student body organization on career opportunities in the PHS. Similar letters will be available for professional organization contacts. Hopefully, we can post these on PAC websites and the JOAG site.

The Career Online Resources Workgroup will work to pilot a program for online occupational postings with the Public Health Service. The workgroup will explore opportunities for posting informative, yet broad Public Health Service postings on

free professional job-posting websites. The newly formed workgroup will explore posting options without associated advertising costs.

The Recruitment and Retention Committee retains four other workgroups: The COSTEP Connection Program, Career Fairs List Workgroup, the R&R Publications Workgroup, and the JOAG Informational Workgroup.

#### 1) Recruitment Taskforce

LT Chorosevic is leading the charge to coordinate efforts between the category ARs and the CAM to offer mentoring assistance to the list of active applicants to the Therapy Category. It was decided to use the ARs for this purpose since ARs already receive annual training and have a working knowledge of how to find placement within various agencies. The list of applicants will be obtained from LCDR McMillan, who is the Therapist representative on the CAM. The taskforce will track the number of applicants and the number of CADs to monitor the effectiveness of this initiative.

#### 2) Associate Recruiter Lead Meeting, April 10-11 2008, Rockville, MD

LCDR Souvignier attended as the Therapist Category Associate Recruiter Lead. This was a successful effort by LCDR Pryor, ARP Coordinator, to bring all the Leads together to discuss the AR program and receive specific recruitment training.

to discuss the AR program and receive specific recruitment training. The first day of the meeting involved discussion of the application process and included representatives from the Medical Review Board and all of the CAM teams. The budget for recruitment efforts from DCCR is \$120,000 annually. DCCR has created a "branding" for the USPHS, where they want all recruitment materials to look alike. Currently there is no information sheet which addresses the Therapist category individually, as we are included under "public health professions." There is currently no plan in the budget to create a Therapist insert for the recruitment folders. CAPT Dandridge also provided an update of the recruitment call center, which received 2600 calls during the first quarter. There is still a future plan to try to provide Associate Recruiters with the contact names from the Call Center.

The second day of the training was taught by a former Navy recruiter, Mr. Rick McCallum, who shared recruitment techniques. His overarching message was that the

USPHS needs to be more "customer" focused in our efforts. He offered a new perspective and his message was very well received.

1) The retention survey has been completed. A total of 46 surveys were completed and returned, representing a 34% category response rate. The TPAC Retention Survey provides valuable insight into factors that may affect retention of therapist officers. However, much of the information on the survey development is intuitive being based on the opinions of several committee officers. Nine domains of factors affecting retention were identified. Survey development considered factors the officers "believe" are important to retention considering past and current aspects of officer life. Questions related to the changes associated with transformation were also included however much

of this is speculative considering that the transformation process has not been completed and is stalled due to funding issues.

Future survey development would benefit from a more formal scientific process to accurately determine domains related to retention and most appropriate questions to explore those domains. The current process has led to a "shotgun" approach with well over 100 questions related to retention. Refinements in survey development by trained professionals would greatly enhance future retention analysis. However, this level of development is beyond the scope of an individual PAC. Additionally, many factors included in the TPAC survey are generic to all categories. These factors point to the need for a coordinated effort from headquarters in future survey development; this will assist Corps leaders in understanding the factors related to retention of officers across all categories. We hope that our efforts have opened the door to this process. See attachments for more in-depth review.

<u>New Business:</u> While performing our year end review of the therapist category appointment standards an inconsistency within the category appointment standards became apparent. Namely, new graduates with the clinical doctorate in Audiology (Au.D) are awarded the pay grade of

0-3, while new graduates with the clinical doctorate in Physical Therapy (DPT), Occupational Therapy (OTD) are commissioned in the pay grade of 0-2. On the surface it appears graduates with the clinical doctorate in Audiology are awarded more academic credit, 8 years compared to 7, than the other professions for what appears to be equal degrees in their respective fields. The Committee has set out to perform extensive research on the Doctorate of Physical Therapy and the Doctorate of Occupational Therapy programs (to our knowledge Respiratory Therapy and Speech Therapy do not offer an entry level Clinical Doctorate at this time).

#### RECOMMENDATIONS:

Due to the evidence presented in the final report, and the fact the precedent has been set in our sister services, as well as in other professions within our category, the Appointment Standards Subcommittee concludes that the TPAC should recommend revising the Appointment Board Standards to award the entry level DPT and the entry level OTD with 8 years of academic credit.

### RECOMMENDED CHANGES TO THE APPOINTMENT BOARD STANDARDS: Audiology

Au.D shall receive 8 years TED credit for basic undergraduate and professional education.

#### Physical Therapy

DPT shall receive 8 years TED credit for basic undergraduate and professional education. Occupational Therapy

O.T.D. shall receive 8 years TED credit for basic undergraduate and professional education.

#### **2007 TPAC Retention Survey Results**

#### **Survey Data**

A total of 46 surveys were returned giving a response rate of approximately 34%. Surveys we divided into three categories based on agency of the respondent. Categories included: I.H.S., BOP, and Other. The category "other" included responses from the Office of the Surgeon General, FDA, NIH, CDC, USDA, and, HRSA. The total number of surveys per category included: IHS -26, BOP -9, and Other -11.

Two graphical reports are included as attachments. Responses to each question are reported via a horizontal bar graph referenced to a neutral response. One report includes the results of all respondents. The second report includes the results from each the three categories of respondents. The response for each question includes three bar graphs for comparison.

#### **Quality of Responses and Data:**

The Excel version of the survey opened on the survey tab bypassing the demographics portion. Several respondents did not notice additional tabs for demographics and returned the survey without this data. This problem was usually corrected by contact with the officer, however, there were two surveys where the officers were not able to be contacted.

The total number of responses varied for each question. Occasionally a respondent would omit answering a question. This response error was accounted for during data analysis.

#### **Demographic Items:**

Several demographic and survey items did not produce adequate information; this is due to items not lending well to analysis (poor design), lack of meaningful data, and/or lack of understanding of the question/s. Some of these items could be corrected by adding standard definitions to increase consistently and quality of responses, more powerful statistical techniques to give greater meaning of responses, or omission of selected items from future surveys.

The section regarding "Educational Degrees Obtained" provided informative data however it appears to be incomplete in scope. Some respondents listed all degrees while others appeared to only list their terminal degree; this data has been omitted from the report.

Demographic questions related to the "types of assignments" would provide more meaningful data if definitions were provided to clarify terminology related to the questions. Responses varied substantially leading to questionable understanding of the intent of questions. Additionally, usefulness of the data would be enhanced with analysis from higher level statistical software. Data from this section has been omitted from this report.

#### **Survey Items:**

"Number of awards received" was not included in the report. This information could provide more meaningful data if analyzed with a more powerful statistical software package. For instance, are more senior officers receiving more awards than junior officers? Is there equity in award numbers from officers in differing agencies? This level of analysis was determined to be beyond the scope of the current survey and statistical capabilities.

Comments: Numerous written comments were received and are attached to this report for review. Written subjective comments are difficult to quantify, however, do provide valuable insight. The comments section of the Adobe version of the survey did not function properly; this provided fewer responses from those using this format affecting BOP officers the most.

Respondents were asked to indicate which question in each category was the "most important" to them. Responses for this request were very low and did not provide meaningful results.

#### Rank Order of Survey Categories

This section provides good insight into how respondents rank the nine categories of items included in the survey. Overall ranking of the categories is as follows:

- 1. Quality of Life
- 2. Billets & Assignments
- 3. Compensation
- 3. Professional Growth
- 4. Promotions
- 5. Awards
- 6. Assimilation
- 7. OFRD
- 8. DCP Operations

Compensation and professional growth tied for the third location.

  - > Recommendations by the previous task force

- Need a full-time, permanent billet in the OSG: *Director for Healthy Lifestyles Program for the Commissioned Corps*.
- Focus of the Healthy Lifestyles Program should be "LEADING BY EXAMPLE."
- o Begin Corps-wide conventional program with more narrow focus: physical fitness & nutrition.
- o Gradually expand program to include other areas (stress management, substance abuse, etc.) as Healthy Lifestyles Program becomes established.

#### > Responsibilities of the Director of the Healthy Lifestyles Program

- Lead multidisciplinary team in planning and implementing future program for the Commissioned Corps. CPOs & PACs must contribute to these efforts to be successful.
- Facilitate the development and implementation of healthy lifestyle health promotion programs, as well as preventive care efforts nationally for the Commissioned Corps.
- Develop and assist in provision of ongoing regional educational/motivational programs designed to encourage healthy lifestyle behaviors, and maximize the safety and benefit of employee fitness/wellness activities.
- o Serve as the liaison between officers in the field and those at the highest levels in the USPHS.
- Continue to support and facilitate established local fitness/wellness programs for officers and serve as the central resource for initiating new programs.
- Perform ongoing regional assessment of fitness/wellness needs of officers and recommend action plans to meet them, working in collaboration with local, regional and national resources.
- Establish collaborative relationships with available resources to provide additional program support including; other federal agencies, local, state and national organizations.

#### Challenges to Physical Fitness

- o Regular physical activity/exercise is not a normative expectation in the way that other aspects of personal hygiene are (brushing teeth, bathing...).
- o Naturally occurring social and material contingencies are not sufficient to shape and maintain regular physical activity and exercise.
- o Education alone regarding potential health benefits is generally ineffective.
- o 50% of individuals who start an exercise program drop out during the first 3 to 6 months.

#### **➤** Motivational Intervention

- The real challenge is motivating officers to take action to positively change their lifestyles.
- The *Transtheoretical Model of Behavior Change* is a valid model when applied to physical activity. This model can be utilized in helping officers improve their current lifestyle practices.

- o This health behavior model was initially developed in the early '80s as the key part of successful smoking cessation interventions.

  - o Director HLP to meet with Agency & USPHS leaders to collaborate on positive action for improving employee health.
  - o Provide "training trainers" classes regionally. Include a fitness activity event for community with these programs.
  - o Reinforcement of healthy lifestyle practices (ie. daily physical activities/events and healthy snacks during COA meetings, etc.).
  - o Healthy Lifestyles Program segment during BOTC.
  - o Regular articles in Commissioned Corps Bulletin and other publications.
  - o Expand Healthy Lifestyles Program for Commissioned Corps to provide resources more akin to what other services have available.
  - o Better integration of preventive health measures within MAB.
  - o Senior officers should serve as role models for healthy lifestyles.


