V. Open Forum:

- A. CAPT R. Nelson reported that the following information was inadvertently omitted from the December 8, 1988 TPAC minutes.
 - 1. LCDR J. Hunter recently received a PHS Achievement Medal.
 - 2. LT M. Pizzi was promoted to LCDR effective April 1, 1989. The TPAC congratulates these Therapists!
- B. Career development and recruitment were the primary agenda items of this TPAC meeting.
- C. CAREER DEVELOPMENT TRACTS: TPAC reviewed and further revised the therapist career development tracts (D. Swett, TPAC minutes 3/88). The purposes of the therapist career development tracks are to:
 - 1. Assist the therapist recruitment effort by providing applicants with a description of career tracks and professional opportunities in the PHS.
 - 2. Aid active duty therapists with their decisions about career development opportunities.

CAREER DEVELOPMENT SURVEY: TPAC reviewed the therapist career development survey instrument adapted from LCDR C. McGarvey's proposal (TPAC minutes 9/88). The purpose of the Career Development survey instrument is to compile data on (across grades) the percentage of time therapists spend in various professional responsibilities at their duty station.

PURPOSE OF DATA COLLECTION: This data will help to:

- 1. Determine departmental strengths
- 2. Focus attention on staffing needs
- 3. Develop strategies for departmental growth
- 4. Define career development opportunities

PLAN OF ACTION:

- 1. D. Swett and M. Rogers-Smith each agreed to review the operational definitions on the career development descriptions for clarity and to provide feedback to R. Nelson by March 23, 1989.
- 2. A random sample of PHS therapists will be pilot tested as to the general applicability and reliability of this instrument
- 3. Appropriate changes in the instrument will be made from the results of the pilot survey.
- 4. A full survey of all PHS therapists will be carried out on or about July, 1989 and subsequently compiled according to grade level (i.e. all 02 therapists, all 03, etc.)
- D. RECRUITMENT: TPAC reviewed the results of the University/College Grid prepared by the recruitment committee (Attachment B). TPAC expressed their appreciation to Ralph Utzman (COSTEP) and all members of the recruitment committee for the work in collecting and formatting the data. Specifically: D. Aretino, D. Brueggeman, D. Breger, B. Ferguson, G. Hunt, M. Huylebroeck, E. Koziatek, K. Lohmann, G. Schofield, W. Smith, K. Varvel, I. Williams, and M. Pizzi (Chair).

ACTION ITEM: W. Fromherz and R. Nelson plan to meet with M. Pizzi, Chair, Recruitment Committee to both further review, and determine implementation strategies for the grid.

E. Josef Hoog Research Award - TPAC discussed the idea of re-examining the criteria for the Josef Hoog Research Award.

ACTION ITEM: R. Nelson will contact J. Birke, Chair Josef Hoog Research Award committee, to relay TPAC's discussion and to request that the committee review the matter and submit its recommendations to the next regular TPAC meeting (5/25/89).

VI. Reports

- A. Chair R. Nelson
 - 1. Bill Fromherz and Roger Nelson continue to work on pressing Therapist Category Career Development Issues and Recruitment Strategies.

- 2. Roger and Bill worked with Ralph Utzman (COSTEP supported by DCP) in the refinement of the career development, recruitment and collegiate grid developed initially by D. Swett, C. McGarvey and the Recruitment Committee respectively. Some of Ralph's efforts are presented in this edition of the TPAC minutes.
- 3. Roger and Bill continue to attend the Surgeon General's monthly CPO/PAC meetings, where all category CPO's and PAC Chairs meet together.
- 4. The Surgeon General's CPO/PAC meeting was held on March 2, 1989. The TPAC also met at that time. Therefore, Ivana Williams was asked to attend the CPO/PAC meeting representing Bill Fromherz and Roger Nelson. Some of the notes of that meeting appear under the DCP/CPO report.

ACTION ITEM: TPAC thanks Ivana for attending the meeting and providing a complete set of notes.

- 5. Roger has received seven (7) self nomination forms for TPAC involvement.
- 6. An Executive Summary of the PHS honor award descriptions is attached (C).

B/C. CPO/DCP Representative - W. Fromherz

1. The Vacancy Announcement Tracking System (VATS) report is attached (D).

NOTE: The number of new positions and current vacancies emphasizes the need for INCREASED RECRUITMENT activities.

- 2. DCP is currently reviewing all PHS officers between 20 and 30 years, relating their billet to current rank.
- 3. A summary of the promotion process update is attached (E).
- 4. DCP has received 17 COSTEP applications to date.
- 5. CPO/PAC meeting highlights (note; the information presented below represent the abstracted highlights of a full report submitted by Ivana Williams) March 2, 1989:
 - Nursing Bill: Has been revised to include amenities for PHS nurses, as well as military nurses. Revisions include ROTC/COSTEP type program with salary of \$500.00 plus per month; up to \$5000.00 accession bonus and incentive special pay for nurse anesthetists. The benefit to other categories; the Nurse bill may be looked at as a trial case with the possibility of including other categories which have demonstrated shortages.
 - b Promotion Board:
 - (1) Billets will not be used as precepts at this promotion cycle due to the fact that all billets are not current.
 (2) Continuing education will not be considered in this promotion cycle due to the inadequate knowledge on how continuing education will be defined for promotion purposes. In addition there appears little to no uniformity in category requirements.

- (3) Performance ratings will be the major criteria used for promotions this cycle. Other criteria have been published in the Commissioned Corps Bulletin.
- (4) Categories are developing standardized billets for their specialties. The dental category has developed twelve (12) standardized billets which account for 90 percent of all dental officers. These billets address career progression, continuing education, rotation of assignments, career tracks and responsibility levels. All dental program chiefs have agreed to use these billets for applicable positions. Positions not covered under the standardized billets include pure administrative assignments. Administrative personnel should have different requirements and criteria so that they are not in direct competition with clinicians when it comes to promotions. Pharmacy is also in the process of developing standardized billets for their clinical positions, specifically for those pharmacists stationed in clinical positions at IHS, BoP or NIH.
- (5) NOTE: IHS Therapist billets have been revised with the direct input for the revisions by M. Wilson and D. Swett. The billets are currently in the process of being finalized.
- c. Recruitment remains the highest priority for the Therapist category .
- d. CPO Selection Update See attachment F.

 NOTE: Dr. Koop has extended W. Fromherz's appointment as
 Chief Professional Officer, Therapist Category for an additional two year period effective immediately.
