## 1. Profile Future Trends: Therapist Category

An examination of the data on commissioned officers of the therapist category on a year by year basis based on 30 yr mandatory retirement and 20 yr eligible retirement reveals that:

In the years 1996 - 2001, fifteen officers will hit the 30 year mark and fifteen will hit the 20 year eligible retirement mark resulting in one of the following scenarios:

- a. <u>conservative trend</u> If only 30 year officers retire, the therapist category will have a deficit of four to five therapists.
- b. <u>semi-conservative trend</u> If one-half of 20+ eligible officers retire along with 30 year officers, the therapist category will have a deficit of 10 11 therapists.
- c. worst case scenario If all 20+ eligible officers retire with 30 year officers, there will be a deficit of 20 21 therapists.

In summary, it is recommended that we key off the semiconservative trends in both periods as probably the most realistic. After the year 2001, this top-heavy effect will begin to balance out to a more uniform distribution of officers.

Current strength of therapist category Charlie submitted a current roster of therapists (ATTACHMENT H) and data that identifies the breakdown of therapists according to disciplines, gender, rank, location, and agencies. (ATTACHMENT I).
