- IV. ON-GOING BUSINESS
  - A. NOTE OF ABSENCE:

#### VI. NEW BUSINESS

- A. CDR M. Schroeder (PT/FDA) serves as the Dietician, Therapist, & Veterinarian Officer representative to the Commissioned Officers Association (COA) National Board of Directors. ATTACHMENT B is an explanation of the mission, duties, and goals of the COA.
- B. Sandra Adams (PT/Civil Service) was appointed Awards Coordinator for TPAC. The objective for this position is to effectively communicate information on the appropriate use of the Public Health Service and Civil Service award and recognition systems to identify and publicize the achievements of all therapist category members. Congratulations, Sandra and we look forward to your input.

ACTION ITEM: Sandra will outline the goals and objectives as Awards Coordinator and report her progress at the next TPAC meeting.

- C. Articles highlighting the Therapy COSTEP program and providing the toll free PHS Recruitment number were recently published in the Physical Therapy Advance and the Occupational Therapy Advance. A similar article will be published in a future issue of Speech Advance. CDR Charlie McGarvey was instrumental in having these articles published and has received several inquiries about PHS as a result. Inquiries were forwarded to the respective agencies. Thanks, Charlie.
- D. CDR C. McGarvey served as a PHS representative for CAPT Diullo to the uniformed services meeting held at Bethesda, MD. This meeting collaborates on therapists issues between the joint services: Navy, Army, Air Force, PHS.
  - 1. Currently pediatric trained therapists are being sent to Romania to help children with disabilities. This program is called Operation Smile and it requires a commitment of one month per tour. The question was raised if PHS could commit to the program.

ACTION ITEM:

CAPT Diullo has received a draft letter inviting PHS therapists to participate in Operation Smile. He will review PHS policy and procedures and submit a response regarding our future participation.

- 2. Bethesda Naval Hospital is offering a 6 month EMG training course. The course is scheduled to begin in May, but will likely be offered again in six months. Any interested applicants contact CDR R. Nelson at (301) 295-4879 for more information.
- E. CDR C. McGarvey served on a panel sponsored by ACHPR. The purpose of the panel was to establish guidelines for pain control following surgery. This committee met over a 2 year period and produced the first set of national guidelines on the subject. A question arose as to how these guidelines may affect future policies for the funding of health care services.
